## MetroPlan Orlando Delegation Report JULY 2021

## Work and Upcoming Studies:

#### Pedestrian & Bicyclist Safety Action Plan

Phase 2 of the Action Plan involves developing safety infrastructure project applications for six of the nine corridors studied in Phase 1 and developing messaging approaches for the key behavioral strategies. The corridor project concepts and applications are undergoing final review.

#### Corridor Safety Concept Development & Countermeasure Study

The study is developing detailed Countermeasures and Concept Development plans for the 38 miles of State Roadways that represent more than 23% of all crashes on our system. Existing conditions analysis, data analysis and field reviews have all been completed for four of the study corridors: Silver Star Road (SR 438) from Hiawassee Road to Pine Hills Road, Orange Blossom Trail (US 441) from Oakridge Road to 34<sup>th</sup> Street, Colonial Drive (SR 50) from Tucker Road to Harrell Road, and Colonial Drive (SR 50) from Harrell Road to Alafaya Trail. Project concepts reports are in final the development stage for implementation through the Highway Safety Program.

#### SunRail Parking Feasibility Study

MetroPlan Orlando is leading a cross-jurisdictional study to explore the need and feasibility of increasing the parking supply at three of the Phase 2 SunRail stations. The parking at the Meadow Woods, Tupperware and Poinciana SunRail Stations exceeds the available number of spaces on most days SunRail is in service. The project will engage SunRail Riders, stakeholders and neighborhoods adjacent to the stations. The project will also include concepts for each parking area to address safety, operations and overall capacity for users of SunRail. This project is still ongoing.

#### Traffic Signal Retiming Contract

The FY 2020-2021 Traffic Signal Retiming program is complete, with 21 corridors and 18 standalone intersections being retimed throughout the MetroPlan Orlando planning area. The assessment of the 2020-2021 retiming program is underway and will wrap up in late 2021.

A call for requests for the FY 2021-2022 program went out to maintaining agencies in the region in May and requests for retiming projects on 28 corridors have been received to date. Initial data collection efforts for the FY 2021-2022 program will commence in late summer/early fall. MetroPlan Orlando staff will also be working with the maintaining agencies, retiming consultants, and the GPC firm that leads the Before and After Studies of the signal retiming effort to review, discuss and consider diversifying the metrics that are used to measure the success of the program to better consider safety and bicycle and pedestrian benefits and impacts as well as those associated with vehicular throughput.

#### **Equity Audit**

MetroPlan Orlando staff kicked off an equity audit for the organization in March. The intent of the audit is to explore the distribution of transportation benefits and disbenefits across the region through a social equity lens as well as to catalog how equity is addressed through existing policies and plans. The preliminary schedule for the audit calls for developing a draft white paper and presentation for internal review and discussion in October, with the potential to provide initial findings and recommendations to the Board and committees in late 2021 or early 2022.

#### Safety Data Initiative (SDI) Safety Tool Grant

In June 2020 MetroPlan Orlando, along with major partners UCF and FDOT, was awarded one of the nationwide Safety Data Initiative (SDI) Safety Tool grants. The award amount was nearly \$295K. The grant funds will be used to develop the Crash Prediction for Expedited Detection (CPED) application, which will further refine the Real-Time Crash Visualization Tool for Traffic Safety Management tool developed by the UCF SST team led by Professor Abdel-Aty.

The team has completed the Crash Prediction for Expedited Detection (CPED) application, integration and testing. Additionally, the visualization function for the CCTV module and the secondary crash prediction module are complete along with data cleaning and integration. The team has prepared a user manual for the CPED system. The team participated in the SDI peer exchange in May 2021. The purpose of the meeting is for the review panelists to provide feedback on the MetroPlan Orlando Crash Predictions for Expedited Detection tool, discuss opportunities, and describe how they envision applying this tool. Review panelists include FHWA, NHTSA, OST, NCDOT, and MDOT SHA. Each of the project teams from other parts of the county participated in virtual meeting with the Office of Safety Librarian on procedures and protocols for submitting reports and data.

#### 10th Street Complete Streets Study

Within St. Cloud, 10th Street is a significant east to west street and provides a vital link to Downtown. This critical linkage to the heart of the community serves an important function of connecting residents to the vibrant shops and events in Downtown. The purpose of the 10th Street Complete Streets Study is to evaluate 10th Street from US 192 to South Narcoossee Road for modifications to sidewalks and crosswalks, bicycle facilities, landscaping, drainage and lighting. The study goal is to improve the travel and safety for residents and visitors and create positive economic impacts. Led by MetroPlan Orlando in partnership with Osceola County and the City of St. Cloud. This study will coordinate and engage with community members, agencies, businesses, and government entities throughout the 18-month duration of the project (January 2021 through June 2022) in order to guide project goals, provide support and feedback for alternative's concepts, and share information about the recommended conceptual plan. #### Rock Springs Road and West Orange Trail Extension Studies

MetroPlan Orlando is conducting two studies concurrently in the City of Apopka: 1) the Rock Springs Road Study, and 2) the West Orange Trail Extension Study. The Rock Springs Road Study will evaluate safety and access improvements at the intersection of Rock Springs Road and Welch Road, and along the half-mile of Rock Springs Road from Welch Road to Lester Road. The study will also include an intersection analysis and evaluate realignment for the intersection of Sandpiper Street with Park Avenue, as well as consider the addition of sidewalks on either side of Park Avenue to fill existing gaps. The West Orange Trail Extension Study will evaluate a connection between the existing portion of the West Orange Trail, which currently ends at Lester Road, and Kelly Park Road, tying into the proposed Wekiva Trail. The study will also evaluate two trail spurs to connect the Trail to the entrance to Wekiwa Springs State Park along Welch Road, and to connect to Wolf Lake Elementary and Middle Schools and the City's Northwest Recreation Complex. These studies are expected to be completed in December 2022 and are being conducted in partnership with the

City of Apopka and Orange County. More information on both studies can be found at www.metro<u>planorlando.org/rocksprings</u>.

#### Health Strategic Plan

The Health Strategic Plan will highlight the ways in which MetroPlan Orlando can enhance the transportation system by planning with health and the environment in mind. This plan shall illustrate areas where public health improvement through transportation planning is needed most, as well as exploring potential strategies in tackling public health issues. Some of the key components of the plan include addressing access to healthcare services, advancing trails and active transportation, and improving air quality. The goal of the Health Strategic Plan is to provide data-driven solutions to public health issues in order to round out MetroPlan Orlando's commitment to performance-based planning. This project will wrap up around September or October 2021.



## Ocala/Marion County Transportation Planning Organization (TPO) Delegation Report for July 2021

## TPO Board Adopts Fiscal Years (FY) 2021/22 to 2025/26 Transportation Improvement Program (TIP) and 2021 List of Priority Projects (LOPP)

Upon the conclusion of an expanded public and partner review process of 45 days, on June 22, 2021, the TPO Board adopted the FY 2021/2022 to 2025/2026 TIP. The TPO Board also took action to adopt the 2021 LOPP. The TPO continued its process of developing a public-friendly document with individual project summary pages and online interactive map. The Adopted TIP and online map may be accessed at the TPO's website.

#### Congestion Management Plan Status Update

In 2021, the TPO is conducting a major update to the Congestion Management Process (CMP). To better engage with the public, the TPO conducted a public survey, and is developing a concise CMP document with summary components and a future online interactive map. The TPO is on schedule to release a draft CMP by August, and adopt the document at the Board meeting in October.

#### **Transportation Resilience Guidance Project**

The TPO is in the process of developing a planning guidance resource document on transportation resilience. Based on the federal emphasis of MPO/TPO's to support improvement of the resiliency and reliability of the region's transportation system, combined with the recent development of Resilient Florida in 2021, the Ocala Marion TPO is identifying future opportunities and challenges to address resiliency in Marion County. The guidance resource publication is anticipated to be completed by October 2021.

#### Interactive Traffic Count Map and Report

The role of data, such as traffic counts, is critical to the MPO/TPO planning process. The Ocala Marion TPO for decades has worked collaboratively with Marion County, the City of Ocala and Florida Department of Transportation to maintain ongoing traffic count reports and manuals. To ensure the general public has access to readily understood information associated with traffic counts, the TPO has developed a 2021 Traffic Counts Report, Story Map and Online Map. 2020 was a year of significant instability, and the counts in the latest version of the TPO's report are reflective of that reality. Traffic counts in some locations grew, while in many other locations volumes were significantly down. 2021 data will be of great interest to track and correlate the significant growth taking place across Marion County. https://ocalamariontpo.org/transportation-statistics




## Polk TPO Delegation Report Central Florida MPO Alliance Meeting July 9, 2021

## 2021 Transportation Priority Projects

On June 10, the Polk TPO approved the 2021 Priority Transportation Projects for Polk County. The TPO's adopted *Momentum 2045* is the source for the priority projects. Several of the priority projects are requests to restore funding which had been deferred or removed out of FDOT's FY 2021-2025 Work Program. Such projects are Central Polk Parkway – Phase II (CST), SR 544 (PE), and US 17/92 (PD&E).

Example of other priority projects include State Road 33 and Interstate 4 (Exit 38) interchange reconstruction which is a critical safety project to address truck and passenger vehicle stacking on exit ramps; the Lakeland Intermodal Center, which will be a state-of-the-art transit terminal for Citrus Connection to include parking garage, relocation of Amtrak station, and connection to the convention



center; North Ridge Trail, which will be a new 2lane road along and west of US 27 in Northeast Polk County to provide access to signalized intersections for local traffic, improving traffic safety, preserve and through-traffic capacity of US 27; and several multiuse trails, such as Ridge Scenic Highway Connector Trail through Lake Wales and Old Dixie Trail, which will link Auburndale/Van Fleet Trail to Lake Alfred/Chain of Lakes Trail and Haines City Trail.

## Northeast Polk US 27 Mobility Study


At its June 10<sup>th</sup> TPO meeting, the Florida Department of Transportation (FDOT) and in conjunction with Florida's Turnpike Enterprise (FTE) provided an update to the Northeast Polk US 27 Mobility Study. This study comprises a broad study area between Lake Wales and US 192 at the Polk/Lake County Line.

This study is evaluating short and long-term options for improving mobility on US 27 and other major roads in northeast Polk County. Some of the options being considered include improving transit services and signalized intersections in the region; the construction of service or frontage roads along US 27; and widening key roads. The major outcome of the update is a proposal to construct a limited access, toll lane alternative to US 27. Many of these improvements proposed in the study are already contained in the TPO's recently adopted Momentum 2045 (long-range transportation plan).

## 2021 Transportation Regional Incentive Program (TRIP) Project Priority List

Due to its proximity along the I-4 corridor, Polk County is an integral regional partner to counties to our east and west. As such, Polk TPO is a member of both the Central Florida MPO Alliance and the West Central Florida Coordinating Chairs Committee (CCC).

At its June 25<sup>th</sup> meeting, the CCC endorsed the 2021 TRIP priority projects from both its District One and District Seven MPOs. The number one priority from the District One MPOs (Polk and Sarasota/Manatee) is Polk County's North Ridge Trail from Deen Still Road to Sand Mine Road, for which \$4 million is requested. Having secured an endorsement by Regional Planning Entity, Polk County is proceeding with submitting this project for 2021 TRIP funds.





## River to Sea TPO's Delegation Report to the Central Florida MPO Alliance July 2021

#### Planning Projects – Recently Completed, Underway and Upcoming

- Project Feasibility Studies The R2CTPO sets aside \$100,000 annually in two project categories (Traffic Operations/Safety and Bicycle/Pedestrian) to complete project feasibility studies as requested by local government sponsors for projects administered through the Local Agency Program (LAP). Projects are prioritized and studies are initiated at the start of the fiscal year to prepare project applications for the next Call for Projects.
- <u>Votran Transit Development Plan (TDP) /Transportation Disadvantaged Service Plan (TDSP) and</u> <u>Comprehensive Operational Analysis (COA)</u> – The R2CTPO is providing staff support and funding to the local transit provider to assist with planning efforts such as the TDP/TDSP/COA. These planning efforts are currently underway and are anticipated to be complete in September 2021.
- <u>Paratransit Service Analysis</u> Many changes have occurred regarding the provision of transportation services for disabled and disadvantaged. New transportation options, as well as changes to the structure of the coordinated transportation system established under Florida Statutes, have influenced the provision of services throughout Florida. This study examines local area service and the state of practice throughout the state to identify issues and opportunities that impact efficiencies in paratransit service. The estimated completion date is September 2021.
- <u>2021 List of Project Priorities (LOPP)</u> The long-range transportation plan establishes priorities for the major capacity projects including the Strategic Intermodal System (SIS) and Non-SIS highways. The R2CTPO sets-aside funding for smaller, impactful projects that address safety, operations and non-motorized travel which are prioritized through an Annual Call for Projects that identifies projects for state and federal funding. The 2021 LOPP was adopted on June 23, 2021.
- Non-Motorized Traffic Count Program The R2CTPO is developing a program to identify locations and conduct periodic counts of bicycle and pedestrian activity throughout the planning area. The program will be implemented in FY 2021/22.
- <u>Congestion Management Process (CMP) and Performance Measures Report</u> Transportation data is being
  used to evaluate the performance of the existing system as well as to inform decisions regarding the
  prioritization and funding of projects and programs to address needed improvements. The R2CTPO is
  initiating an update to the process for collecting and reporting this information to make the best use of the
  data available. A draft report is expected in Spring 2022.

## Space Coast TPO's Delegation Report to the Central Florida MPO Alliance July 9, 2021

## NEW 2021 Intelligent Transportation System (ITS) Master Plan Adoption

The SCTPO officially adopted its 2021 ITS Master Plan on July 8, 2021.

The ITS Master Plan is the TPO's guiding document for implementing technology on the transportation network. The 2021 ITS Master Plan Update focuses on using technology to improve traffic flow and aims to maximize existing infrastructure to provide an accessible, safe, reliable, efficient, and secure transportation system for all users. This plan proposes numerous technologies and locations for safety improvements as well as a tiered approach for future system expansion and operation. The proposed improvements and strategies will ensure that the Space Coast area is prepared for autonomous and connected vehicles

## Transportation Resiliency Master Plan

The SCTPO is in the process of developing a Transportation Resiliency Master Plan. Upcoming activities include community conversations with Transportation Disadvantaged Communities and determining shocks and stressors to be analyzed.

The Transportation Resiliency Master Plan will build on our past work regarding sealevel rise vulnerabilities to define potential transportation-specific stressors, identify vulnerable corridors in Brevard County, and recommend strategies to improve the adaptability/recoverability of the system.

## North Brevard Wayfinding Master Plan

North Brevard has a network of regional trails such as the Coast to Coast Trail, St. Johns River to Sea Loop, and East Coast Greenway. The regional trails cross through multiple jurisdictions within Brevard and each have its unique branding.

Per the request of trail managers and North Brevard municipalities, the Space Coast TPO is developing a Wayfinding and Amenities Master Plan to address trail network and trailheads which provide access to the North Brevard Trail Network. The plan will develop a consistent wayfinding and amenity plan to be used across the regional trails for the purposes of improving the trail experience and aesthetic.

### Vision Zero Action Plan

The SCTPO is currently holding Leadership Committee Meetings as the next step to implement our Vision Zero initiative. The meetings discuss methods to promote Vision Zero as a viable approach to traffic safety and prioritize action items in the Space Coast TPO Vision Zero Plan.

The most recent SCTPO event was held in June to promote the City of Cocoa as one of our Vision Zero Heroes. The City adopted Vision Zero and implemented the roadside marker program to bring awareness to the public on traffic fatalities. The SCTPO is actively working to gain support for additional Vision Zero cities within Brevard County.

#### b. FDOT District Reports

Mr. Wayne Gaither, represented FDOT District 1. Mr. Gaither reported out on the I-4 Connect project. This is District 1's attempt to look at the interstate systems their potential build-out and growth. The PD&E study is currently underway for the portion of I-4 from S.R. 570 aka Polk Parkway to west of U.S. 27. The purpose is to determine the operational capacity and future deficiencies. The interchange for I-4 @ S.R. 557 located north of Lake Alfred in Winter Haven will go from a clover leaf design to a full diamond. The changes will also incorporate roundabouts at either end to allow for continuous movement for S.R. 557 and the on/off ramps in both north and south bound directions. The U.S. 27 Mobility study is currently underway to review alternative routes that are being analyzed or the effectiveness of distributing traffic along the transportation network. Updates on this

Mr. Gaither announced that on January 30<sup>th</sup>, there will be an open house for M-Cores project in addition to a task force meeting scheduled for February 13<sup>th</sup>. He provided the website address so that Alliance members can keep up-to-date: <u>https://floridamcores.com/</u>. Mr. Gaither stated that FDOT District 1 is taking a unique approach to study the relationships that exist among land use, transportation, and development along state roads by conducting Planning Studios. He said that the Planning Studios are conducted with the local jurisdictions, and provide a way to address traffic needs for continuous development.

Ms. Loreen Bobo, Director of Development for FDOT District 5. Ms. Bobo reported out on the status of District 5. Secretary Shannon left the D5 in November. The current interim, Jared Perdue, was appointed in December and he comes from D3. She stated that interviews for the D5 Secretary are anticipated for February. Ms. Bobo stated that the \$4.7 billion dollar five-year work program has been delivered to the FDOT Central office and Legislature in Tallahassee. The work program makes up about 11% of the State's overall FDOT work program. She briefly highlighted the Wekiva Parkway. She commented that all segments of the Wekiva Parkway are under construction, and anticipated completion by 2022.

Mr. Siaosi Fine, FTE, provided an update on the PD&E study for the widening of the Turnpike Mainline on the stretch of road that runs from S.R. 408 to S.R. 50 in Ocoee/Oakland. He stated that the purpose of the study is to evaluate roadway widening, improvements, and modifications to existing interchanges. Mr. Fine said that this includes interchanges at S.R. 408, 429, S.R. 50 in Ocoee, S.R. 50 in Oakland/Clermont and interchanges that are yet to be determined. The PD&E kickoff meeting is tentatively scheduled for Thursday, February 20<sup>th</sup> at the Turnpike Headquarters.

#### VII. Action Items

#### a. Approval of Previous Meeting Minutes

Action is requested for approval of the October 11, 2019 Central Florida MPO Alliance meeting minutes.

**MOTION:** Commissioner David Moore moved approval of the October 11, 2019 meeting minutes. Commissioner Cheryl Grieb seconded the motion. Motion carried unanimously.

#### b. Recommended Revisions to the Regional Project Prioritization Process

Ms. Lois Bollenback, River-to-Sea TPO presented the revisions to the Regional Project Prioritization Process. She explained that for the past few years, the CFMPOA has been developing a regional priority list which includes Strategic Intermodal System projects, regional trails and regional transit projects. She presented an overview of the process that the CFMPOA follows that outlines the process the CFMPOA follows in the development of the regional PPL lists, and it has been updated to include two new categories: Transportation

Regional Incentive Program (TRIP) and Transportation Systems Management and Operations (TSMO) projects.

**MOTION:** Commissioner Cheryl Grieb moved approval of the Regional Project Prioritization Process as presented. Commissioner Jay Zembower seconded the motion. Motion carried unanimously.

#### VIII. Presentations/Discussion

#### a. Central Florida Expressway Authority (CFX) Update

Mr. Glenn Pressimone, Chief of Infrastructure, CFX, provided an update of CFX projects. The CFX is a local independent special district in the state. CFX was established in 2014 with an expanded mandate to build and maintain a regional transportation network of 125 miles of roadways that connects Brevard, Lake, Orange, Osceola and Seminole counties. He discussed CFXs plans for the future of the region, the projects that are a part of the \$2.5 billion work plan, and emerging technology that CFX has incorporated into the existing infrastructure.

#### b. FDOT Funding Levels

Ms. Alison Stettner, Director of Policy Planning, FDOT Central Office, provided information on how transportation infrastructure is funded in the State. She explained that it is funded by a combination of federal, state, and local fuel taxes; fees on annual vehicle registrations, the initial registration, and vehicle titles; a \$2.00 per day rental car surcharge, and a share of documentary stamp taxes. She discussed the fiscal challenges of relying on the fuel tax as the primary source of transportation funding for the future. She explained that she feels that now is the time to begin the discussion of replacing it with a more sustainable option.

#### c. Florida Transportation Plan (FTP) Update

Ms. Alison Stettner, Director of Policy Planning, FDOT Central Office, gave a brief update on the public outreach efforts of the Florida Transportation Plan. She gave the website address to that Alliance members can find information and keep abreast of updates: www.floridatransportationplan.com.

#### VII. Presentation/Discussion

#### a. Regional Transportation Systems Management & Operations Program (Corridor Coalition) Presenter: Eric Hill

Mr. Eric Hill provided an update of progress made since the regional transportation summit held with the joint MPOS in July. The July 10<sup>th</sup> meeting ended with a resolve to participate in the effort, identify champions (either policy board members or MPO staff to champion TSMO efforts), and to re-convene another meeting to establish more structure. As a result of the efforts, the River-to-Sea and Space Coast TPOs have been added to the effort. The working group met on August 21<sup>st</sup>. The working group discussed developing an MOU between the MPO/TPOs throughout Central Florida in an effort to come to an agreement to advance the concept of TSMO planning throughout Central Florida and to establish a process by which to get the MOU executed through each MPO/TPO. A membership roster was developed which included FDOT districts. In the background, staff has been making efforts to sustain the initiative by applying for grant funding through the State Transportation Innovation Council (STIC) for TSMO planning along the I-4 corridor. The grant award was in the amount of \$100,000. Mr. Hill stated that the working group is scheduled to meet again on October 21 and report back on what steps that have been taken to get the MOUs executed, formalize governance of the group and to discuss bringing both the Central Florida Expressway Authority and the Tampa/Hillsborough Expressway Authority into the working group since they both impact Central Florida.

#### b. Presentation/Discussion: 2021 Legislative Positions

Presenter(s): Mr. Carl Mikyska, MPOAC and Mr. Ryan Matthews, Peebles Smith & Matthews

Mr. Carl Mikyska, Executive Director, Florida MPO Advisory Council, provided an overview of legislative positions supported by the MPOAC which are reviewed by the staff directors and presented to the MPOAC Governing Board. Mr. Mikyska stated that a new policy position has been added with regard to the ability to hold virtual meetings. He explained that in light of the experiences of 2020, the MPOAC is supporting new legislation that will add provisions to Florida's Sunshine Law to allow all government entities to hold virtual meetings during a declared emergency plus a period of 90 days past the declared emergency dates. Mr. Mikyska stated that when committee weeks resume in January, the legislative weekly newsletter will return. Mr. Mikyska discussed his concerns with earmarks and budgets. He discouraged earmarking projects out of concern for the impact that it would have on that project on the overall budget. He also expressed concern on the impact that it would have on the DOT and its ability to fund other projects.

Mr. Ryan Matthews, Peeples, Smith and Matthews, provided insights on the past legislative session and what to expect in the upcoming 2021 legislative session. Mr. Matthews thanked Mr. Mikyska for this thoroughness of his presentation detailing the constraints and issues for the 2021 legislative session. Over the next 18-24 months, projected \$5.5 billion budget deficit. For the 2020 legislative session, a \$93.2 billion budget (the largest in the State's history) was passed and ultimately \$1 billion was vetoed from the budget because of the coronavirus pandemic. An organizational session is set for November 17<sup>th</sup>. At that organizational session, the new leaders of the Senate and House will be installed. Committee

Mr. Matthews stated that from a policy perspective, a 2021 session will likely be dominated by governing during the time of a pandemic. He said that he agrees with Mr. Mikyska on the need to support legislation that allows for government agencies to have the ability to hold virtual meetings for continuity of operations. He will continue to keep MetroPlan Orlando abreast of any happenings as relates to transportation.

#### b. FDOT District Reports

Ms. Nichole Mills, represented FDOT District 1. Ms. Mills stated that District 1 has released its 2045 traffic model known as the DR1RPM, and will soon be conducting mini training webinars to provide an overview of the changes and differences between the 2040 and 2045 plan. The District is also reviewing new model software for the next plan update. The District continues to plan uses for the anticipated federal government stimulus funding for all phases of projects. Additional funding was obtained for buses for the Posner Center

Central Florida MPO Alliance April 9, 2021 - Meeting Minutes Page 2 of 5 Park and Ride facility at US 27 and I4 for transport over to the Poinciana SunRail station. The additional express buses will help to alleviate overcrowding and parking concerns at the Poinciana SunRail station.

Ms. Loreen Bobo, represented FDOT District 5, safety continues to be a top focus for District 5. She stated that the District continues to strive for Vision Zero. She provided an overview of "Operation Stride" (Statewide Traffic Railroad Initiatives using Dynamic Envelopes). She explained that the purpose of Operation Stride was to bring more driver awareness of where not to stop on railroad tracks. Ms. Bobo noted that a total 172 Dynamic Envelopes were installed in District 5 over the past year. Ms. Bobo reported that the I-4 Beyond the Ultimate project is slated for completion by the end of 2021. The District continues to plan uses for the anticipated federal government stimulus funding for all phases of projects. Ms. Bollenback, River to Sea TPO, thanked FDOT District 5 for great interaction and partnership they have created with the communities that they work with.

Mr. Siaosi Fine, represented FTE. He reported that FTE is widening the Turnpike mainline from SR50 in Clermont to the Minneola Interchange from four to eight lanes to include replacement of crossing bridges and a round-a-bout at CR 455. Construction is expected to begin in Mid-July 2021.

#### VII. Discussion and Consensus Items

#### a. Previous Meeting Minutes

Minutes of the October 10, 2020 Central Florida MPO Alliance meeting were provided for information. The CFMPOA will take formal action at a future in-person meeting to approve their recommendation.

#### VIII. Presentation/Discussion

#### a. Coast to Coast Trail/SunTrails Update

Ms. Robin Birdsong, Program Manager, SUN Trail and Transportation Alternatives, provided a brief overview of the Florida Transportation Plan, Florida's Vital Few Initiative, and the creation of the Florida Greenways and Trail System. Ms. Birdsong explained that the plan is coordinated by the Department of Environmental Protection (DEP), and that network maps are updated in coordination with partners and stakeholders every 3-5 years. The next update is anticipated for 2023. She discussed the two-tier funding structure, project phases, FDOT work program, schedule milestones. She provided contact information for Trail Coordinators in each District, and the website address www.floridasuntrail.com so that members can obtain information and keep up-to-date on progress.

#### b. Overview of the Process for Adoption of the Regional List of Priority Projects List

Ms. Georganna Gillette, Executive Director, Space Coast TPO, gave an overview of the adoption of the Regional List of Priority Projects List. The list, may be viewed at: <u>Regional LOPP 2020 All Tables-10-1-20 Final DRAFT.xlsx (metroplanorlando.org)</u>

#### c. Regional Transportation Systems Management & Operations Program Update

Mr. Eric Hill, Director of Transportation Systems Management & Operations, MetroPlan Orlando provided an update of the Regional TSMO Program. For the benefit of new members, Mr. Hill gave an overview of what TSMO is. He discussed the program framework which included deciding on a proper name for the group, developing and executing the MOU, development process, bringing the program to life by establishing a working group made up of staff from each of the partnering MPO/TPOs. The working group met on March 9<sup>th</sup> and will meet again on April 13<sup>th</sup>. Mr. Hill explained that efforts made to sustain the program by applying for grant funding through the State Transportation Innovation Council (STIC) for TSMO planning along the I-4 corridor. The grant award was in the amount of \$100,000 and have partnered with the Center for Urban Transportation Research (CUTR) to apply for a grant award of \$100,000 through the National Institute for Congestion Reduction to bring the academic arm into the program. Also partnered with CUTR for a Department of Energy grant that will evaluate proposed technologies that will enable automated driving systems for safety and energy. CUTR will use planning models for each MPO/TPO to evaluate the benefits.

#### d. Presentation/Discussion: 2021 Legislative Update

Ms. Virginia L. Whittington, Director of Regional Partnerships, MetroPlan Orlando, provided an update on the current legislative session. Ms. Whittington mentioned to Alliance members that proposed SB 62 which sought to abolish RPCs in the State of Florida which received a lot of attention early in the session lost traction and is no longer of concern. SB 100 titled Highways Projects, sought to repeal M-Cores passed in its Senate Committees; however, the companion bill, HB 763, has yet to be heard in House Committees. Ms. Whittington noted that MetroPlan Orlando's Tallahassee team will continue to monitor proposed SB 1412 and companion bill HB 1113 as it goes through the last rounds of committees. She noted that proposed legislation that calls for adding provisions to the Sunshine Law allowing local governments to hold virtual meetings during declared states of emergency, and 90 days beyond gained no traction in either the Senate or House.
