#### I. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Board Chair Cheryl Grieb called the meeting to order at 9:00 a.m. and welcomed everyone. Mr. Carson Good, GOAA, led the Pledge of Allegiance.

#### II. CHAIR'S ANNOUNCEMENTS

Chairwoman Grieb highlighted the Palm Beach TPA visit to tour the Brightline Facility on February 20<sup>th</sup> and thanked Commissioner Dallari and Mr. Huttmann for their participation. She recognized outgoing Board Chair Commissioner Mayra Uribe with a plaque and thanked her for her service. Commissioner Mayra Uribe reported on the February 15<sup>th</sup> TDLCB Meeting. Commissioner Uribe announced that Bill 1032 relating to the MPOAC failed. MetroPlan Orlando staff member Mighk Wilson provided the Safety Moment highlighting March as Bicycle Safety Month.

#### III. EXECUTIVE DIRECTOR'S ANNOUNCEMENTS

Mr. Huttmann provided an update on the Board Apportionment Plan, and the amended Interlocal Agreement. He acknowledged Commissioner Michael Scott, representing Orange County in place of Commissioner Gomez-Cordero. He noted that Commissioner Brandon Arrington (CFX Representative), was attending virtually; Mr. Huttmann updated Board members on the newly added performance measure for Greenhouse Gas Emissions; and provided an update on the 2024 Four Corners Summit held on February 15<sup>th</sup>. Mr. Huttmann reported that Council Member Gilbert, City of St. Cloud, participated in the MPOAC Institute on March 8<sup>th</sup> and 9<sup>th</sup>. He congratulated MetroPlan Orlando staff member Eric Hill on his 25-year work anniversary. Mr. Huttmann called attention to information contained in supplemental folders.

Ms. Lisa Smith called the roll and confirmed that a quorum was physically present.

Mr. Huttmann noted there were no changes to the agenda and announced that Secretary Tyler and the District 5 Leadership Team were hosting the Statewide Executive Leadership Team and unable to attend today's meeting.

#### X. OTHER ACTION ITEMS

A. Approval of FY 2025/26 Draft Unified Planning Work Program (UPWP)

Mr. Alex Trauger, MetroPlan Orlando staff, presented the draft FY 2025-26 Unified Planning Work Program (UPWP). Mr. Trauger explained that the UPWP is a two-year document that represents the MetroPlan Orlando working budget. It is one of the required documents that all MPOs must prepare and receive Board approval. MPOs in the State of Florida are required to prepare a UPWP every two years. He noted that the UPWP defines in very general terms the work that the MPO staff will be doing over the planning period. Some of the tasks will be done with the assistance of our General Planning Consultants.

- MOTION: Commissioner Viviana Janer moved to approve the draft Unified Planning Work Program (UPWP). Commissioner Christine Moore seconded the motion. Motion carried unanimously.
- B. Approval of Amendments to the FY 2024-2028 TIP (ROLL CALL VOTE)

Mr. Jason Sartorio, MetroPlan Orlando staff, requested Board approval to amend the FY 2023/24 – FY 2027/28 TIP to include the following item:

 FM #445299-1: SR 535 from N of SR 530/US 192 to S of International Dr. – This amendment adds a total of \$6,559,059 in federal, state, and local funding for construction including: \$905,745 in ACNR funds, \$2,467,959 in DDR funds, \$267,987 in LF funds, \$2,907,088 in SA funds, and \$10,280 in DIH funds.

Mr. Sartorio noted that funding is being added to a project where cost estimates have increased due to scope changes and cost increases for materials. A letter from FDOT staff explaining the amendment request was provided along with a fact sheet prepared by MetroPlan Orlando staff, and the draft resolution.

**MOTION:** Commissioner Viviana Janer moved to approve of the amendments to the FY 2024-2028 TIP. Commissioner Mayra Uribe seconded the motion. A roll call vote was conducted. Motion carried unanimously.

C. Approval of the FDOT Joint Certification

Ms. Amy Beckman, FDOT staff, presented FDOT's report on the 2024 Annual State Certification Review of MetroPlan Orlando. Ms. Beckman told Board members that the certification review is conducted annually and provided some highlights of the certification review. She reported that MetroPlan Orlando exhibits good financial practices and as a result was awarded a low-risk rating.

**MOTION:** Commissioner Mayra Uribe moved to approve the FDOT Joint Certification. Mr. Carson Good seconded the motion. Motion carried unanimously.

  - **MOTION:** Commissioner Bob Dallari moved approval of the Information Items for Acknowledgement; Items A through I. Commissioner Mayra Uribe seconded the motion. Motion carried unanimously.

#### XII. OTHER BUSINESS/PRESENTATIONS

#### A. Review of the 2024 Legislative Session

Ms. Virginia L. Whittington, MetroPlan Orlando, provided the Board with a review of the 2024 Legislative session. She stated that 1,900 bills were filed, and more than 50 were transportation related which MetroPlan Orlando watched, monitored or were significantly involved in. She provided an overview of the bills that MetroPlan Orlando monitored which included several that lined up with the approved legislative priorities and bills related to MPO efficiency and consolidation, distracted driving, and any bills that sought to repeal or rescind red light cameras. Ms. Whittington provided an overview of the approved budget and work program, and the bills that passed. Ms. Whittington noted that MetroPlan Orlando staff spent a significant amount of time meeting with elected officials in both the House and Senate concerning HB 749/SB 1032 regarding the governance structure of the MPOAC. She noted that the Bill ultimately failed.

#### B. Vision Zero Safety Action Plan Update

Mr. Mighk Wilson, MetroPlan Orlando, presented an update to the Vision Zero efforts. He disussed public engagement efforts, and the feedback map that allows the reporting of incidents or concerns and the ability to upload photos. He highlighted the FDOT Safety Strategic Plan workshop held on January 31<sup>st</sup>. He shared additions to the hub site and called attention to the Elected Officials Guide. He called attention to the Safety Guide for Kid's activity book, fact sheets on the HIN (High Injury Network), and trend analysis page. Mr. Wilson provided details of the Task Force Meeting #4 held on February 20<sup>th</sup>. He stated that the meeting covered topics such as a Benchmarking Process for the MetroPlan Orlando region, pairing the Countermeasures with identified projects from the HIN, and potential prioritization categories. He noted that the federal government published its Notice of Funding Opportunity (NOFO) on February 20 for the Safe Streets 4 All program. Mr. Wilson noted that there are still opportunities for planning or demonstration grants with later deadlines, that will be pursued for the region. He reviewed the next steps and stated that the Vision Zero Action Plan document is on track for adoption.

#### C. Update on the TSMO Master Plan

Mr. Eric Hill, MetroPlan Orlando, presented an update on the TSMO Master Plan. Mr. Hill discussed the makeup of the Steering committee and noted there had been six meetings held since June 2022. The final is scheduled for March 20<sup>th</sup>. Mr. Hill detailed the strategies and provided an overview of the project scope and provided the next steps. Mr. Hill noted several areas of focus, including leveraging existing investments, pursuing regional strategies and artificial intelligence.

#### D. Preview of Transportation for All (Title VI & LEP)

Ms. Sarah Larsen, MetroPlan Orlando presented the Transportation for All Plan. She explained that it is an update and expansion on Title VI and Limited English Plan (LEP). Ms. Larsen confirmed that MetroPlan Orlando is using USDOT's Equity Action Plan (2022) to expand the plan, focusing on underserved, overburdened, and disadvantaged communities. She stated that they also used USDOT resources including the Equitable Transportation Communities (ETC) web map to identify those areas most in need. She identified the types of disadvantages affecting people and shared the definition of transportation equity as defined by responses to the 2021 Regional Public Opinion Survey Report. She noted that a Partner Agency network is being established with the goal of having broad representation of the community. Ms. Larsen defined Transportation Underserved Communities (TUCs) as those places with the greatest disadvantage and need in the region and shared a map highlighting those areas. She shared the Equity Plan Development Timeline.

Ms. Joanne Counelis commented on the need for bus stops and shelters at several sites in Seminole County, and the need for 24/7 mass transit in the Region.

On behalf of MetroPlan Orlando, the Metropolitan Planning Organization for Orange, Osceola, and Seminole Counties I want you to know that we support Seminole County and their request for Community Project Funding. The request will fund roadway and public safety improvements as part of Seminole County's North Street Roadway Improvements – Phase 1 project. This project is in a residential neighborhood and surrounds and passes through the county's planned 123 acre Rolling Hills Park, formerly a golf course. Phase 1 was originally to be funded through MetroPlan Orlando (FY 2026-2027). However, due to overwhelming public support for both the planned park and roadway improvements, the County intends to accelerate the construction of Phase 1 of this project. Unfortunately, MetroPlan Orlando funds will not be available for this earlier start of the project. As such, the County is requesting funding from the Transportation, Housing and Urban Development (T-HUD) Account to accommodate the earlier start to the Phase 1 improvements.

The overall North Street Roadway Improvements Project is a Complete Streets project to address mobility, safety, and livability along North Street, Raymond Avenue, and North Palm Springs Drive. The addition of roundabouts as part of the larger project will serve to reconfigure access, improve traffic flow efficiency, slow driver speeds, and provide substantial safety and operational benefits for the neighborhood and planned park. Roundabouts have contributed to an 80% reduction in serious injuries and fatalities. As this area of the County continues to grow, improving the efficiency of a complete transportation network is vital for public safety and the economic growth of the community.

This Project is a priority for multi modal capacity, movement in the corridor and public safety. The project and the improvements associated with it are all consistent with the region's 2045 Metropolitan Transportation Plan and our full support.

On behalf of MetroPlan Orlando, the federally designated Metropolitan Planning Organization for Orange, Osceola and Seminole Counties, I am writing in support of the Florida Department of Transportation (FDOT) Multimodal Project Discretionary Grant application for the John Young Parkway (U.S. 17-92) at Pleasant Hill Intersection Improvements. The project will improve traffic flow at a major intersection in the Orlando Urbanized Area as well as improve access to nearby businesses and transit service, extend bike/ped facilities, and enhance the aesthetics of the corridor.

The John Young Parkway (U.S. 17-92) at Pleasant Hill Intersection Improvements will improve the operation of one of the busiest intersections in the area. This intersection handles over 6,000 vehicles between 4-6 pm each weekday. The current intersection design is unable to handle this volume, leading to significant travel delays. Further, this significant volume is leading to a high number of crashes due to unexpected stops and excessive queues. Conditions will only worsen with a projected 52 percent increase in vehicles traveling through this intersection over the next twenty years.

To address the mobility challenges, the John Young Parkway (U.S. 17-92) at Pleasant Hill Intersection Improvements includes an innovative intersection design to support the efficient movement of people and vehicles. The proposed innovative design includes a grade separation for eastbound through movements, and the quadrant roadway (eliminating all left turns from the main intersection), increases the capacity along the corridor and removes the conflict points that lead to serious crashes while preserving access to local businesses.


Additionally, the enhanced features in the proposed John Young Parkway (U.S. 17-92) at Pleasant Hill Intersection Improvements will provide a safe space for bicyclists and pedestrians, connections to the nearby LYNX transit service and improved Osceola County School System bus stops. This project also maintains the community feel by preserving mature oak trees that offer shade and enhanced aesthetics for bicyclists and pedestrians.





Dear Metropolitan Planning Organization Partners,

As the Florida Department of Transportation (FDOT) continues our collaboration with and in support of Florida's Metropolitan Planning Organizations (MPOs), we remain committed to providing updates on recent events to ensure clarity and transparency regarding FDOT's actions.

As you are aware, on December 7, 2023, USDOT issued a Final Greenhouse Gas (GHG) Rule requiring state DOTs and MPOs to establish and report on declining carbon dioxide targets biennially as part of the Transportation Performance Management (TPM) program. The Rule required state DOTs to submit declining GHG targets by February 1, 2024. However, the Infrastructure Investment and Jobs Act (IIJA) did not explicitly authorize USDOT to assess environmental performance and FHWA exhibited broad overreach in the promulgation of the GHG Rule.

Furthermore, the high level of efforts and costs associated with the GHG Rule compliance is burdensome and an economic hardship to our agency partners. This was especially important due to the language in the Rule that relates to MPOs, as Florida has the highest number of MPOs in the nation -27 MPOs and 33 UZAs (urbanized areas with populations over 50,000).

Florida has the best air quality on record and consistently commits to projects that protect our natural resources, including protecting our water quality and restoring the Everglades. Florida is the most populous state to meet or exceed the existing Environmental Protection Agency (EPA) benchmarks for air quality.

On December 21, 2023, Florida joined 20 other states and filed a complaint in Kentucky federal court requesting relief from the GHG Rule requiring states to submit declining GHG targets. Shortly after the filing, FHWA postponed the original target submission deadline to March 17, 2024, and ultimately to April 1, 2024.

The state of Texas initiated a separate challenge in a Texas federal court and received an Order from the District Judge on March 27 determining that the 2023 GHG Rule was promulgated in excess of USDOT's statutory authority. The judge vacated the Rule and provided relief to all impacted pending a 7-day administrative stay permitting USDOT to seek relief.

On April 1, the Kentucky federal court entered an Order finding that the GHG Rule exceeds FHWA's statutory authority and is arbitrary and capricious. Currently, no appeals have been filed in either case.

Thank you for your partnership throughout this very worthy process. As we move forward, we will continue to collaborate with our MPO partners and deliver a transportation system that will meet the needs of our growing state, support Florida's economic growth, and ensure resiliency of our network into the future.

## SAFETY SNAPSHOTS

In January, Florida's Pedestrian and Bicycle Safety Coalition renewed its commitment to safety at its quarterly meeting in Orlando. This meeting covered an array of safety topics, including a <u>"Walkshop"</u> exploring safety installations and intersection murals through out <u>Orlando</u>. These innovative art pieces have been proven to reduce crashes by over 50 percent <u>according to a</u> <u>study</u> from Bloomberg Philanthropies.

In March, FDOT, in collaboration with its Motorcycle Safety Coalition, launched the Ride SMART 2 Daytona campaign. The campaign aimed at ensuring the safety of all participants during Daytona Beach Bike Week 2024, a globally renowned event. This celebration of motorcycle culture and camaraderie typically draws 500,000 to 600,000 enthusiasts to our area, but also brings a critical need for safety awareness. The 2023 Daytona Beach Bike Week saw 31 serious injuries and four deaths. This safety campaign sought to ensure that even more visitors get home safely this year.

This Spring, FDOT District Five is conducting a series of workshops around the FDOT<u>Strategic</u> <u>Highway Safety Plan</u> and Target Zero, our effort to eliminate fatalities and serious injuries on all of Florida's public roads. Currently, workshops have rolled out to the Space Coast, River to Sea, and MetroPlan TPOs.

## S.R. A1A RESILIENCY PLAN

A long-awaited effort to strengthen the S.R. A1A corridor between Roberta Road in Ormond-by-the-Sea, Volusia County, and Osprey Drive in Beverly Beach, Flagler County is now underway.

The plan proposes to place buried, earth-retaining secant walls along two stretches of roadway that are vulnerable to damage from storms. This is intended to improve resilience and overall community safety.

In February, representatives of the project participated in the First Friday event at Veterans Park Flagler Beach to communicate the plan's recommendations along the 13-mile corridor and receive community feedback. Construction began shortly after this event, so this was a timely and beneficial opportunity to meet with over 300 community members to answer questions and learn opinions in a positive, relaxed environment.

The community response was very supportive, with several questions about construction and potential lane closures. FDOT assured the community that they plan to restripe the road temporarily to move traffic over to the West side. They also explained changes to beach access and walkovers, and explained that only occasional road closures are expected. The USDOT's Safe Streets and Roads for All (SS4A) is a program focused on making transportation safer, working to reduce accidents and injuries on roads and streets. The initiative brings together different levels of government and communities to improve infrastructure design, implement traffic calming measures, enhance pedestrian and cyclist safety, promote safe driving behaviors and more.

Between 2022 and 2026, the initiative has \$5 billion in appropriated funding available for grantees and is expected to improve roadway safety for about 70 percent of the US population.

In our District, current grantee recipients include: MetroPlan Orlando, River to Sea TPO, Merritt Island Redevelopment District, the City of Ocala and more. Check out <u>all of this years'</u> <u>SS4A Grant Awards</u> here.

## TRAINING UPDATE

On January 18, 2024, a newly developed training session on Community Engagement was given to the participants of FDOT's Professional Engineer (P.E.) Training Program.

This new training provides tips and tools to go above and beyond the basic checklist approach to public involvement. Attendees learned new methods and strategic approaches to engaging key stakeholders, media, elected officials, and the community throughout the project lifecycle.

The session featured a full day of speakers, including Secretary Jared Perdue, Huiwei Shen, Kathleen Toolan, Kellie Smith, and Steven Buck, as well as Transportation Consultant Maryam Ghyabi-White. Each speaker addressed crucial aspects of the engagement process, including the importance of relationships, developing smart goals, forming partnerships, and providing project overviews.

Additionally, case studies were discussed providing real-life examples and scenarios from the field to help trainees envision the potential pitfalls and opportunities that they might face within a project.

A version of this training session will be offered throughout the state in the upcoming months – stay tuned for enrollment details.

MetroPlan Orlando and its planning partners are committed to improving public safety and security. In February 2019, the MetroPlan Orlando board unanimously supported the Florida Department of Transportation's Vision Zero statewide safety performance targets. This policy acknowledges human life and health is paramount and that no loss of life is acceptable. Safety and security are shared responsibilities between transportation users and the professionals that plan, design and operate the regional system.



## Indicators:

- Number of fatalities, serious injuries and crashes by mode/user
- Rate of fatalities, serious injuries, crashes per 100 million vehicle miles traveled (VMT) for all modes/users
- Number of evacuation route lane miles per 1,000 households





#### A Safe System is built on six principles.

At the highest level, a Safe System acknowledges that while humans make mistakes, death and serious injury are unacceptable outcomes of using our transportation system.

#### The Six Safe System Principles



#### DEATH AND SERIOUS INJURY ARE UNACCEPTABLE

While eliminating all crashes is an eventual goal, this plan focuses on eliminating crashes that result in death and serious injuries on state roads in Manatee County.

#### HUMANS MAKE MISTAKES

Everyone makes mistakes that can lead to a crash. The goal of the Safe System Approach is to design and operate our transportation system to ensure these mistakes don't have life-altering impacts.

#### HUMANS ARE VULNERABLE

Human bodies can only withstand a limited amount of impact from a crash before death or serious injuries occur.

#### **RESPONSIBILITY IS SHARED**

Every person in the transportation system, from elected officials to everyday users, to planners and engineers, has a role to play in reaching zero fatalities and serious injuries.



#### SAFETY IS PROACTIVE

Rather than waiting for crashes to occur, transportation agencies should seek to proactively identify and address dangerous situations.



#### REDUNDANCY IS CRUCIAL

Redundancy means making sure there are multiple layers of the transportation system working together towards safer outcomes so that if one layer fails, people are still protected.



#### Combined Walk Shed of All Schools



### **2050 Metropolitan Transportation Plan** Draft Goals and Objectives April 2024

#### **Overview**

The 2050 MTP is guided by five long-term goals, which describe the desired transportation system in the year 2050. The five goals are supported by fifteen objectives, which are specific, measurable statements that support one or more goals. Together, these goals and objectives describe an interconnected, multimodal transportation system that enhances the quality of life in Central Florida and allows all residents and businesses to flourish.

The goals and objectives build on the 2045 MTP. They were developed based on a review of goals and objectives established by neighboring MPOs or peer MPOs in Florida and other states as well as stakeholder and public input. The goals and objectives are consistent with the national transportation performance goals and required metropolitan planning factors established in federal law and rule, as well as with the Florida Transportation Plan, the statewide long-range transportation plan. The goals and objectives are also consistent at a high level with other regional and local plans, including local government comprehensive plans. The goals are not listed in priority order. Specific indicators will be defined to measure progress toward the goals and objectives.

#### **Goal: Safety**

#### PROVIDE A SAFE AND SECURE TRANSPORTATION SYSTEM FOR ALL USERS

A safe and secure transportation system is the most fundamental commitment we can make to Central Florida's residents, businesses, and visitors. MetroPlan Orlando and its partners for many years have committed to a vision of zero fatalities and serious injuries. This goal expands our view of safety to include better preparing for and responding to emergency events, as well as reducing the potential for harm from environmental, security, and other risks to transportation users and the regional system.

#### **OBJECTIVES**

- Eliminate deaths and serious injuries on the transportation system, with an emphasis on the most vulnerable users
- Provide infrastructure and services to help mitigate, prepare for, respond to, and recover from emergencies
- Increase the resilience of transportation infrastructure to environmental, security, and other risks

#### **Goal: Reliability**

#### PROVIDE A RELIABLE TRANSPORTATION SYSTEM ACROSS ALL MODES FOR PEOPLE AND FREIGHT

The region's transportation system should provide reliable service to all users. This means that roads, bridges, rail corridors, passenger and freight terminals, and transit vehicles are in good condition. It also means that customers can expect reliable travel times between destinations and efficient connections between modes. Finally, it means that the system adapts to accommodate changing customer expectations and technologies.

MetroPlan Orlando and its partners will continue to make Central Florida's transportation system more accessible, inclusive, and responsive to the needs of the diverse communities it serves.




