This Meeting Summary serves to reflect the actions taken and major topics discussed at the December 1, 2023, public meeting of the Sun Coast Transportation Planning Alliance (SCTPA). The meeting was held at the Florida Department of Transportation (FDOT) District 7 Auditorium, 11201 McKinley Drive, Tampa, Florida. A sign in sheet was provided.

Meeting Called to Order:

- Chair Pffeifer called the meeting to order at 10:30 a.m.
- A quorum was declared.

Actions by Vote:

Approval of the June 23, 2023, SCTPA Meeting Summary - Approved Unanimously

Public Comments:

• There were none.

TMA Update:

• The TMA took action on the Regional Transportation projects to transmit the projects to the SCTPA. TMA motioned to transit a report to the Governor and Legislator regarding the central merger of Pinellas, Pasco, and Hillsborough MPO's to one MPO.

Presentations

Major Regional Transportation Priority Projects:

- Chelsea Favero, Planning Manager, Forward Pinellas MPO, presented the Major Regional Transportation Priority Projects. Project schedule consisted of Demand Analysis in June 2023 and the Safety Analysis in August 2023. Project Identification took place in October 2023, and the final report should be available in January 2024.
- Hernando/Citrus projects include US 41 from Oak Forest St. to Lake Lindsey Road, SR 50 from Emerson Road to I-75, and County Line Road from East Road to the Suncoast Pkwy.
- Pasco projects include County Line Road from East Road to Suncoast Parkway, I-75 from Sr 52 to SR 54/56, BB Downs from SR 56 to Bearss Ave., SR 54/56 from Suncoast Parkway to Bruce B Downs, US 41 from Connerton Blvd. to Caliente Blvd., and US 19 from SR 52 to Tampa Road.
- Hillsborough projects include I-75 from East Fowler Ave. to I-275, I-4 from I-275 to W of US 27, and BB Downs from SR 56 to Bearss Ave.
- Pinellas projects include I-275 from 54th Ave S. to I-75, I-275 from 54th Ave. S. to Gandy Blvd., US 19 from 118th Ave. N. to 70th Ave. N., US 19 from Drew Street to East Bay Drive, US 19 from SR 580 to Drew Street, US 19 from SR 52 to Tampa Road, and SR 60 from McMullen Booth Road to Nova SE.
- Polk projects include I-4 from I-275 to W of US 27, SR 60 from Bonnie Mine Road to US 27, US 17/92 from Osceola County Line to East Hinson Avenue, Ronald Reagan Parkway from US 27 to US 17/92, and US 27 from I-4 to Dundee Road.
- Sarasota/Manatee projects include US 41 from US 19 to US 301; 301 Blvd./15th Street from US 41 to 63rd Ave.; Fruitville Road from US 41 to Dog Kennel Road; and University Parkway from Longwood Drive to East of I-75.
- Next steps are to refine the corridors, finalize documentation and take action from the SCTPA to transmit priorities to MPO/TPO's and FDOT.

Legislative Updates Relative to SCTPA

- Whit Blanton, with Forward Pinellas gave the Legislative Updates.
- HB 1487: Pinellas Suncoast Transit Authority, Pinellas County. A local bill by Chaney. Pinellas Suncoast Transit Authority, Pinellas County; Revises definition of "public transit"; revises membership of governing body of authority; revises powers of authority; establishes requirements for advertising placed on authority property; provides for best budget practices; establishes procedures for lane elimination; prohibits certain offices, boards, employees, or other actors whose purpose is to eliminate or reallocate public lanes; requires semiannual reporting of certain provisions to Pinellas Board of County Commissioners. Effective Date: 7/1/2024.
 - The Pinellas Bill (Local Bill) will make major changes to the government operations in Pinellas Transit Authority (PTA). As proposed the Bill will reduce the size of the governing board from 15 to 11 members. Four seats of those seats will be allocated to the County Commissioners and the other seven individual seats will be filled by appointment by the Senate President, and the Speaker of the House. The PTA Governing Board will report to the Board of County Commissioners. Lane elimination or repurposing needs must be approved by 2/3 majority PTA Governing Board and reported to the Board of County Commissioners.
- SB 266: Department of Transportation General Bill by Hooper. Department of Transportation; Prohibiting the department from annually committing more than a certain percentage of revenues derived from state fuel taxes and motor vehicle license-related fees to public transit projects; replacing the term "public-private partnership agreement" with the term "comprehensive agreement"; prohibiting additional metropolitan planning organizations from being designated in this state after a specified date; creating within the department a local agency program for a specified purpose, etc. Effective Date: 7/1/2024. See also, companion bill HB 287 by Espisito.
 - There is already a 15% minimum public transit, and this bill would create a 20% cap, which will significantly restrict the use of the fees. The state funds do not necessarily require a federal match. (Except funds that are approved by a supermajority vote of county commissioners, of the county of which the project is located.) The bill would create local agency programs to aid counties and cities to develop, design, and construct transportation

- with federal funds. After July 1, 2024, additional MPO's may not be designated within the state except for new urban areas that are not continuous in other urban areas.
- HB 107: Electric and Hybrid Vehicle License Fees general bill by Esposito. Electric and Hybrid Vehicle License Fees; Imposes additional annual license fees on electric vehicles & plug-in hybrid electric vehicles; increases such fees at certain times; authorizes persons & entities to biennially renew registrations for such vehicles; provides for distribution of proceeds from additional annual license fees; specifies requirements for use of proceeds by local governments; provides exemptions; provides for future expiration. Effective Date: 7/1/2024. This would charge a \$200 electric vehicle license fee for each vehicle. The fee would be increased to \$250 in 2029. There would be a fee of \$150 for plug-in hybrid vehicles in 2034.
- SB 58: Sales Tax Holiday for Micromobility Vehicles and Related Personal Safety Equipment -- general bill by Stewart. Sales Tax Holiday for Micromobility Vehicles and Related Personal Safety Equipment; Providing a sales tax exemption during a specified period on the retail sale of micromobility vehicles and related personal safety equipment; defining the terms "micromobility vehicle" and "related personal safety equipment", etc. Effective Date: Upon becoming a law.
- HB 449: Speeding by Motor Vehicles -- general bill by Michael; (CO-INTRODUCERS) Alvarez.
 Speeding by Motor Vehicles; (30 MPH and over) Increases penalties for specified motor vehicle operating offenses; provides that operation of motor vehicle in specified amount in excess of posted speed liming creates conclusive presumption for purposes of vehicular homicide statute; specifies methods for determining motor vehicle's speed. Effective Date: 10/1/2024.

Regional LRTP Needs Assessment & FDOT Tentative Work Program Review

- Chelsea Favero, Planning Manager, Forward Pinellas MPO, provided an update on the status of the Regional LRTP Needs Assessment and FDOT's new Draft Tentative Work Programs for District's One and Seven.
- The Demand Analysis was completed in June 2023, the Safety Analysis was completed in August 2023, the Project Identification was completed in October 2023, and the Final report should be complete by January 2024. The Demand Analysis Data includes mobile location data, consumer, and resident data, built environment data, and credit transaction data. The Congestion Analysis includes existing and 2045 projections, focus on volume and capacity ratio. The Crash Data Analysis includes fatal and serious injury crashes, corridors with the highest crashes from both local and regional perspective and developed a Regional High Injury Network. Project identification includes level of congestion on the corridor, crash history, MPO Project Priority, Logical Termini, and travel flows used for Transit Corridors
- Hernando/Citrus include US 41 from Oak Forest Street to Lake Lindsey Road, SR 50 from Emerson Road to I-75, and County Line Road from East Road to Suncoast Parkway. Hillsborough County projects include I-75 from East Fowler Ave to I-275, I-4 from I-275 to W of US 27, and BB Downs from SR 56 to Bearss Ave. Pasco projects include County Line Rd. from East Rd to Suncoast Parkway, I-75 from SR 52 to SR 54/56, Bruce B Downs from SR 56 to Bearss Ave., SR 54/56 from Suncoast Parkway to BB Downs, US 41 from Connerton Blvd. to Caliente Blvd., and US 19 from SR 52 to Tampa Road. Pinellas projects include I-275 from 54th Ave. S to I-75, I-275 from 54th Ave. S to Gandy, US 19 from 118th Ave N to 70th Ave., US 19 from Drew Street to East Bay Drive, US 19 from SR 52 to Tampa Rd., and SR 60 from McMullen Booth Road to Nova SE. Polk projects include I-4 from I-275 to West of US 27, SR 60 form Bonnie Mine Road to US 27, US 17/92 from Osceola County Line to E. Hinson Ave., Ronald Reagan Parkway from US 27 to US 17/92, and US 27 from I-4 to Dundee Road. Sarasota/Manatee projects include US 41 from US 19 to US 301, 301 Blvd/15th Street from US 41 to 63rd Ave., Fruitville Road from US 41 to Dog Kennel Road, University Parkway from Longwood Drive to East of I-75.

- Transit projects are based on regional travel demand and not based on congestion relief.
- The next steps will be to refine the corridors and finalize documentation. Projects will be integrated into MPO's Long Range Plans, and projects will be considered for future prioritization by SCTPA.

Approve Meeting Calendar for 2024

• Proposed 2024 Meeting dates for TMA are Feb 16th May 17th, Sept. 20th, and Dec. 6th, 2024. SCTPA 2024 meeting dates are May 17th, and December 6, 2024. Proposed dates approved unanimously.

Updates on Moving Florida Forward

• Kyle Purvis, FDOT gave The Moving Florida Forward projects which include, I-75 at Fruitville Road Interchange Fall 2024 anticipated cost \$192M; I-4 at SR 33 Interchange, late 2024, anticipated cost \$197M; I-75 at Pine Ridge Road Interchange early 2025, anticipated cost \$23M; I-4 from US 27 to Champions Gate in Fall 2026, anticipated cost \$635M; I-75 from Golden Gate Pkwy to Corkscrew Road in Fall 2027, anticipated cost \$578M; SR 70 from Bourneside Blvd. to Waterbury Road Fall 2024 anticipated cost \$53M; SR 29 from CR 846 to New Market Road in Spring 2027, anticipated cost \$85M; and SR 29 from New Market Road to SR 82 in Spring 2027, anticipated cost \$44M.

District 1 Updates:

- Kyle Purvis, FDOT gave the D1 Update.
- Mr. Purvis discussed a new statewide regional trail corridor between Collier and Polk County.
- Major construction projects underway in Manatee County include the I-75/US 301 Interchange and the Desoto Bridge which is funded for construction in FY 2027. Also, the Sarasota Bradenton International Airport Terminal expansion is underway and should be completed by late 2024.
- He highlighted two rail safety projects in Polk County including CSX crossing at SR 60 and SR 655 which are programmed for improvements.

District 7 Updates:

- Elizabeth Winters, FDOT provided the D7 Update.
- Ms. Winters provided an overview of the District's "Transportation Talks" public outreach program. The program is intended to create an open line of communication directly with the members of the community. FDOT's approach is to have several outreach opportunities, both in-person and virtually, to seek input from the citizens who live, work, and play along the selected corridors. In addition to hearing the community's concerns, the meetings present a unique opportunity to inform citizens on FDOT processes. This can range from understanding how the funding works to how closing a median opening is the safer option to how to find information related to general inquiries or project information. After the completion of the outreach the Department should sponsor project(s) to address the major correctable concerns and continue to keep an open line of communication with the community members. Ideally, the network created with the community conversations will empower citizens with an understanding of FDOT and how together, we can work toward our Target Zero goal.

SunRail Extension - Transit Concept and Alternative Review:

• Kyle Purvis, with FDOT District One gave an update on the proposed SunRail extension in Polk County. As part of FDOT's study, seven (7) station locations were evaluated between Lakeland and the Poinciana SunRail station near the Osceola County line – a distance of 37 miles. In terms of next steps, the first phase to downtown Haines City will be starting a project development and environmental (PD&E) study next year.

Public Comments:

• The chair opened the floor for public comment and there were none.

Board Member Comments and Updates:

• The next regular meeting of the Sun Coast Transportation Planning Alliance (SCTPA) will be hosted by Forward Pinellas on May 17, 2024, beginning at 10:30 a.m., in the Florida Department of Transportation (FDOT) District 7 Auditorium, 11201 McKinley Drive, Tampa, Florida.

Transportation Regional Incentive Program

- Part of Growth Management Legislation (2005)
- Regional Planning Incentive Tool
- Provides State Funds for Regional Travel
- Matching Fund Commitment: FDOT will pay up to 50%; Local Match of 50% is required





What is TRIP?






