I. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Board Chairwoman Christine Moore called the meeting to order at 9:00 a.m. and welcomed everyone. Commissioner Nicole Wilson, Orange County, led the Pledge of Allegiance.

II. CHAIR’S ANNOUNCEMENTS

Commissioner Moore reported on the January 9th FDOT Steering Committee meeting. Commissioner Viviana Janer reported on the January 22nd Central Florida Commuter Rail Commission meeting. Commissioner Mayra Uribe reported on the January 28th MPOAC Meeting. MetroPlan Orlando staff member Mighk Wilson provided the Safety Moment highlighting Rail Crossing Safety.

III. EXECUTIVE DIRECTOR’S ANNOUNCEMENTS & AGENDA REVIEW

Mr. Huttman noted that Mr. Joe Nunziata (GOAA alternate for Ms. Stephanie Kopelousos) was attending virtually, along with Mayors Art Woodruff (City of Sanford) and Jackie Espinosa (City of Kissimmee) and Commissioner Arrington representing CFX. He acknowledged Mr. Jim Stroz FDOT District 5 alternate for Secretary John Tyler. Mr. Huttman announced the retirement of Sally Morris, Finance Clerk, and welcomed new staff members Jamie McMillan, student intern and Natalia Barbour, Senior Transportation Planner. He highlighted the recipients of the USDOT SS4A grants. He provided the latest updates to the federal reauthorization for transportation and the Lake to Lake Trail. Mr. Huttman reminded Board members of the MPOAC Institute scheduled for May 1st. He encouraged Board member participation to learn more about the MPO process. Mr. Huttman also called attention to the items in supplemental folders and noted that Slade Downs would present Item IX. A. TIP amendment.

His safety moment focused on February 6th Florida School Crossing Guard Appreciation Day

- A. Approval of Amendments to the FY 2026-2030 Transportation Improvement Program (TIP) (Roll Call vote)

Mr. Slade Downs, MetroPlan Orlando, requested approval of Amendments to the FY 2025/26 – FY 2029/30 Transportation Improvement Program. A letter from FDOT explaining the amendments, a summary prepared by MetroPlan Orlando staff, the draft resolution, and the full list of amendments were provided.

MOTION: Commissioner Viviana Janer moved approval of the amendments to the FY 2026-2030 Transportation Improvement Program (TIP). Commissioner Mayra Uribe seconded the motion. A roll call vote was conducted, and the motion carried unanimously.

- B. Approval of Federal Annual Safety Performance Measures & Targets

Ms. Lara Bouck, MetroPlan Orlando, requested approval and support for the federal transportation performance measures and targets. She noted that the support of the safety performance measure targets has been done annually since 2018 as a part of the performance-based planning process. Ms. Bouck gave a brief presentation on the five federal performance measures, and noted that today’s requested action focuses on safety, bridge and pavement conditions and system performance/reliability. She provided an overview of each performance measure, and the current state of the system performance.

MOTION: Commissioner Nicole Wilson moved approval of the Federal Annual Safety Performance Measures and Targets. Commissioner Maribel Gomez-Cordero seconded the motion. Motion carried unanimously.

MOTION: Commissioner Bob Dallari moved approval of the Information Items for Acknowledgement: Items A through O. Maribel Gomez-Cordero seconded the motion. Motion carried unanimously.

XI. OTHER BUSINESS/PRESENTATIONS.

A. Status Update of the 2026 Legislative Session

Ms. Virginia L. Whittington, MetroPlan Orlando, gave a status update on the 2026 Legislative Session. She provided a list of bills to watch, bills that are moving and bills that are at risk. Ms. Whittington noted that by the March 11th meeting, both Chambers would have released their initial budgets, adding that property tax reform negotiations are coming to the legislature's attention currently. Ms. Whittington noted that the Governor's 2627 budget proposes \$15.4 billion for transportation, 2% higher than the last proposed budget. She also noted that there are more than 2,800 local appropriation requests totaling approximately \$21 million. Ms. Whittington highlighted bills that are of special interest to the MetroPlan Orlando region SB 382/HB 243 related to e-bikes, e-mobility and safety. She called attention to other bills that are being monitored by MPO. The members of the Board discussed the pros/cons of the bills discussed. Consensus was to have Ms. Whittington come back to the March 11th meeting and provide another update as the session ends.

B. MetroPlan Orlando Pilot Program on E-Bike Safety

Mr. Mighk Wilson, MetroPlan Orlando, presented the Pilot Program for E-Bike Safety. Mr Wilson presented statistics on the percentage of bicycle crashes that involved e-bikes and/or e-scooters. He outlined the virtual program that will be aimed at new drivers and soon to be drivers noting the drivers will be trained in how to operate these motorized vehicles. The course will be free of charge to students and focus specifically on grades 7 through 10. The course is developed by the

American Bicycling Education Association, the developers of cycling savvy course, with 21 modules, approximately 60 minutes each, and will include quizzes and pre and post course surveys. Mr. Wilson highlighted what each section would cover. Mr. Wilson discussed the project timeline which includes ongoing coordination with the local school boards. He noted that course distribution would begin in late winter, or early spring and the report is estimated to be completed by June 30th with results by grade level and future implementation recommendations.

C. Informational Presentation on the FY 26/27-FY 27/28 Unified Planning Work Program (UPWP)

Mr. Alex Trauger, MetroPlan Orlando, provided a preview of the upcoming Unified Planning Work Program (UPWP) for Fiscal Years 2027 and 2028. Mr. Trauger explained that the UPWP is a two-year document that represents the MetroPlan Orlando operating budget; and it's one of the required documents that all MPOs must prepare and receive Board approval. Mr. Trauger reviewed the timeline for transmittal to FDOT, the organization and core tasks detailed in the document, and proposed studies and planning activities. Mr. Trauger stated that the draft UPWP will be presented at the March meeting for approval.

D. LYNX Transit Development Program

Mr. Myles O'Keefe, LYNX, presented the annual update to the LYNX Transit Development Plan highlighting goals, accomplishments, service changes, and upcoming projects. He noted recent achievements which include the opening of the Pine Hills Transfer Center in August 2025, the completion of an ADA transition plan, an update of the Human Services transportation plan. Upcoming projects include a transit-oriented development planning project along State Road 436 and a new bus transfer facility at the airport. Mr. O'Keefe noted that the plan will be presented to the LYNX Board for authorization.

TECHNICAL ADVISORY COMMITTEE BYLAWS

Section 1. Authority, Creation

In accordance with the 1962 Federal Aid Highway Act requiring that transportation planning be comprehensive, cooperative, and continuing in nature, a transportation technical committee known as the "MetroPlan Orlando Technical Advisory Committee" is hereby created.

Section 2. Definitions

For the purpose of these Bylaws, the term "Technical Committee" or use of the acronym "TAC" shall mean the MetroPlan Orlando Technical Advisory Committee.

Section 3. Purpose

The purpose shall be to develop, coordinate and/or review transportation studies, plans, and programs to provide a balanced, multimodal transportation system. The committee shall also provide comments and recommendations based on the technical sufficiency, accuracy, and completeness of said studies, plans, and programs. It shall be the function of the Technical Committee to:

- A. Be responsible for the review of all transportation studies, reports, plans and/or programs and recommending action pertinent to the subject documents to MetroPlan Orlando.
- B. Develop priority recommendations to the MetroPlan Orlando Board and/or other agencies responsible for plan and program implementation based upon the needs as determined by technical studies.
- C. Be responsible for assisting MetroPlan Orlando with coordinating public information concerning the studies.
- D. Serve as an advisory committee for the completion of all required transportation studies, plans development, and programming recommendations required under the public laws pertaining to all modes of transportation and transportation support facilities.
- E. Serve as an advisory committee to any and all duly constituted area-wide transportation authorities and/or boards, as well as area-wide planning boards or councils for physical

development, health, social or comprehensive planning upon direct request of such authorities, boards or councils.

- F. Annually review and revise the MetroPlan Orlando Prioritized Project List. This list will be the source of candidate highway, Transportation System Management and Operations (TSMO), bicycle and pedestrian and transit projects, and other categories of projects as necessary, to be implemented for the region and each county; for projects meeting state and federal eligibility, and any new funds identified at the local, state or federal level.
- G. Assist in other functions as deemed desirable by the MetroPlan Orlando Board.

Section 4. Membership, Appointments, Term of Office, Vacancies, Removal from Office

A. Membership

Planning, engineering, and/or management specialists shall represent the various public governmental bodies, authorities, and agencies of Central Florida and shall be involved in the transportation planning process by the establishment of a technical advisory committee.

- 1. The intent of the membership composition of the Technical Committee is to represent planning and engineering expertise from federal, state, regional or local agencies. Municipalities within Orange, Seminole and Osceola Counties are eligible for representation. Voting representation for each jurisdiction will be determined by population, according to the latest census and/or the University of Florida population estimates. The MetroPlan Orlando Board may authorize additional voting representatives to the Technical Committee, upon written petition through the Technical Committee.
- 2. The allocation of voting representation of the Technical Committee shall be based on the following criteria:
 - (a) Local jurisdictions with a population of 100,000 or more shall be allocated three (3) votes each.
 - (b) Local jurisdictions with a population between 50,000 and 99,999 shall be allocated two (2) votes each.
 - (c) Local jurisdictions with a population between 5,000 and 49,999 shall be allocated one (1) vote each.
 - (d) Local jurisdictions with population less than 5,000 shall be allocated one (1) non-voting seat each.
 - (e) Local transportation agencies/authorities and school districts shall be allocated one (1) vote each.

3. The voting representation is three (3) voting representatives from each of the following:
 - (a) Orange County
 - (b) Osceola County
 - (c) Seminole County
 - (d) City of Orlando

4. The voting representation is two (2) voting representatives from each of the following:
 - (a) City of Apopka
 - (b) City of Kissimmee
 - (c) City of Ocoee
 - (d) City of Sanford
 - (e) City of St. Cloud
 - (f) City of Winter Garden

5. The voting representation is one (1) voting representative from each of the following:
 - (a) City of Altamonte Springs
 - (b) City of Belle Isle
 - (c) City of Casselberry
 - (d) City of Lake Mary
 - (e) City of Longwood
 - (f) City of Maitland
 - (g) Town of Oakland
 - ~~(h) City of Ocoee~~
 - (i) City of Oviedo
 - (j) City of Winter Park
 - ~~(k) City of Winter Garden~~
 - (l) City of Winter Springs

6. The non-voting representation is one (1) from each of the following:
 - (a) Town of Eatonville
 - (b) City of Edgewood
 - ~~(c) Town of Oakland~~
 - (d) Town of Windermere
 - (e) University of Central Florida

7. The voting representation is one (1) voting representative from each of the following transportation agencies/authorities and school districts:
 - (a) Central Florida Regional Transportation Authority/LYNX
 - (b) East Central Florida Regional Planning Council
 - (c) Greater Orlando Aviation Authority
 - (d) Kissimmee Gateway Airport
 - (e) Central Florida Expressway Authority
 - (f) Central Florida Tourism Oversight District (formerly Reedy Creek Improvement District)
 - (g) Sanford Airport Authority
 - (h) Seminole County Public School District

- (i) Orange County Public School District
- (j) Osceola County Public School District

- 8. Upon written petition to the Technical Advisory Committee, additional non-voting advisory members may be appointed to the Technical Committee with the recommendation of the Technical Committee and the approval of the MetroPlan Orlando Board.
- 9. In addition, there shall be non-voting advisors from each of the following agencies: the Florida Department of Transportation District V and the Florida's Turnpike Enterprise.

B. Appointments

- 1. Each represented agency shall appoint one primary and at least one designated alternate voting member from each of the membership agencies listed in Section 4 A for which it is eligible. These appointments shall be made in writing by the County Commission Chair/Mayor, City Mayor, County Administrator, City Administrator, City Manager, Deputy/Assistant City Administrator, Deputy/Assistant County Administrator, School Superintendent, ~~and or~~ the Executive Director of other members' agencies. The failure of an agency to appoint a primary representative will result in that agency losing its voting authority on the Technical Committee.
- 2. The appointed representatives, both primary and alternates, shall be selected from the agency membership listing under Section 4 A.
- 3. In the absence of the primary member, the alternate member shall have the same privileges as the primary member and may serve on a subcommittee.

C. Term of Office

The term of office for a Technical Committee member shall be for an indefinite period, or until reappointment, or until the appointment of a successor. Separation from employment of the jurisdiction or agency represented constitutes the end of an appointment.

D. Vacancies and Membership Revisions

Any vacancies in membership shall be filled in the same manner as the initial appointment. The Technical Committee membership may be revised if justified by the most recent University of Florida or U.S. Census population figures.

E. Removal from Office

- 1. Members serve in an advisory capacity, as volunteers, without compensation, and at the pleasure of the MetroPlan Orlando Board and the applicable appointing authority.

2. Grounds for Removal
 - a. Removal for excessive absenteeism
 - i. Each member is expected to demonstrate interest in the committee's activities through the member's or a designated alternate's participation in the scheduled meetings.
 - ii. If a member has three (3) consecutive absences from the meetings or has missed a majority of meetings during the year, the supporting MetroPlan Orlando staff person shall notify the appointing authority and said member in writing in an effort to ensure full participation in the committee.
 - iii. Staff may recommend removal of members with excessive absences to the MetroPlan Orlando Board and appointing authority.
 - b. Removal for cause:
 - i. A member may be removed for cause for:
 - a) Any conduct by a member, which in the opinion of MetroPlan Orlando, is inappropriate or unsuitable and which would adversely affect, lower, or destroy the respect or confidence of MetroPlan Orlando in the ability of the member to perform his or her duties as a member of the committee, or conduct which brings disrepute or discredit to the committee or to MetroPlan Orlando;
 - b) Violation of any provision of an applicable statute, county, or city code of ethics governing the conduct of officials;
 - c) Malfeasance, misfeasance, neglect of duty, or inability to perform his or her official duties; or
 - d) Conviction of a felony.
 - ii. Staff may recommend the removal of a member for cause to the MetroPlan Orlando Board and applicable appointing authority.
3. Procedure for Removal. Removal of a member may be affected by majority vote of the MetroPlan Orlando Board.

Section 5. Officers, Term of Office

- A. The November/December meeting shall be known as the Annual Meeting of the Technical Committee and shall be for the purpose of electing new officers and conducting such other business as may come before the members. The Technical Committee shall elect from its membership the following officers:
 1. Chairperson

2. Vice-Chairperson

- B. Each officer shall be from a different jurisdiction/agency.
- C. Each elected officer shall serve for one (1) year or until that officer is re-elected or until that officer's successor is elected. The newly elected officers shall be declared installed following their election and shall assume the duties of office at the first meeting of the new calendar year.
- D. Neither the position of Chairperson or Vice-Chairperson shall be given individual votes. In order to cast a vote, they must do so as a representative of an agency listed in Section 4 A.
- E. In the absence of the Chairperson, the Vice-Chairperson shall assume the duties and responsibilities of the Chairperson. Should both officers be absent, the Technical Committee shall elect a temporary chairperson to chair the meeting. The Staff Liaison may call the meeting to order and proceed with the agenda until the Technical Committee elects a temporary chairperson.
- F. The Chairperson shall represent the Technical Committee as a non-voting advisor on the MetroPlan Orlando Board. In the absence of the Chairperson, the Vice-Chairperson is the designated alternate. In the absence of both Chairperson and Vice-Chairperson, the Staff Liaison may serve as the designated alternate at the discretion of the MetroPlan Orlando Executive Director.

Section 6. Rules of Procedure

- A. An annual meeting schedule will be adopted in November/December for the following year. The Chairperson of the Committee may waive a monthly meeting; however two consecutive meetings may not be waived. Business to have been conducted at the waived meeting shall be considered at the next successive monthly meeting. When necessary, the Chairperson may call special meetings to deal with immediate issues.
- B. Technical Committee members or their designated alternates must be present to cast a vote. A quorum shall consist of the majority of those appointed members entitled to vote, and any business transacted by the Technical Committee must be approved by not less than a majority of the votes cast. Business shall be transacted only at regular or called meetings and shall be duly recorded in the minutes thereof.
- C. Minutes shall be kept of the Technical Committee's proceedings and official actions, which shall be of public record.
- D. Voting shall be by voice, but a member shall have his or her vote recorded in the minutes if he or she so desires. A roll call vote shall be held upon request. All other questions or procedures shall be guided by Robert's Rules of Order, Revised.

- E. Meeting agendas shall include two public comment periods, one at the beginning of the meeting for action items and again at the end of the meeting for general comments. Public requests for Technical Committee action or recommendation shall be placed on the agenda as a scheduled business item.

Section 7. General Policies

- A. MetroPlan Orlando's Board and Committee structure consists of five (5) committees, including the Board;
 - 1. MetroPlan Orlando Board
 - 2. Community Advisory Committee
 - 3. Municipal Advisory Committee
 - 4. Technical Advisory Committee
 - 5. Transportation Systems Management & Operations Advisory Committee
- B. All Committees and studies shall follow the intent and further the Mission Statement adopted by the MetroPlan Orlando Board, which is as follows:

To provide leadership in transportation planning by engaging the public and fostering effective partnerships.
- C. All Committees shall maintain a broad perspective covering the range of all modes of transportation and associated facilities (including, but not limited to, roadways, bicycle and pedestrian facilities, safety, micromobility, and transit) in all recommended planning work programs so that proper study and evaluation of transportation needs shall result in a multi-modal transportation system plan, balanced with respect to area-wide needs and properly related to area-wide comprehensive plans, goals and objectives.
- D. Reports, studies, plans, programs and databases shall be approved or endorsed by the MetroPlan Orlando Board after review and recommendation by the Technical Committee and such other committees as may be interested or affected. A recommendation may be noted as officially adopted by the Technical Committee and placed into effect upon signature by the Technical Committee Chairman without waiting for the minutes of the previous meeting to be officially approved at the next Technical Committee meeting.
- E. Reports, studies, plans, programs or databases that have been approved or endorsed by the MPO are, by definition, public records and shall be available to the public for inspection and copying upon request. This may be limited however by the custodian of the records, to that time necessary to review the records and excise the information which is deemed to be exempt from the Public Records Act, as stipulated by Florida Law. A reasonable fee may be charged for copying costs.
- F. Reports, studies, plans, programs or databases that are working papers or draft documents and have therefore not been approved by the MetroPlan Orlando Board shall

also be released upon request as public records. The receiver of the information however shall be cautioned that it has not been formally approved and is therefore subject to change and may only be used at their own risk.

- G. The release of databases shall be reported to the Technical Committee at their next scheduled meeting.
- H. Databases, computer software or other information that has been access-limited through contractual agreement shall be protected from disclosure, as authorized by Florida Statutes.

Section 8. Procedures for Amending Adopted Studies, Plans, or Programs

- A. The procedures for amending the Orlando Urban Area Metropolitan Transportation Plan (MTP), the Transportation Improvement Program (TIP), and the Urban Boundary are established in the MetroPlan Orlando Board Rule 35I-1.009 which is incorporated by reference herein.
- B. The Technical Committee shall review the proposed change based on a technical evaluation of its merit and shall recommend approval or disapproval to the MetroPlan Orlando Board.
- C. The MetroPlan Orlando Board shall have final approval or disapproval disposition action of the requested change or changes.

Section 9. Ad hoc Subcommittees or Task Force

- A. Ad hoc subcommittees or task forces may be appointed by the Chairman to address specific issues or investigate and report on specific subject areas of interest to the Technical Committee.
- B. Designation of representatives to each of the subcommittees shall be made by Technical Committee members representing that jurisdiction or agency. In the case of multiple Technical Committee members, the designation of subcommittee representatives shall be made by caucus of the members. To be a designated subcommittee representative, it is not necessary to be a Technical Committee member.
- C. Each ad hoc subcommittee may appoint a chairman who will report the subcommittee's findings to the Technical Committee. In the absence of a chairman, a temporary chairman shall be appointed by the subcommittee in accordance with Robert's Rules of Order.
- D. Subcommittees or Task Forces may include, but not be limited to:
 - 1. Metropolitan Transportation Plan (MTP) Subcommittee
 - 2. Project Prioritization Subcommittee
 - 3. Nominating and Bylaws Review Subcommittee
 - 4. Air Quality

5. Freight and Goods Movement
6. Vision Zero / Safety

E. Each meeting shall be recorded and if requested, minutes of a meeting shall be provided.

Section 10. Bylaws Review and Amendment

- A. A bylaws review subcommittee shall review these bylaws at least every other year on odd numbered years or as may be deemed necessary. These bylaws can be amended at any regular meeting of the Technical Committee by voting members or appointed alternates (provided there is a quorum) if the proposed amendment has been submitted in writing to the Technical Committee members with the proper notification of the meeting.
- B. These Bylaws may be altered, amended, or added to by vote of the Technical Committee provided that:
 1. Notice of the proposed changes shall normally contain a full statement of the proposed amendments.
 2. The proposed amendment(s) is/are placed on the agenda for the next scheduled meeting following such presentation.
 3. The proposed written changes shall be forwarded to all Technical Committee members at least five (5) business days prior to the meeting at which a vote will be held.
 4. Technical Committee members may propose relevant changes from the floor to any proposed amendment under consideration on the agenda.
 5. The Technical Committee adopts the proposed amendment(s) by a majority vote of the members present at the Technical Committee meeting.
- C. MetroPlan Orlando staff may also initiate a review and recommendation of changes to these bylaws that may result from a review of the organization's internal operating procedures, and/or in coordination of implementation of the strategic plan.

TRANSPORTATION SYSTEMS MANAGEMENT AND OPERATIONS COMMITTEE BYLAWS

Section 1. Authority, Creation

In accordance with the 1962 Federal Aid Highway Act requiring that transportation planning be comprehensive, cooperative, and continuing in nature, a transportation systems management and operations committee known as the "Orlando Urbanized Area Transportation Systems Management and Operations Committee" is hereby created.

Section 2. Definitions

For the purpose of these Bylaws, the acronym "TSMO" shall mean the Orlando Urbanized Area Transportation Systems Management and Operations Committee.

For the purpose of these Bylaws, TSMO shall mean: an integrated program to optimize performance of infrastructure through implementation of systems, services, and projects to preserve capacity and improve the safety, security, enforcement, education, and reliability of a multimodal surface transportation system.

For the purpose these Bylaws, a TSMO program may include but not be limited to the following strategies: traffic signal retiming, transportation improvements, traffic incident management, traveler information, data management, and Intelligent Transportation Systems (ITS). Additionally, the following disciplines shall be included: traffic engineering, transportation planning, information technology, public safety, emergency management, fire and rescue and emergence of Automated, Connected, Electric and Shared Vehicles (ACES).

Section 3. Purpose

Transportation Systems Management and Operations specialists shall represent the various public governmental bodies, authorities, agencies, and safety-related organizations of the Orlando Urbanized Area and shall be involved in the process of integrating various strategies to optimize performance and safety of the region's surface transportation system by the establishment of a TSMO advisory committee. It shall be the function of the TSMO Committee to:

- A. Serve the MPO in an advisory capacity on TSMO matters relating to the update of the MPO's Congestion Management Process (CMP) of the MPO's Metropolitan Transportation Plan (MTP) and the coordination of TSMO with the regional ITS architecture.
- B. Be responsible for the review of all studies, reports, plans and/or programs germane to TSMO and to recommend action pertinent to the subject documents to MetroPlan Orlando.
- C. Develop priority recommendations to the MetroPlan Orlando Board and/or other agencies responsible for plan and program implementation based upon the needs as determined by TSMO studies and project applications.
- D. Advise staff in the development of an Annual Congestion Management System Report as called for in the Congestion Management Process (CMP) Element of the MPO's long range plan, and subsequently revise the CMP Element as needed to ensure that it functions efficiently and effectively.
- E. Annually review and revise the TSMO Prioritized Project List. This list will be the source of candidate projects to be implemented with the MPO's Congestion Management System (CMS) Box funds for the region and each County; for projects meeting state and federal eligibility, and any new funds identified at the local, state or federal level. In addition, the list can be a resource for local governments looking for traffic operations improvements to be implemented by developers as part of a Development Order.
- F. Develop and recommend a list of traffic operations and TSMO project priorities to be implemented with CMS Box funds and/or MetroPlan Orlando's share of District Five Allocated STP and State funds. Projects may include improvements including, but not limited to, studies, plans, installing or synchronizing traffic control devices, safety and/or evacuation efficiency improvements, adding or extending turn lanes at intersections, TSMO deployments, system maintenance projects, operations, Road Side Units (RSUs) such as sensors and projects that shift automobile congestion to other modes and change or reduce single occupant vehicle trip demand.
- G. When appropriate, review state Project Development and Environmental (PD&E) studies and design plans to ensure that adequate provisions for ITS, traffic operations and flow are included in the planning and design of new and reconstructed highways, and consistent with any specific committee recommendations that may have come out of the TSMO prioritized project list and consistent with the list of recommended TSMO projects. MetroPlan Orlando staff or any committee member may bring design plans to the committee for review at the discretion of the committee.
- H. Participate in updates to the regional ITS architecture; and coordinate with the MPO's other advisory committees.

Section 4. Membership, Appointments, Term of Office, Vacancies, Removal from Office

A. Membership

The intent of the membership composition of the TSMO Committee is to represent planning and engineering expertise from Federal, State, regional or local agencies.

1. The following jurisdictions are eligible to appoint voting members as indicated. Appointees should have an interest or active involvement in TSMO related activities:

- (a) Orange County (2)
- (b) Osceola County (2)
- (c) Seminole County (2)
- (d) City of Orlando (2)
- (e) City of Belle Isle (1)
- (f) City of Kissimmee (1)
- (g) City of Sanford (1)
- (h) City of Altamonte Springs (1)
- (i) City of Apopka (1)
- (j) City of Casselberry (1)
- (k) City of Lake Mary (1)
- (l) City of Longwood (1)
- (m) City of Maitland (1)
- (n) City of Oakland (1)
- (o) City of Ocoee (1)
- (p) City of Oviedo (1)
- (q) City of St. Cloud (1)
- (r) City of Winter Garden (1)
- (s) City of Winter Park (1)
- (t) City of Winter Springs (1)

2. Municipalities whose population is less than 5,000 may each appoint one (1) non-voting member. These municipalities would include:

- (a) Town of Eatonville
- (b) City of Edgewood
- (c) Town of Windermere

3. The following transportation agencies/authorities are also eligible for voting representation. Each agency may appoint one (1) voting representative:

- (a) Central Florida Regional Transportation Authority/LYNX
- (b) Central Florida Expressway Authority
- (c) Central Florida Tourism Oversight District
- (d) Greater Orlando Aviation Authority
- (e) Kissimmee Gateway Airport

- (f) Orlando Sanford Airport
- (g) MetroPlan Orlando appointee, such as a community advocate that is not serving on a MetroPlan Orlando Advisory Committee.

4. In addition, representatives from the following shall serve as non-voting advisors or members:

- a. Florida Department of Transportation, District Five, non-voting advisor
- b. Florida's Turnpike Enterprise, non-voting advisor
- c. University of Central Florida, non-voting member
- d. Orange County Community Traffic Safety Team (Chair or designee), non-voting member
- e. Seminole County Community Traffic Safety Team (Chair or designee), non-voting member
- f. Osceola County Community Traffic Safety Team (Chair or designee), non-voting member

B. Appointments

- 1. Each eligible jurisdiction and agency shall appoint voting members and one designated alternate from each of the membership agencies listed in Section 4 A for which it is eligible. Voting members and their designated alternates must be employees of the jurisdiction or agency represented. These appointments shall be made in writing by the County Commission Chair/Mayor, City Mayor, County Administrator, City Administrator or Manager, or the Executive Director of other agencies. The failure of an agency to appoint a primary representative will result in that agency losing its voting authority on the TSMO Committee until such time as the vacancy is filled.
- 2. The appointed representatives, both primary and alternates, shall be selected from the agency membership listing under Section 4 A.
- 3. In the absence of the primary member, the alternate member shall have the same privileges as the primary member and may serve on a subcommittee or task force.

C. Term of Office

The term of office for a TSMO Committee member shall be for an indefinite period, or until reappointment, or until the appointment of a successor. Separation from employment of the jurisdiction or agency represented constitutes the end of an appointment. The MetroPlan Orlando appointee may serve four (4) years or until reappointed or until the appointment of a successor.

D. Vacancies and Membership Revisions

Any vacancies in membership shall be filled in the same manner as the initial appointment.

E. Removal from Office

1. Members serve in an advisory capacity, as volunteers, without compensation, and at the pleasure of the MetroPlan Orlando Board and the applicable appointing authority.

2. Grounds for Removal

a. Removal for excessive absenteeism

- i. Each member is expected to demonstrate interest in the committee's activities through the member's or a designated alternate's participation in the scheduled meetings.
- ii. If a member has three (3) consecutive absences from the meetings or has missed a majority of meetings during the year, the supporting MetroPlan Orlando staff person shall notify the appointing authority and said member in writing in an effort to ensure full participation in the committee.
- iii. Staff may recommend removal of members with excessive absences to the MetroPlan Orlando Board and appointing authority.

b. Removal for cause:

- i. A member may be removed for cause for:
 - a) Any conduct by a member, which in the opinion of MetroPlan Orlando, is inappropriate or unsuitable and which has a tendency to adversely affect, lower, or destroy the respect or confidence of MetroPlan Orlando in the ability of the member to perform his or her duties as a member of the committee, or conduct which brings disrepute or discredit to the committee or to MetroPlan Orlando;
 - b) Violation of any provision of an applicable statute, county, or city code of ethics governing the conduct of officials;
 - c) Malfeasance, misfeasance, neglect of duty, or inability to perform his or her official duties; or
 - d) Conviction of a felony.

ii. Staff may recommend the removal of a member for cause to the MetroPlan Orlando Board and applicable appointing authority.

3. Procedure for Removal. Removal of a member may be effected by majority vote of the MetroPlan Orlando Board.

Section 5. Officers, Term of Office

- A. The November/December meeting shall be known as the Annual Meeting of the TSMO Committee and shall be for the purpose of electing new officers and conducting such other business as may come before the members. The TSMO Committee shall elect from its membership the following officers:
 - 1. Chairperson
 - 2. Vice-Chairperson
- B. Each officer shall be from a different jurisdiction or agency.
- C. Each elected officer shall serve for one (1) year or until that officer is re-elected or until a successor is elected. The newly elected officers shall be declared installed following their election and shall assume the duties of office at the first meeting of the new calendar year.
- D. Neither the position of Chairperson or Vice-Chairperson shall be given individual votes. In order for either the Chairperson or vice-Chairperson to cast a vote, they must do so as a representative of an agency listed in Section 4 A.
- E. In the absence of the Chairperson, the Vice-Chairperson shall assume the duties and responsibilities of the Chairperson. Should both Chairperson and Vice-Chairperson be absent, the TSMO Committee shall elect a temporary Chairperson to chair the meeting.
- F. The Chairperson shall represent the TSMO as a non-voting advisor on the MetroPlan Orlando Board. In the absence of the Chairperson, the Vice-Chairperson is the designated alternate.

Section 6. Rules of Procedure

- A. An annual meeting schedule will be adopted in November/December for the following year. The Chairperson of the Committee may waive a monthly meeting, however two consecutive meetings may not be waived. Business to have been conducted at the waived meeting shall be considered at the next successive monthly meeting. When necessary, the Chairperson may call special meetings to deal with immediate issues.
- B. TSMO Committee members or their designated alternates must be present to cast a vote. A quorum shall consist of the majority of those appointed members entitled to vote, and any business transacted by the TSMO Committee must be approved by not less than a majority of the votes cast. Business shall be transacted only at regular or called meetings and shall be duly recorded in the minutes thereof.
- C. Minutes shall be kept of the TSMO Committee's proceedings and official actions, which shall be public record.
- D. Voting shall be by voice, but a member shall have his or her vote recorded in the minutes if he or she so desires. A roll call vote shall be held upon request and whenever an opposing vote is recorded. All other questions or procedures shall be guided by Robert's Rules of Order, Revised.
- E. Meeting agendas shall include two Public Comment periods, one at the beginning of the meeting for action items and again at the conclusion of the scheduled business items which shall be for discussion purposes only. Public requests for TSMO Committee action or recommendation shall be placed on the agenda as a scheduled business item.

Bottom Line Up Front (BLUF): The MetroPlan Orlando MPO represents a "Low Risk" on its 2025 Joint Certification. The results were presented to MPO staff on February 11, 2026. There are no corrective actions at this time.

Background: Each year, the District and the Metropolitan Planning Organization (MPO) must jointly certify the metropolitan transportation planning process as described in 23 C.F.R. § 450.336. The joint certification process begins in January, allowing time to incorporate any recommended changes into the Draft Unified Planning Work Program (UPWP). The District and the MPO prepare a joint certification package that includes a summary of noteworthy achievements by the MPO and, if applicable, a list of recommendations and/or corrective actions. The joint certification package must be submitted to the Central Office, Office of Policy Planning (OPP), no later than June 1.

Process: The certification process is divided into two parts. Part 1 is completed by the MPO and covers plans, policies, data collection, and cooperative efforts with neighboring MPOs/TPOs and consultants. The MPO/TPO is also given the opportunity to list noteworthy practices and achievements, as well as provide comments.

Part 2 is completed by the District and consists of an evaluation focused on invoices, procurement, and planning documents. If any items or processes do not meet statutory requirements, the District may issue recommendations or corrective actions to the MPO. The higher the MPO's risk level, the more frequently its processes are monitored.

The MPO Director and the Director of Transportation Development will sign parts 1 and 2, completing the annual certification.

A: Regarding professional development, rather than additional technical training for MPO staff, we believe there would be significant value in offering targeted training for our local agency partners focused on the Local Agency Program (LAP) requirements and certification process. We frequently receive questions related to LAP procedures, documentation, and compliance, and a workshop or coordinated informational session would help improve understanding, consistency, and overall project delivery.

2. What challenges does the T/MPO anticipate during the next UPWP cycle, and what specific assistance or support from FDOT would help address those challenges?

A: With respect to the upcoming UPWP cycle, we have not identified any specific assistance needs at this time. Continued coordination, clear communication, and ongoing collaboration with FDOT remain the most important factors in supporting a successful and efficient regional planning, project development, and implementation process.

Apr - Jun	2025	Successful Transportation Improvement Program public participation - Public participation opportunities were expanded to include a multitude of new, personalized engagement opportunities. This included hosting four Ask a Planner About the TIP sessions, which served as open forums for members of the public to learn about the TIP and ask questions directly to staff members. Three of these sessions were hosted virtually and the fourth was hosted in-person. Members of the public were also encouraged to participate, either in-person or virtually, through the MetroPlan Orlando Advisory Committee and Board meetings, view and comment upon projects in the Online TIP Viewer, and/or view a more traditional presentation of the TIP in an online video. 17 people participated in the live TIP events, and the published materials reached a total of 275 people between participants at the live events and post-event views of published TIP videos.
Jan - Dec	2025	Continued improving public access to the transportation planning process - The public has permanent access to view MetroPlan Orlando Board and committee meetings virtually and provide live comments from the comfort of their homes. Meetings are also posted to our YouTube channel. In 2025, we posted a total of 112 videos to MetroPlan Orlando’s YouTube channel, including 102 meeting recordings and 10 educational videos. These videos have about 9,150 views and a watch time of about 625 hours. This represented about a 22% increase from 2024 in video views, due in part to the popular Vision Zero Safety Speaker Series videos and the MTP Technical Workshops.
Jan - Dec	2025	New communication materials featuring plain language and engaging visuals - New communication tools in 2025 included: 1) A "trans-created" kids safety book in Spanish, which went beyond simple translation to create word puzzles, text and activities that were language for Spanish-speaking audiences; 2) We installed software on our website to comply with upcoming federal standards for disabled users, and also included features that help a variety of users see and use the site more comfortably; 3) We used short-form video as a go-to to promote webinars and public meetings, allowing our staff members to give informal previews of the material they planned to present and discuss; 4) We dabbled with the idea of social media influencers by creating the 2050 Plan Fan Club, a group of community leaders in all sectors who received a branded fan with a request to post about the 2050 Plan. Response was good and got notice for the plan adoption.
Jan - Dec	2025	Increased youth outreach efforts - Our Path to 2050 book, which focused on the 2050 MTP and provided activities for elementary-aged kids was a big hit. We distributed most of the 5,000 printed copies at events and through schools. We interacted with students of all ages – from preschool to high school in classroom presentations at school STEAM fairs, as well as other events, including the annual Aviation Day the Sanford Airport. We engaged the pre-teens and teens with safety quizzes and street design activities. Staff also provided several presentations to college classes on planning, public policy, and environmental effects of transportation.
Oct	2025	Raise awareness of safety for visually impaired people - MetroPlan Orlando took the lead in presenting the 2025 Blind Experience event, which attracted more than 75 participants (almost double last year's attendance). The event involved elected officials, law enforcement, government partners, and people with vision disabilities. We had several information tables to engage participants, as well as speakers and musical entertainment. The street-crossing exercise used both the traditional blindfold and low-vision goggles to simulate different levels of vision impairment. Staff prepared a highlights video for use on social media and in board and committee meetings to help center the needs of the visually impaired. The video received 54 views on our YouTube channel. The event also was covered by Orange County's government access channel.
Jan - Dec	2025	Offer targeted outreach to older adults - MetroPlan Orlando participated two programs with the Orange County Office on Aging to provide information on the 2050 Plan to older adults. A staff member also made a presentation to a Seminole County older adults’ group. We continued our connections with the AARP and Safe Mobility for Life programs and shared their materials at some of our tabling events. A staff member also has regularly attended the City of Orlando's Commission on Livability and Healthy Aging.

Jan - Dec	2025	Multi-Pronged Public Engagement Approach Offered for the Transportation Disadvantaged Local Coordinating Board (TDLCB) Annual Public Meeting - MetroPlan Orlando serves as the Designated Official Planning Agency (DOPA) for the Joint Orange, Osceola, Seminole Transportation Disadvantaged Local Coordinating Board (TDLCB). As such, MetroPlan Orlando is required to hold an annual public meeting for the purpose of receiving input on unmet needs and other issues related to local paratransit services. Members of the public were given multiple opportunities to address the board, before and during the meeting, ensuring feedback could be shared in ways that worked best for riders in order to remove participation barriers. The meeting was widely advertised to reach TD paratransit riders and the general public through multiple channels which included legal notices published in the Orlando Sentinel and La Prensa newspapers. Direct emails were sent to ACCESS LYNX TD riders with active email addresses on file with LYNX. Public meeting notices were posted on MetroPlan Orlando’s website, LYNX’s website, and social media platforms. Fliers were also posted onboard every ACCESS LYNX vehicle announcing the date, time, and location of the meeting and meeting information was also added to the ACCESS LYNX call-hold recording which is heard while riders wait to make or change reservations. The 2025 meeting was held at MetroPlan Orlando’s offices, providing a familiar, accessible setting that easily accommodated ACCESS LYNX vehicles. Participants unable to attend in person could submit comments in advance by email or voice message left on a dedicated phone line. Those who attended the meeting were able to do so in person or virtually via Zoom. This reflected strong engagement across formats. Written and voicemail comments that were left by Spanish speaking commenters were translated to English for the benefit of the board members. Additionally, a Spanish-speaking staff member was available in person to translate or those with limited English proficiency.
Jan - Dec	2025	Using big data to support local governments - We’ve provided big data resources and analysis to support a wide variety of projects in our region, including: annual signal retiming; regionwide travel time reliability, long-range transit planning, speed management and traffic studies, traffic calming , cut-through traffic patterns analysis, origin-destination (OD) data for long-range travel patterns and traffic forecasting, origin-destination (OD) data for bicycle and pedestrian safety studies, and safety studies.
Jan - Dec	2025	Emphasized safety and vulnerable road users in planning process – Continued use of performance-based planning and prioritization process to include board preference weighting for safety and emphasis on vulnerable road users, including adopting a Prioritized Project List with safety and vulnerable roadway user emphasis. Established Vulnerable Road Users Safety Working Group has been elevated to serve a regional Vision Zero Task Force with broaden participation. This group meets regularly to review and provide guidance on MetroPlan safety planning efforts. Another practice continued by MetroPlan Orlando staff this year are data-driven “safety moments” during our advisory committee and board meetings.
Jan - Dec	2025	Using our regional MPO resources to advance cross-jurisdictional planning projects - In 2025, MetroPlan Orlando staff continued to serve on a variety of Project Advisory Groups, Agency/Stakeholder Meetings, and other similar Advisory Groups to aid in the development of transportation projects that support local, regional and statewide travel needs. MetroPlan Orlando is continuing to build off the work outlined in the Health Strategic Plan (2022) to incorporate health and sustainability into our plans, programs, and processes. HSP served as a foundation to community health section of the adopted 2050 MTP.

Jan - Dec	2025	Collecting bicycle and pedestrian counts and behaviors - MetroPlan Orlando continued collecting pedestrian and bicyclist counts along streets, highways and shared use paths using a video camera system that uses artificial intelligence to count non-motorists, differentiating bicyclists from pedestrians, and determining their lateral position along streets, and direction. This data helps us more accurately assess the safety performance and mode shift performance of our pedestrian- and bicyclist-related improvements.
Jan - Dec	2025	The adopted 2050 MTP encompasses both the breadth and depth of transportation needs throughout the region and identifies strategies to enhance how transportation influences community health and housing, environmental stewardship and resilience, technology, and safety. The 2050 MTP Public Participation Plan created opportunities for more than 13,000 Central Floridians to be informed and engaged throughout the process. Public input was collected through a mix of public, stakeholder, and board engagement activities. Feedback from local stakeholders was collected through interviews, technical workshops, and the MTP Summit. Public engagement opportunities included the 2050 MTP Community Survey and a series of webinars, as well as over 40 outreach events and meetings at schools, community organization meetings, resource fairs, festivals, and more. Online materials helped the public take advantage of information presented at the MTP Public Meeting in September – even if they couldn't attend in person. Outreach has been ongoing since the MTP was adopted to help people find and understand what it provides.
Jan - Dec	2025	Annual Traffic Signal Retiming and Before/After Studies – MetroPlan Orlando completed the FY 2023-2024 Before and After retiming evaluation of 20 corridors and four (4) intersections in September 2025. Key activities and findings include overall benefit cost ratio of negative 0.4; 80 percent of corridors have an improvement in travel time reliability; 50 percent of corridors now have shorter travel times; six (6) percent of intersections had less pedestrian delay during the peak-period; and 25 percent of individual intersection had less intersection delay during the peak-period.
June	2025	Regional TSMO Strategic Plan - .The Regional TSMO Program is a partnership between ten (10) M/TPOs in Central Florida for the purpose of facilitating cooperation and coordination of TSMO. MetroPlan Orlando serves as the lead agency for the Program. Highlights in the Program for 2025 include: four (4) RTSMOP Directs' Meetings; establishment of a Governance Committee; completion of the Strategic Plan in March that is focused on the value of establishing a formal organizational platform for regional TSMO planning collaboration; a draft Scope of Work for completing the RTSMOP Implementation Action Plan and commitment on cost-sharing to complete the Plan; execution of a new Memorandum of Understanding (MOU) between the agencies; and pending draft language for the UPWP task for agency staff activities and transfer of funds from the M/TPOs to MetroPlan Orlando to support the work of RTSMOP.
Jan - Dec	2025	Improved Online Maps and Dashboards – Tracking the Trends is an ongoing and evolving program designed to feature transportation data and trends. This program tracks over 100 statistics aligned with and exceeding the focus areas laid out in the MTP. The program has been streamlined to make data more accessible and digestible to the public as well as MetroPlan Orlando's partners. This streamlined Tracking the Trends site has been created to feature Transportation Trend Highlights, using Esri StoryMaps. Part of this program includes historic and longform data stored in the Data Library, an online data clearinghouse which is available to the public. The data is updated on a rolling cycle as new information is made available from a variety of verified sources at the state, local, and federal level. Esri StoryMaps are also utilized in the Accessibility Hub, a site that shows accessibility around the region to dozens of destination types and points of interest. Lastly, the System Performance Report dashboard is a singular resource for all federally mandated performance measures, making those metrics clear to the public as well as government administrative partners at every level. This Dashboard was updated and aligned with the MTP development process, as a System Performance Report Appendix is included in that document as well.

**Excerpt from Internal Operating Procedures Approved by the MetroPlan
Orlando Board at the September 13, 2023, Meeting**

V. Board Officers, Board Officer Elections, Election Process, and Board Officer Vacancies

(1) Board Officers and Officer Duties

- (a) The officers of the MetroPlan Orlando Board are the Chairperson, Vice-Chairperson, and Secretary-Treasurer. Each MetroPlan Orlando Board officer shall be from a different local government and shall serve for one (1) year or until he/she is reelected or until his/her successor is elected.
- (b) The Chairperson shall preside at all MetroPlan Orlando Board meetings, appoint all board committee members, and shall sign, on behalf of the MPO, all board meeting minutes, resolutions, agreements, and other documents approved by action of the MetroPlan Orlando Board. The Chairperson shall have the authority to call special meetings of the MetroPlan Orlando Board and Board Committees, and/or may cancel any regularly scheduled meeting. The Chairperson shall also preside over the board officer election process.
- (c) The Vice-Chairperson shall assume the duties and responsibilities of the Chairperson in his/her absence, including having signatory authority where applicable.
- (d) The Secretary-Treasurer shall be responsible for ensuring the minutes and records of MetroPlan Orlando are kept in proper order and shall assume the duties and responsibilities of the Chairperson in the absence of both, the Chairperson and Vice-Chairperson.
- (e) In the absence of all three board officers, the Immediate-Past Chairperson may preside over the meeting where a quorum is established. A temporary chairperson may also be elected by majority vote at said meeting to serve as Chairperson for the purpose of conducting the business of the MetroPlan Orlando Board.

(2) Board Officer Elections

- (1) The last scheduled meeting of each calendar year shall be known as the Annual Meeting of MetroPlan Orlando and shall be for the purpose of electing new board officers and conducting such other business as may come before the members. MetroPlan Orlando shall elect from its voting membership a Chairperson, Vice-Chairperson and Secretary-Treasurer.
- (2) Each officer shall be from a different local government or transportation agency.
- (3) Each member so elected shall serve for one (1) year or until he/she is reelected or until his/her successor is elected. The Chairperson, Vice Chairperson and Secretary-Treasurer's terms of office shall be limited to two (2) consecutive one (1) year terms and neither shall be eligible again until two (2) additional years have elapsed, nor shall either be succeeded by a member from the same local government or agency for his/her respective office.
- (4) The Chairperson of the MetroPlan Orlando Board shall preside over and facilitate the election of officers for the ensuing year.
- (5) The newly elected officers shall be declared installed and shall assume the duties of office upon adjournment of the meeting where the board officer elections are held, or as designated by the board.

(3) Election Process

The election of board officers shall take place in the following order:

- The nomination process shall begin with the current Chairperson accepting nominations for the office of incoming Chairperson.
- When nominations are complete, the Chairperson shall accept a motion to close the nominations.
- Should only one person be nominated, that nominee shall be declared elected to the office by acclamation.
- When more than one person is nominated, a roll call vote shall be conducted by the Agency Clerk.
- If a candidate receives the majority of voice votes, he or she shall be declared elected to the office.

- Upon completion of the election of the incoming Chairperson, the election of Vice-Chairperson, followed by the election of Secretary-Treasurer, shall take place in the same manner described above.

(4) Board Officer Vacancies

If the Chairperson is unable to complete his/her term, the Vice-Chairperson shall serve as Chairperson until the next regular election. Vice-Chairperson or Secretary-Treasurer vacancies shall be filled by majority vote of the MetroPlan Orlando Board for the term balance remaining for said office. Officers elected to fill a term balance must be from the same jurisdiction as the previous office holder.

'MAKE GOOD CHOICES'

If you read that with an eye roll or emoted some version of "huh," you have something in common with my 16-year-old daughter. For the past seven months, I have incorporated the phrase "Make good choices" into my communication habits with her, just like "I love you" and "Be safe." Seven months ago, my daughter became a fully licensed driver. After a year of anxiety-filled practice driving along State Road 40 and U.S. 17 (both roads necessary to travel to school), she left on her first solo drive. For my overly cautious and hesitant child, this was a huge deal. Ten days later, her friend and classmate lost her life in a head-on collision close to our home.

My daughter and many of her friends, who were just getting their licenses, were not just devastated by the loss of their friend; they were now scared to drive. As details emerged, we discussed, without shame or judgment, that certain choices had contributed to the crash and its outcome. I watched them regain some of their confidence and even a sense of empowerment. I reminded them to "make good choices."

But you never know if or how it will be put into action. Just a few weeks later, my daughter was taking me to work before class. We were on U.S. 17, it was dark, and a vehicle was hurtling toward us in our lane at an extremely high speed, with no sign of slowing. I was amazed by her ability to remain calm and adjust her speed and path to avoid a crash. She made good choices when someone else didn't.



May we all get home safely, and may we all "make good choices."

Steering Committee Holds Fourth Meeting in Casselberry

On Jan. 9, the Central Florida Safety Strategic Plan (CFSSP) Steering Committee met for the fourth time. The meeting was held at the Casselberry Arts Center.



Kelly Brock, with the City of Casselberry, presented at the January Steering Committee meeting about Casselberry's safety projects and safety results.

The Steering Committee was formed in 2024 to help monitor and advance the CFSSP. The committee consists of 16 members who represent Central Florida's five Metropolitan Planning/Transportation Planning Organizations, as well as the communities and counties across Central Florida. The committee is tasked with advancing and implementing the 21 action steps identified in the CFSSP.

At the meeting, District 5's Secretary John E. Tyler and Safety Administrator Loreen Bobo welcomed everyone and discussed the importance of the work the committee is undertaking as the region strives to "get to zero." Loreen shared end-of-year data showing a significant reduction in Central Florida transportation-related fatalities in 2024 and 2025 compared to previous years.

As part of the meeting, City of Casselberry Public Works Director Kelly Brock presented a series of safety projects and street transformations that were implemented in Casselberry in recent years. Kelly detailed the before-and-after results and explained how Casselberry is striving to become the most walkable, rollable, and bikeable city in Central Florida. Committee members noted how Casselberry has been a regional leader and champion for creating safer streets for all users.

Loreen then presented on the Central Florida Teams (Targeted Enforcement and Awareness Messaging for Safety Program) Program, which will enable Central Florida law enforcement agencies to accrue points to receive safety equipment that advances Target Zero goals. The program will be initiated shortly and was discussed further at the 2nd annual District 5 Community Traffic Safety Teams (CTST) Safety Summit.

The committee then focused on the work that individual focus group teams are advancing. Chris Coleman of STV presented the draft Getting to Zero Checklist, which was co-developed with Adriana Rodriguez of MetroPlan Orlando. This tool was developed to identify safety issues and assist in future project scoping. Lara

Bouck of MetroPlan Orlando and Christy Lofye of Ardurra presented on the merits of existing and emerging speed data collection tools currently in use and under exploration across Central Florida. The teams will continue to finalize their work and will post their findings on the Office of Safety's website soon.

The Steering Committee concluded the meeting with a Walk and Talk led by Jenna Mousseau of Bike/Walk Central Florida (BWCF), Marie Hernandez and Jerome Williams of AARP, and Dan Gallagher of Burgess & Niple.

The next CFSSP meeting is scheduled for April 2026, and the 3rd Annual Central Florida Safety Summit is scheduled for May 8 in St. Cloud.

Committee Members Participate in Walk and Talk Tour

As part of the Central Florida Safety Strategic Plan (CFSSP) Steering Committee's January meeting, members participated in a facilitated Walk and Talk led by Bike/Walk Central Florida (BWCF), AARP, and Burgess & Niple. The Walk and Talk was 0.25 miles and consisted of six stops.

At each stop, committee members had to view the street through the eyes of a persona they were assigned. The personas included a pedestrian, a motorist, a bicyclist, an e-scooter rider, a transit user, a 12-year-old, an 80-year-old, and a parent with a toddler.

Participants were asked to share observations regarding the comfort and safety level of their assigned persona.

The exercise yielded a wide range of observations, robust conversations, and a deeper understanding of the challenges residents face as they navigate the streets of Central Florida. Participants noted that a variety of street design features, vehicle speed, weather, and noise from passing vehicles shaped their comfort during the Walk and Talk.

Check Your Bike Before You Ride

March is Florida Bicycle Month.. Time to dust off the bike, get out, and ride. But it may need more than just dusting off after a short hibernation. Actually, your bike may need a little attention even if you rode it yesterday. Take a little time before each ride to make sure your bike and other equipment are ready for the road.

A pre-ride check may be called an ABC Quick Check or an M-Check (depending on the location of the parts checked), but the point is to check the parts most likely to cause trouble quickly. Let's walk through the ABC Quick Check.

'A' is for Air – Check your tire pressure and make sure it's set within the recommended range. Also, make sure there are no bare patches, weird bulges, cracks, or embedded debris. Pro tip: Remember that the max PSI (pounds per square inch) rating on the tire may not be the best for you and your riding habits. Do some research or experimentation to determine what is best for you.

'B' is for Brakes – If your bike uses coaster brakes, make sure they will stop the bicycle. Brake levers should stop short of reaching the handlebars. The brake pads should be clean, straight, and evenly contact the rims. This is also a good time to make sure your wheels are true, round, and not wobbly.

'C' is for Chain (and cranks, and cogs) – Your chain shouldn't be rusty. It should move freely and be lightly oiled. Grab your pedals and try to wiggle your crank arms; there shouldn't be any wiggle. Make sure the gears are free of debris or goopy oil buildup. Make sure the derailleurs (shifting mechanisms) let you shift gears smoothly.

'Quick' is for Quick Release – If your bike has quick-release levers on the wheels or seat post, make sure they are closed securely.

'Check' is for Check It All Over – Lightly bounce your bike on the front and back wheels. Listen for loose or broken parts. Get them fixed before you hit the road. Check that your handlebars are straight and snug.

It's also important to inspect your e-bike and battery before heading down the street or hitting a bike trail. Taking those few extra minutes can help prevent unfortunate surprises and keep your ride safe and enjoyable.

E-bike riders: Turn on your display and check the battery level. You don't need the battery to ride your e-bike, but you probably don't want to run out of juice unexpectedly. Also, make sure there are no signs of damage to your battery.



OTHER NOTES FOR E-BIKE RIDERS

- Use the charger that comes with your e-bike. Batteries vary in type and specifications. Using the wrong charger can prevent proper charging or even cause a fire hazard.
- Avoid extreme temperatures. It is hot here in Florida during the summertime. Storing your batteries in a shed in the backyard can damage them. Check your batteries' manual; typically, batteries like indoor, air-conditioned environments.
- Check your battery for dents, cracks, bulges, or corrosion each time you ride. If you see any of these, don't use the battery.
- If your battery is damaged or won't charge, replace it. You don't want a faulty battery ruining a great day out riding.

Safety Equipment

Your bike is ready. To help you stay safe and better enjoy the ride, you should consider the following when selecting your safety equipment.

Helmet – If, for some reason, you fall off the bike, you want to protect yourself against head and facial injuries. A helmet is the way to go. Get yourself a comfortable helmet, fit it properly, and wear it every time you ride your bike. It's a good idea for everyone and is required for anyone under 16 years of age.

Bike Bell or Horn – Saying "On your left!" is the method most bicyclists use to alert others that they are going to pass. A bicycle bell, however, is a distinctive sound that most people immediately recognize as a notice that a bicycle is approaching.

Water Bottles – Most bikes either have water bottle holders or you can mount one. Take water with you when you ride. You do not want to dehydrate.

Sunglasses – Protect your eyes by wearing sunglasses. They shield your eyes from UV rays and prevent road debris from entering your eyes.

Appropriate Clothing – Bright colors help motorists see you. At night, consider a retroreflective vest. Also, dress for the weather and avoid baggy clothing or lengthy shoelaces, as they can get caught in chains or on gears.

Lighting – If you are going to ride between sunset and sunrise, you must have a white front light, a red rear light, and a red rear reflector on your bicycle. Get the best lights you can. Many new, bright lights are inexpensive and use rechargeable USB batteries. Additional reflectors or retroreflective tape on your bike can make you even more visible.

Gloves – Gloves reduce vibrations that affect hands, wrists, arms, and shoulders, making longer rides more comfortable. And should you fall, they can keep you from getting some nasty scrapes on your palms.


Tool Kit – If a minor bike malfunction occurs while you are riding, you don't want it to ruin your ride. Consider getting a bag and placing it under your seat or mounting it on your frame. Use it to carry a spare tube, tire levers, and some simple tools (or a bike multitool). Small air pumps can be mounted directly under your water bottle holders. A few tools can mean the difference between a disaster and a minor inconvenience.

Headsets – Headsets are a big NO. To ride safely, you need to be aware of your surroundings. This includes being able to hear traffic. Florida statute prohibits wearing headphones or any other listening device, except a hearing aid, while riding a bicycle. A headset that only provides sound through one ear can be used if it allows surrounding sounds to be heard with the other ear.

Your Most Important Piece of Equipment

You are your most important piece of safety equipment. By practicing safe bicycling behavior, you can make each ride safe and enjoyable. Prepare for your ride, be visible, be aware of your surroundings, and give yourself time to exercise sound judgment. Know and follow traffic laws.

Consider taking a Cycling Savvy or Effective Cycling class to increase your knowledge and improve your skills riding on trails and in traffic.



Florida Bicycle Month: Riding Safely Across the Sunshine State

Riding around town can be a joyful experience for the whole family. Whether you're rolling over gravel, sand, asphalt, or grass, simple safety habits can make every ride smoother and safer.



Florida's landscape is full of diverse terrains, busy roads, and vibrant communities. One thing stays constant across the state: motorists and cyclists must share the road. Riders should always follow traffic laws, wear proper safety gear, and stay alert. And remember, being on a bike doesn't exempt anyone from safe driving behavior. Avoid riding under the influence, and keep phones tucked away to prevent distraction.

As daylight fades, visibility becomes critical. Turn on your bike lights as soon as the sun begins to set and keep them on until after sunrise. Bright clothing and reflectors help drivers see you sooner.

Helmets are required for riders 16 and under, but they're a smart choice for everyone. Use hand signals when turning, ride in the lane when appropriate, and avoid riding more than two side by side. Sidewalks can be a safer alternative in some areas, but cyclists must always yield to pedestrians.

Drivers play a key role in keeping cyclists safe, too. Give at least three feet of space when passing, check mirrors and bike lanes before turning, and always look for cyclists before opening your car door.

BICYCLE SAFETY TIPS

- Always wear a properly-fitted helmet when you ride.
- Be visible. Position yourself in the lane so others can see you.
- Ride in the same direction of traffic on the street.
- Always use a headlight and taillight at night.
- Obey all traffic signs, signals and lane markings.

Move Over Month Spotlights Roadside Safety

The new year kicked off with January’s Move Over Month, serving as a staunch reminder that 198 people, including 36 responders, are killed on average each year in crashes involving first responders. And in Florida, drivers are required to “Move Over or Get Pulled Over.”

Florida Highway Patrol (FHP) Col. Gary Howze urged in January for “every driver to slow down and ‘Move Over’ when approaching flashing lights.”



“It’s not just the law,” Howze said. “Moving over is common sense, common courtesy, and a simple action that can prevent a 100% preventable tragedy.”

Whether it is law enforcement, emergency responders, tow trucks, or utility vehicles—slow down and move over. Your decision can be the difference between life and death.”

Lt. Tara Crescenzi, FHP spokesperson for Troop D in Orlando, said in a recent social media post that “no matter what type of vehicle is on the side of the road, always move over when it’s safe to do so.”

She noted that drivers in Florida must move over for disabled cars, emergency vehicles, Road Rangers, police, utility workers, tow trucks, and sanitation vehicles, as well as for construction and maintenance vehicles.

“Give space to those on the side of the road or slow down 20 miles under the posted speed limit,” Lt. Crescenzi stated.

“Not only is it the right thing to do . . . but it is also the law.”

It has been a year since the Move Over law was updated. As of Jan. 1, 2025, Florida’s Move Over law has been expanded to include parked vehicles on the roadside with hazard lights flashing,



As soon as it is safe to do so, vacate the lane closest to the stopped vehicle. This must be done for all disabled, law enforcement, emergency, sanitation, and utility service vehicles, including tow trucks, maintenance, and construction vehicles, while they are displaying warning lights.

emergency flares, or visible emergency signage. Disabled vehicles, including those with a flat tire, are protected under the law.

When drivers fail to move over for stopped or disabled vehicles, they put the safety of law enforcement, first responders, and other motorists in grave danger.

Giving those on the side of the road adequate space can significantly increase safety on Florida’s roadways. In 2024, there were 205 crashes, and more than 17,500 citations were issued to motorists who failed to move over in Florida.

“The safety of everyone on Florida’s roads matters, and by staying alert and avoiding distractions, you make the roads safer for other drivers and those responding to emergencies,” said FDOT Secretary Jared W. Perdue.


SLOW DOWN

If moving over cannot be safely accomplished, or when driving on a two-lane road, slow down to a speed that is 20 mph less than the posted speed limit when the posted speed limit is 25 mph or greater. The law states that drivers must travel at 5 mph when the posted speed limit is 20 mph or less on a two-lane road.



New Safety Measures Headed to High-Crash Intersection

As part of continued efforts to make travel safer for everyone in Central Florida, the STRIDES 2 ZERO initiative selected the intersection of State Road 435 (Kirkman Road) and County Road 526 (Old Winter Garden Road) in Orlando as a priority location for safety improvements. With a crash rate of 2.082 crashes per 1 million vehicles, the intersection was selected for targeted enhancements to reduce vehicle collisions and improve overall safety.

Following a comprehensive traffic safety study, engineers recommended replacing the existing diagonal-span traffic signals with a box-span

configuration to improve signal visibility, particularly during high-traffic periods and in complex driving conditions. The signal improvement alone is projected to reduce correctable crashes by approximately 15%, resulting in an estimated annual cost savings of \$828,789.

In addition to the signal upgrades, extra safety funds have been allocated to install an advanced flashing warning sign on the westbound approach. This sign will alert drivers earlier to upcoming signal changes, providing additional time to react and stop safely.

Together, these improvements support FDOT's Target Zero mission by proactively addressing crash trends and creating a safer intersection for the Central Florida community.

STRIDES 2 Zero is a statewide initiative operated by the FDOT Traffic Engineering and Operations Office to work toward the goal of eliminating traffic fatalities and serious injuries on roadways. This initiative's objectives are to enhance highway safety management practices in Florida through a data-driven process, to provide engineering-based safety solutions for various transportation facilities and modes, and to encourage the implementation of technological advances in highway safety.

Freedom Elementary Joins Bike Bus Movement

Getting to school has taken on a whole new energy at Freedom Elementary in DeLand, where the community has embraced the growing "Bike Bus" movement.

A bike bus is an organized bike ride to school on a designated route, usually led by parents or teachers. Freedom Elementary Teacher Chuck Madden registered the school with Bike Bus World, an organization that helps communities launch their own Bike Buses. In November 2025, Freedom Elementary became the third school in Florida to establish a Bike Bus through Bike Bus World.

The school's very first Bike Bus on Nov. 7, 2025, drew more than 40 excited riders, and participation has only grown. Each Friday, students gather with teachers and parents to review the Bike Bus's three core rules:

1. Be safe.
2. Look out for your friends.
3. Have fun.

Led by Mr. Madden, the rides have become a joyful blend of exercise, community building, and real-world lessons in safety and responsibility.

Local law enforcement has played a significant role in the program's success. Sgt. Brian Bice from the



DeLand Police Department provided a full police escort during the second ride, turning the route to school into a rolling parade. In the weeks that followed, Freedom welcomed deputies from the Volusia County Sheriff's Office, including K-9 Maverick. Even DeLand Fire Station #83 joined the fun with a special appearance.

As December approached, the Bike Bus added a festive twist. Volusia County Sheriff Mike Chitwood, Santa Claus, Buddy the Elf, and even the Grinch surprised students by joining the ride, making the morning commute unforgettable.

With each event drawing a strong turnout and enthusiastic support, Freedom Elementary has fully embraced the Bike Bus spirit. The school's growing tradition reflects the broader mission of **Bike Bus World: to build healthier, happier, and more connected communities one ride at a time.**



Building Tomorrow's Workforce at Central Florida CCD

It's been projected that roughly 365,000 new residents flooded into the Sunshine State in 2025. This influx of people requires additional roads to be built and expanded to keep Floridians moving efficiently.

While there is an urgent nationwide need to expand highways and byways, the transportation construction industry is facing a labor shortage, especially in Florida. That is why states around the country hold Construction Career Days, and Central Florida is no different.

On Jan. 29 and 30 at the Volusia County Fairgrounds, hundreds of volunteers gathered for Central Florida Construction Career Days (CCD), which welcomed more than 2,200 high school and technical students from 57 schools across Central Florida. The hope is that the young attendees will discover the plethora of career opportunities in the transportation construction industry.




On both days, engineers and skilled trades workers from local companies, engineering firms, professional organizations, and FDOT not only guided junior and senior high school students through 48 learning labs but also provided opportunities to connect with industry professionals. They also had the chance to operate heavy equipment and realistic equipment simulators to experience their capabilities in real time.

FDOT D5 Office of Safety hosted a learning lab that focused on road safety solutions. Students participated in a hands-on activity in which they installed crash-mitigating safety features on a scale model of an intersection or curve to address documented crash history with various patterns and severities. The countermeasures they chose and installed also accounted for the documented crash-reduction benefit of each. Discussions included explaining their selections, examining potential alternatives, and outlining the configuration of the installed devices. The activity concluded with a workforce development discussion that highlighted the career opportunities in transportation safety and the required education for each option.

Michigan Avenue Elementary Bike Safety Event



Touch-a-Truck




Breakfast with Santa


Annual Downtown DeLand Christmas Parade

FDOT D5 & Orlando Magic Honor Local LEO



Professionals from local law enforcement, government agencies, community partners, and advocates from across District 5 attended to discuss ways to improve safety districtwide.




The three-hour event served as a road safety forum to align strategies across District 5. The summit, intended to strengthen relationships, focused on real-world solutions to reduce crashes and, in turn, serious injuries and fatalities on Florida roadways.

Participants engaged in workshops, heard from subject-matter experts, and reviewed data-driven strategies grounded in the "4E" framework – Engineering, Enforcement, Education, and Emergency Response.



The summit also highlighted innovative programs and local success stories from CTST groups across District 5, underscoring how teamwork drives measurable safety gains.

CTST groups representing District 5's nine counties meet monthly throughout the year to discuss current traffic safety trends. Each CTST group was bustling in spring and summer, which is considered the deadliest time of year on Florida roadways.



In fact, the period from Memorial Day to Labor Day is called the "100 Deadliest Days of Summer." CTST teams meet monthly to discuss problem areas in local jurisdictions and to identify top solutions needed to reduce traffic-related injuries.

During summer 2025, for instance, most counties participated in 13 national safety campaigns that targeted seat belt enforcement, red-light running, speeding, and drugged driving. Most counties also held events to target more localized issues.



Celebrating Leadership: Loreen Bobo Receives Keri's Promise Award

In January, the Keri Anne DeMott Foundation honored FDOT District 5 Safety Administrator Loreen Bobo with the Keri's Promise Award during the foundation's 10th Anniversary Gala. This award is presented to individuals who embody the heart of "Keri's Promise" by increasing awareness, inspiring safer choices, and serving as positive influences in their communities.



The Keri Anne DeMott Foundation was established to honor Keri's memory and share her story. Keri was just 20 years old when she was tragically killed in a head-on collision caused by a repeat DUI offender. Since then, the

foundation has focused on advocacy, education, and supporting families who have lost loved ones to impaired or distracted driving.

Loreen was selected for this meaningful award for her long-standing dedication to traffic safety and her steadfast commitment to keeping Keri's promise through education, outreach, and advocacy. As an integral member of District 5's Office of Safety, she has led and supported impactful safety initiatives that have reached thousands of people across Central Florida. Her work directly supports FDOT's Target Zero mission and strengthens partnerships with schools, law enforcement, and community organizations.

After the gala, Loreen shared the personal connection she feels to Keri's legacy through the "Starfish Story," a tale about a boy who values the importance of saving a life, regardless of how tall an order it is.

"I learned about the Starfish Story through a co-worker who knew Keri's dad. The Starfish Story was Keri's favorite story. When I heard it four years ago, it resonated with me: a simple story to remind us that every small



and big effort could save a life," Loreen said. "At our Central Florida Safety Summit in May, every attendee received two challenge coins. I challenged them to give the second coin to someone who they felt was helping to make our roadways safer. Well, my co-worker gave his second coin to Keri's dad, Bill DeMott. Tonight, I met Bill for the first time, and he shared that he was so moved that we have carried the Starfish Story even further. He said he carries that coin in his pocket any time he is working on Keri's mission. It was such a full-circle moment."

The Keri Anne DeMott Foundation noted that Loreen represents the spirit of the award – turning purpose into impact and

helping others understand how decisions we make every day affect the people around us. Her leadership continues to help make Central Florida's roads safer for all.

On behalf of MetroPlan Orlando, the federally designated metropolitan planning organization serving Orange, Osceola, and Seminole Counties, I want to express our support of the University of Central Florida's request to the Subcommittee on Transportation, Housing and Urban Development for funding to establish the Urban Innovation Lab (UIL) at UCF Downtown. As the regional agency responsible for coordinating transportation planning, land use integration, and long-range infrastructure investment across one of the nation's fastest-growing metropolitan areas, we have a direct and enduring interest in strengthening the collaborative planning capacity of our region. The Urban Innovation Lab represents a meaningful step toward that goal.

Greater Orlando faces planning challenges of genuine complexity — housing affordability pressures, accelerating infrastructure demands, and the need to engage increasingly diverse communities in decisions that shape their neighborhoods. These are not challenges that any single agency, university department, or private firm can address in isolation. What our region currently lacks is a dedicated, neutral environment where practitioners from government, academia, and industry can convene around shared data, shared tools, and shared problems. The Urban Innovation Lab would fill that gap by creating a professional, technology-enabled venue for evidence-based regional collaboration. 


Project Description

The Florida Department of Transportation (FDOT) is proposing pedestrian safety improvements on South Orange Avenue (State Road (S.R.) 527) in front of the Cortland on Orange Apartments, just north of Butler Drive in Orlando.

The project proposes installing a midblock crossing with a pedestrian-activated signal known as a Pedestrian Hybrid Beacon (PHB) to provide a safe crossing opportunity for pedestrians and cyclists.

A PHB is an overhead traffic device that is designed to provide increased visibility and protection for vulnerable road users at midblock crossing locations. It has two side by side red lights above a single yellow light. Unlike a regular traffic signal, the signal face for drivers remain “dark” until the pedestrian activates the beacon.

Additional improvements include constructing curbs and curb ramps to meet current Americans with Disabilities Act (ADA) standards.


