



# 2045 Metropolitan Transportation Plan Summary of Plan Revisions

MetroPlan Orlando's 2045 MTP was adopted by the MPO Board on December 9, 2020. The table below provides a summary of approved amendments and modifications to the 2045 MTP including links to archived supporting materials.

2	<p>The Florida Department of Transportation (FDOT) requested approval of amendments to the 2045 MTP. FDOT is advancing interim elements of the I-4 "Beyond the Ultimate" project. The currently adopted 2045 MTP and Cost Feasible Plan identifies these projects by reference and includes the Ultimate Configuration of I-4 with General Use and Managed Lanes throughout Orange, Osceola, and Seminole Counties, consistent with FDOT's Strategic Intermodal System (SIS) Cost Feasible/Needs Plans.</p> <p>As described in the letter found in the Supporting Information, FDOT determined the projects are consistent with the SIS Cost Feasible Plan. To ensure planning consistency, Table 6 (Interstate Highway/Strategic Intermodal System) of the 2045 MTP's Cost Feasible Plan will be amended to include the new reasonably available revenue and associated project listing.</p>	<p>Amendments were made to the Cost Feasible Plan: Strategies, Programs, and Projects documentation of the adopted 2045 MTP. 3	<p>The Florida Department of Transportation (FDOT) requested approval of amendments to the 2045 MTP. The project, Hicks Avenue (formerly Terry Avenue) Extension, located in the Griffin Park Historic District, was originally included as part of the I-4 Ultimate project because the Ultimate configuration removed/ relocated ramps and now provides the opportunity to construct an extension of Hicks Avenue from Gore Street to Anderson Street with complete street features, including two roundabouts, bicycle and pedestrian facilities, drainage ponds.</p> <p>FDOT has determined that the project will now be let and constructed as a separate project outside the I-4 Ultimate Concessionaire Agreement. As described in the letter found in the Supporting Information, FDOT has requested the Hicks Avenue project be added to the 2045 MTP's Cost Feasible Plan. To ensure planning consistency, Table 6 (Interstate Highway/Strategic Intermodal System) of the Cost Feasible Plan will be revised to include the new reasonably available revenue and associated project listing.</p>	<p>Requested amendments were made exclusively to Table 6 found in the Cost Feasible Plan documentation of the adopted 2045 MTP. MetroPlan Orlando staff proposed these Plan Revisions to better reflect rising transportation infrastructure costs within the 2045 MTP's Cost Feasible Plan. In addition, based on project implementation best practices, federally funded TSM&amp;O projects were bundled following FHWA guidance.</p> <p>In addition, due to the effort required in updating the budget tables, MetroPlan Orlando staff is taking this opportunity to address feedback from agency partners.</p>	<p>Requested amendments and modifications were made to the Cost Feasible Plan: Strategies, Programs documentation of the adopted 2045 MTP. Per FHWA guidance, a snapshot of the adopted TIP, including state and federal projects fully funded in advance of 2026, must be included in the Cost Feasible Plan’s budget allocation tables.</p> <p>To proactively maintain compliance with state and federal long range planning requirements, MetroPlan Orlando staff proposed Plan Revisions to include fully funded TIP projects in the existing-plus-committed network based on the current TIP. 8	<p>Complete streets projects have continued to see significant cost escalations, which has made several projects within the MTP infeasible due to the upfront capital needed to fund the entirety of a project at one time. This has necessitated splitting several complete streets projects into multiple phases to allow for the project to move forward through incremental steps. To maintain planning consistency, MetroPlan Orlando staff are proposing to amend the 2045 Metropolitan Transportation Plan to include the new phased implementation plans for affected projects.</p>	<p>Requested amendments / modifications will be made to the Cost Feasible Plan: Strategies, Programs documentation of the adopted 2045 Metropolitan Transportation Plan.
