#### I. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Commissioner Bob Dallari called the meeting to order at 9:00 a.m. and welcomed everyone. Mayor Jose Alvarez led the Pledge of Allegiance.

#### II. CHAIRMAN'S ANNOUNCEMENTS

Commissioner Dallari noted that as part of the efforts to make Central Florida safer, Best Foot Forward held their first crosswalk enforcement in Seminole County February 18<sup>th</sup>. A total of 393 warning & citations were issued that day. He added that he traveled to Tampa in February to meet with staff at CUTR and will be considering working with USF and some of their students on safety issues. Commissioner Dallari reported that he organized a tour of the RTMC for Thursday, March 26<sup>th</sup> which will include representatives from the Seminole County EMS as well as Advent Health personnel. He welcomed Commissioner Ortiz, new representative from the City of Orlando, who had not yet arrived.

#### III. EXECUTIVE DIRECTOR'S ANNOUNCEMENTS

Mr. Gary Huttmann called attention to the numerous events staff participated in since the December Board meeting. He recognized Ms. Stephanie Moss, FDOT District Five's new Bicycle/Pedestrian Coordinator. Mr. Huttmann called attention to FDOT's Vision Zero safety initiative which will run through March. He reminded board members about the MPOAC Institute on March 20-22 in Orlando and April 17-19 in Tampa, noting that alternates were welcome to attend. Mr. Huttmann also mentioned the Transplex event scheduled for April 20-22 in Orlando He reported that he and Ms. Virginia Whittington met recently with Natalie Martinez and Lauren Allen from Congresswoman Murphy's office. Mr. Huttmann noted that BUILD grant funding is still available and MetroPlan Orlando staff is available to assist with applications for that funding. He called attention to items in the supplemental folders which included a color copy of the MTP outreach events and a flyer for the Orlando South Interchange PD&E study public meeting. Commissioner VanderLey spoke briefly about a meeting she attended with Congressman Darren Soto and Congressman Peter DeFazio regarding funding for the I-4 Beyond the Ultimate project. She noted that if funding became available the project could possibly move up ten years. Commissioner Dallari asked staff to follow up with Commissioner VanderLey regarding the meeting.

Mayor Alvarez provided a report on the February 13<sup>th</sup> TDLCB Meeting. He reported that TDLCB members approved the November 2019 meeting minutes and acknowledged the November public meeting comments. In addition, committee members approved the reappointment of Ms. Marilyn Baldwin and Mr. Robert Melia, the 2020 Quality Assurance Task Force members and the 2020 Grievance Procedures and Grievance Committee. Mayor Alvarez noted that TDLCB members received presentations on the 2045 MTP Goals and Objectives, the ACCESS LYNX customer survey and the CTC update. He called attention to the ACCESS LYNX customer survey, which he said a majority of committee members did not agree with the results based on comments they have received. As a result of lengthy discussion on the survey the CTC evaluation was deferred to the May meeting. Mayor Alvarez met with Mr. Huttmann to discuss the issues raised and he stressed the importance of communication.

Mayor Demings provided an update on the Orange County proposed sales tax initiative. He reported that Orange County has done extensive outreach for the sales tax initiative, including surveying residents. Mayor Demings noted they received 11,000 survey responses and based on that feedback have determined four emphasis categories which include create/expand mass transit, roadway improvements, safety and operations/maintenance. Discussions have taken place with the thirteen Orange County municipalities with eleven indicating they would like to participate as recipients of funding from the tax, if passed. Mayor Demings provided a timeline with feedback still being accepted, an Orange County Commission work session was planned for March 24<sup>th</sup> and a Commission vote on whether to put the tax on the ballot is scheduled for April 7<sup>th</sup>. Ballot language will be developed prior to the April 7<sup>th</sup> meeting. He added that collaboration will take place with neighboring counties and that MetroPlan Orlando could play a role in the regional collaborative efforts. Plans were to leverage the sales tax dollars with state and federal funds.

#### IV. CONFIRMATION OF QUORUM

Ms. Cathy Goldfarb confirmed a quorum of 13 voting members present.

#### V. AGENDA REVIEW

Mr. Huttmann highlighted the three presentations slated for the meeting and their relationship to outcomes from the new strategic plan. He reported that there were no changes to the agenda and they were ready to move forward.

#### VI. COMMITTEE REPORTS

Mayor Dale McDonald reported that MAC met on March 5th and welcomed Lake Mary Commissioner, Jordan Smith as the new appointment for the City of Lake Mary. MAC members recommended approval of the FDOT Amendment to the FY 2019/20-2023/24 TIP; the Draft FY 2020/2021-2021/22 Unified Planning Work Program, and MetroPlan Orlando's Complete Streets Policy. Presentations included: An update on the development of the 2045 MTP, including an overview of the Congestion Management Process, a report on the 2045 MTP Public Outreach efforts, a presentation on the Regional TSMO Program; and a presentation on the Turnpike's Orlando South Interchange Improvement PD&E Study. The next MAC meeting is scheduled on May 7, 2020.

Ms. Sarah Elbadri reported that Community Advisory Committee members met on February 26<sup>th</sup> and recommended support for the Florida Department of Transportation's amendment to the Transportation Improvement Program, approval of the draft MetroPlan Orlando Unified Planning Work Program and the Complete Streets Policy. CAC members received a presentation from Metric Engineering on the fundamentals of Traffic Engineering. In addition, committee members received an update on the 2045 Plan, results from the 2045 Plan public outreach, a look at the Congestion Management Process, and a PD&E study for the Orlando South Interchange at Florida's Turnpike and State Road 528. The next CAC meeting was scheduled for April 22.

Mr. Nabil Muhaisen reported that Technical Advisory Committee members met on February 28<sup>th</sup>.and recommended approval of the TIP amendment requests regarding the Shingle Creek Trail and Lake Nona mobility network projects, the new UPWP and the Complete Streets Policy. TAC members heard presentations on: the 2045 MTP Congestion Management Process and Public Outreach efforts, the Regional TSMO Program and the Orlando South Interchange PD&E study

Mr. Doug Jamison reported that the Transportation Systems Management and Operations Committee met on February 28, 2020 and approved the January 24, 2020, TSMO meeting minutes, the FY 2019/20 - 2023/24 TIP amendment to include additional funding for the Shingle Creek Trail project in Orange County as well as funding for the Lake Nona Local Alternative Mobility Network project; the FY 2020/21 - 2021/22 Unified Planning Work Program (UPWP); and MetroPlan Orlando's Complete Streets Policy. TSMO members had a presentation by Jeremy Dilmore, FDOT D5, on ramp metering and its application in the I-4 Ultimate Project.

A letter from FDOT explaining the amendment request was provided, along with a fact sheet prepared by MetroPlan Orlando staff and the draft resolution. **MOTION:** Mayor Dale McDonald moved approval of the FDOT Amendment to FY 2019/20 – 2023/24 TIP. Commissioner Jay Zembower seconded the motion, which passed unanimously (Roll call vote conducted).

#### B. Approval of the Draft FY 2020/21 - FY 2021/22 UPWP

Action was requested by Mr. Nick Lepp, MetroPlan Orlando staff, to recommend approval of the FY 2020/21 - 2021/22 Unified Planning Work Program (UPWP). Mr. Lepp reviewed the UPWP schedule, estimated revenue and funding to LYNX. He reported that the UPWP had a streamlined format and he reviewed the new sections, noting which were core products and required tasks.

Ms. Larsen reviewed the edits that had been made to the policy since she previewed it at the February board meeting. These changes included better defining context sensitive, clarifying bicycle speed and funding and adding street lighting.

#### XI. OTHER BUSINESS/PRESENTATIONS

#### A. 2045 MTP Congestion Management Process

Ms. Lara Bouck, MetroPlan Orlando staff, gave an update on the 2045 Metropolitan Transportation Plan (MTP) with a focus on the Congestion Management Process (CMP). Ms. Bouck called attention to 2045 MTP documents that are now available online. She provided definitions of congestion management and congestion management process and its history. Ms. Bouck reviewed the relationship the CMP has with the MTP, process steps and what embodies a well-designed CMP. In addition, she covered the objectives of the MTP and goals and objectives relevant to the CMP. Ms. Bouck detailed FHWA's eight step process, and the timeline for the next steps. Commissioner Uribe commented that based on population growth, there is a need to look at infrastructure as well. Ms. Bouck responded that they will look at both, with CMP being a more short term method of helping with congestion. Commissioner Dallari commented that he would like to see distracted driving included as well as freight management and rest stop issues, which FDOT continues to study. He added that he would like a pollution study done on the local rest stop in light of residents' complaints regarding particulate matter.

#### B. 2045 MTP Public Involvement Update

Ms. Cynthia Lambert, MetroPlan Orlando staff, gave an update on the latest public outreach efforts pertaining to the development of the 2045 MTP. Ms. Lambert played a short video depicting some of the outreach events staff had participated in recently. She provided information on the outreach events staff attended, surveys completed and school-aged children they reached out to. Ms. Lambert reviewed survey results, communication materials provided and what's next, including public opinion research and scenario planning.

#### C. Regional TSMO Program

Mr. Eric Hill, MetroPlan Orlando staff, gave a presentation on MetroPlan Orlando's Regional Transportation Systems Management and Operations (TSMO) program. Mr. Hill reported that Orlando has a robust TSMO program that started eight years ago. He provided a definition of TSMO and the reasons why TSMO is a good option. Mr. Hill reviewed urban and rural contributing factors for congestion, strategies and TSMO history at MetroPlan Orlando. In addition, he reviewed I-4 crash data, regional partners, tasks, and dimensions of the Capability Maturity Model (CMM), along with a comparison of the dimensions of the CMM in 2014 and 2017 for FDOT District 5. Mr. Hill provided information on regional program participation, evaluation standards and challenges and opportunities.

### **RESOLUTION NO. 20-05**

## AUTHORIZING EMERGENCY APPROVALS UNDER A DECLARED STATE OF EMERGENCY TO ENSURE COMPLIANCE WITH FEDERAL AND STATE REQUIREMENTS FOR METROPOLITAN PLANNING ORGANIZATIONS

WHEREAS, the Orlando Urbanized Area Metropolitan Planning Organization (MPO), d.b.a. MetroPlan Orlando, is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for the Orlando Urbanized Area, and

WHEREAS, Florida Statutes 339.175; 23 U.S.C. 134; and 49 U.S.C. 5303 require that the urbanized area, as a condition to the receipt of federal capital or operating assistance, have a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the designated urbanized area; and

WHEREAS, pursuant to 23 U.S.C. 134, 23 CFR 450, and Florida Statutes 339.175, require MetroPlan Orlando and the Florida Department of Transportation to enter into an agreement clearly identifying the responsibilities for cooperatively carrying out the Federal Highway Administration (FHWA) portion of the Metropolitan Planning Process and accomplishing the transportation planning requirements of state and federal law; and

WHEREAS, MetroPlan Orlando is required to develop and amend as appropriate, the plans and programs required by 23 C.F.R. 450.300 through 450.324, including but not limited to the Unified Planning Work Program (UPWP); Transportation Improvement Program (TIP), a Public Participation Plan and a Metropolitan Transportation Plan (MTP); and

WHEREAS, the Novel Coronavirus Disease 2019 (COVID-19) is a severe acute respiratory illness that can spread among humans through respiratory transmission; and

WHEREAS, the Centers for Disease Control (CDC) currently recommends mitigation measures for communities experiencing an outbreak including limiting face-to-face contact with others as much as possible; and

WHEREAS, the Governor of the State of Florida declared on March 9<sup>th</sup>, 2020 a formal State of Emergency (Executive Order 20-52); and

WHEREAS, the Governor of the State of Florida issued Executive Order 20-69 on March 20, 2020 that allows virtual meetings and suspends certain requirements of the State Sunshine Laws; and

WHEREAS, the MetroPlan Orlando Internal Operating Procedures Section VII Operating Procedures and Section VIII. Procedures for Public Involvement Process do not contemplate operating under conditions of a State of Emergency such as we now find ourselves; and

WHEREAS, Section IX of the Internal Operating Procedures grants the MetroPlan Board Chair certain

authority under emergency conditions without having to call an emergency meeting of the board or committees. The Chairman's approval must be ratified at the next regularly scheduled meeting of the MetroPlan Governing Board. To maintain the integrity of the public involvement process, whenever feasibly possible, the Technical Advisory Committee, Community Advisory Committee, Transportation Systems Management and Operations Committee, Municipal Advisory Committee are asked to provide input prior to ratification by the MetroPlan Governing Board; and

WHEREAS, under the current State of Emergency circumstances, MetroPlan Orlando may be required to take immediate action to respond to urgent requests that cannot be delayed until a meeting and quorum can be established;

#### NOW, THEREFORE, BE IT RESOLVED THAT:

MetroPlan Orlando, while operating under a declared State of Emergency, hereby authorizes the Executive Director, with the approval of the Chairperson of the MetroPlan Orlando board, (or Vice-Chair in the absence of the Chair) to:

- 1. Amend a program document to maintain consistency with state or federal programs, or amend program or project funding if the time constraint is such that action at the next scheduled meeting of the MetroPlan Governing Board would significantly delay progress on a project previously supported by MetroPlan Orlando; and
- 2. Execute and amend other such other documents as are necessary and proper to carry out the functions of MetroPlan Orlando if the time constraint is such that action at the next scheduled meeting of the MetoPlan Governing Board would significantly impede the necessary functions of MetroPlan Orlando.
- 3. Adjust and adapt public participation strategies and public comment procedures to ensure the community can safely participate in the transportation planning process while under the State of Emergency; and
- 4. Approve the revision and submission of the UPWP and amendments to the existing TIP, provided that the process for seeking approval of these actions shall follow all applicable procedures when the State of Emergency is suspended; and
- 5. Submit copies of this resolution to:
  - a. Florida Department of Transportation;
  - b. Federal Transit Administration (through the Florida Department of Transportation); and the
  - c. Federal Highway Administration (through the Florida Department of Transportation).

- On February 19, The U.S. Department of Transportation (DOT) published a Notice of Funding Opportunity (NOFO) to apply for \$1 billion in Fiscal Year (FY) 2020 discretionary grant funding through the Better Utilizing Investments to Leverage Development (BUILD) Transportation Discretionary Grants program.
- DOT intends to award 50% of BUILD Transportation grant funding to projects located in rural areas.
- For this round of BUILD Transportation grants, the maximum grant award is \$25 million, and no more than \$100 million can be awarded to a single State, as specified in the appropriations act.

To provide technical assistance to prospective applicants, DOT is hosting a series of webinars during the FY 2020 BUILD grant application process. A webinar on how to compete for BUILD Transportation Grants for all applicants was held on February 25, 2020. MetroPlan Legislative Summary 2020



The 2020 Legislative Session adjourned Sine Die March 19<sup>th</sup> at 1:49pm, six days later than originally planned. The reasons for the extension were multiple. First, presiding officers and budget chairs in both the House and Senate were not in agreement on large aspects of the budget, but there were policy hang ups as well. Second, there was some disagreement as to how much needed to be placed in reserves due to the novel coronavirus.

Even in the four days since adjournment, things have changed drastically. It is not unlikely that the legislature will be forced to return to Tallahassee to have a special session regarding the budget as only \$300,000,000 was placed in reserves to combat the coronavirus.

Some statistics from the 2020 Legislative Session:

- 3,578 Bills and PCBs filed
- 2,596 Amendments filed
- 4,223 Votes Taken
- 40 Floor Sessions
- 210 Bills passed both chambers

#### **Bills that passed**

#### Office of Broadband

#### HB 969 by Drake and Ausley and SB 1166 by Albritton

HB 969 creates the Office of Broadband within the Department of Economic Opportunity, and designates the Office as the lead state agency to facilitate the expansion of broadband internet service within the state. The bill also allocates up to \$5 M to broadband expansion adjacent to proposed multi-use road corridors currently under study. The money would come from a previously allocated \$35 M for other infrastructure along the multi-use corridors.

The bill does not provide a new definition of high-speed broadband. The bill has passed the Legislature and will soon go to the Governor's desk for signature.

#### **Essential Infrastructure**

*SB* 7018 by the Committee on Infrastructure and Security and HB 7099 by the Committee on State Affairs

As passed, SB 7018 has the following provisions:

- Extends the 5G permitting time frame shot clock to include all city or county right of way permitting
- Authorizes FDOT to create emergency staging areas along the Turnpike System
- Makes a finding that climate change impacts will require the development of avoidance and mitigation strategies and that the reduction of carbon dioxide emissions can reduce the impact, thereby making a direct finding by the Florida Legislature that climate change is real and is the result of human activity. FDOT is directed to produce a Master Plan for the deployment of electric vehicle charging station infrastructure along the State Highway System and the PSC is required to make findings regarding demand and delivery systems for this infrastructure. A preliminary report, with recommended legislation, is due back by December 1, 2020.
- Permits landowners whose property is burdened by conservation easements to permit linear facilities across their property

#### **Tax Issues**

#### HB 7097 by House Ways and Means Committee

The final tax package makes a number of technical and procedural changes to Florida tax law and includes a .5% reduction in the State CST rate, hurricane preparedness and back to school sales tax holidays, various technical changes to the ad valorem statutes, and a prohibition on governments accepting any proceeds in return for granting allocation letters pursuant to Section 179D of the Federal tax code relating to energy efficiency improvements. A provision of the bill passed by the House would have limited the term of the Charter County Surtax to 20 years. The Senate amended that to provide a 30-year limit.

#### **Electric Bicycles**

#### HB 971 Grant (M) and SB 1148 by Brandes

The bill updates the state's laws on micro-mobility and legalizes the use of electric bicycles in the same manner that regular bicycles are regulated. The bill creates regulations governing the operation of e-bikes. An e-bike must be afforded all the rights and privileges of a bicycle. Local governments may regulate the operation of e-bikes on streets, highways, sidewalks, and sidewalk areas, and local governments and state agencies with jurisdiction over bicycle paths, multiuse paths, and trail networks may restrict or prohibit the operation of e-bikes on such paths and networks. The legislation passed both chambers without opposition and will soon be sent to the Governor.

#### **School Bus Safety**

#### HB 37 by Zika and SB 290 by Hooper

The bill revises the civil penalties for certain violations relating to stopping for a school bus. It increases the penalty from \$100 to \$200 for failing to stop for a school bus. For a second or subsequent offense within a 5-year period, a person will have their driver license suspended for not less than 180 days and not more than 1 year. The bill also increases the penalty from \$200 to \$400 for passing a school bus on the side that children enter and exit when the school bus displays a stop signal. The effective date of the bill is January 1, 2021. The legislation passed both chambers without opposition and is awaiting the Governor's signature.

#### **Bills that did not pass**

#### **Mid-block Crosswalks**

#### SB 1000 by Perry and HB 1371 by Fine

The bills would have required that crosswalks located at any place other than an intersection of a public street, highway or road be controlled by pedestrian and traffic signals that meet requirements of the Florida Department of Transportation Manual on Uniform Traffic Control Devices. HB 1371 passed the House, but the Senate bill was never heard in Appropriations.

#### **Transportation**

#### HB 395 by Andrade and SB 7054 by Infrastructure and Security

The bills amended various statutes relating to transportation. Of concern to municipalities, the bill expanded the "shot clock" and "deemed approved" requirements to permit applications for all Peebles, Smith & Matthews, Inc.

utilities in the right of way. This language was included in SB 410 which ultimately passed. HB 395 passed the full House, but the companion bill was not heard in its last committee of reference, Appropriations.

#### **Electric Vehicle Charging Stations**

#### HB 943 by Daley and SB 452 by Rodriguez

The bills required FDOT to develop and adopt a master plan for electric vehicle charging stations on the state highway system by July 1, 2021. The contents of this legislation were included in SB 7018- Essential State Infrastructure which passed both chambers and is awaiting the Governor's signature.

#### Use of Wireless Communications Devices While Driving

HB 249 by Slosberg

The bill took the current texting while driving law a step further to authorize law enforcement to stop a motor vehicle and issue a citation to a person using a wireless communications device. This was the "hands free" bill. The bill did not have a Senate companion nor did it receive a committee hearing this year.

#### **Traffic Offenses**

#### HB 455 by McClain and SB 306 by Baxley

This was the "Vulnerable Road User Act" which has been filed the last couple of years. It provided enhanced criminal penalties for a person who commits a moving violation that causes serious bodily injury to vulnerable road users. The bills did not receive a committee hearing this year.

#### Safety Belt Usage

HB 179 by Slosberg

The bill required each passenger in a motor vehicle to be restrained by a safety belt or child restraint device. HB 179 did not have a Senate companion and was never heard in committee.

#### **Motor vehicle Rentals**

#### HB 377 by Latvala and SB 478 by Perry

The bill required peer-to-peer vehicle-sharing programs to impose a \$2 per day surcharge. It defined a number of terms including what a "car-sharing service" is and "peer-to-peer vehicle". It also included insurance requirements. The bills died in committee.

#### **Transportation Disadvantaged**

#### HB 551 by Jenne and SB 76 by Book

The bills required community transportation coordinators, in cooperation with the coordinating board, to evaluate multicounty or regional transportation opportunities to include regional fare payment systems to enhance cross-county mobility for the transportation disadvantaged to access employment, health care, education, shopping, or other life-sustaining services across one or more county lines. HB 551 and SB 76 died in committee.

#### **Fiduciary Duty of Local Government Officials**

#### HB 1113 by Beltran and SB 1270 by Lee

The bills would have created a new statute establishing standards for the fiduciary duty of care for appointed public officers and executive officers of specified governmental entities. "Appointed public official" is defined to include "state officers" as well as "local officers," such as appointed members of the governing body of a municipality, a board authorized to enforce local code provisions, a board having the power to recommend, create or modify land planning or zoning (but not citizen advisory committees) and community redevelopment boards. "Executive officer" is defined as the chief executive officer of a governmental entity. The bills provide that each appointed public official and executive officer has a fiduciary duty of care to the governmental entity served and has a duty to act in accordance with laws and terms governing the office or employment, act with the care and competence normally exercised by reasonably prudent persons in similar corporate positions, act only within the scope of authority, refrain from conduct likely to damage the economic interests of the governmental entity. The Senate passed their version, but the bill died in messages as the House did not take it up after its first committee of reference.

#### **Legal Notices**

#### HB 7 by Fine and SB 1340 by Gruters

The bills would have allowed a governmental agency the option to publish legally required advertisements and notices on a publicly accessible website if certain conditions are met. The bills require a governmental agency to publish a notice at least once a year in a newspaper of general circulation that the resident or property owner may receive legally required notices or advertisements via first class mail or email by registration of his or her name, address and email address with the local governmental agency. CS/HB 7 passed the House (71-47) but was not heard by the full Senate.

## I-4 Ultimate Project Approaches Major Milestone in Summer 2020

Numerous Corridor Improvements Already Available

**ORLANDO, Fla.** – The I-4 Ultimate project anticipates opening the new Interstate 4 (I-4) State Road (S.R.) 408 interchange to traffic summer 2020. Seven flyover ramps will modernize connections between Orlando's two busiest roadways.

While the nearly complete downtown interchange is the crown jewel of the 21-mile rebuild, Central Florida motorists have already been reaping benefits of the I-4 overhaul. Thirteen miles of eastbound interstate lanes, from Anderson Street through the eastern project limits, are in their final footprint. Maitland Boulevard commuters now travel elevated lanes west of I-4, enabling them to bypass traffic signals at Lake Destiny Road, Keller Road and Maitland Summit Boulevard. The new Grand National Drive Overpass has provided congestion relief in the busy attractions area to Central Florida visitors since summer 2017.

To continue forward progress, the Florida Department of Transportation (FDOT), along with I-4 Mobility Partners and its contractor SGL Constructors, is updating the project completion plans and schedule to help ensure work is completed safely and efficiently.

Plans include completing non-tolled general use lanes and interchange ramps ahead of managed lanes, to best serve the nearly 200,000 drivers who depend on I-4 daily. Motorists can expect to have an upgraded I-4 mainline complete with enhanced safety features including full-width travel lanes, shoulders, and increased capacity at 15 major interchanges in early 2021. These general use lane improvements remain consistent with original completion estimates. The updated schedule indicates managed lanes will open in 2022.

"The Department's goal was to provide a solution that would offer the biggest benefit to the greatest number of drivers. Focusing on getting the general use lanes open within the original project timeline does just that," said Florida Department of Transportation Secretary Kevin J. Thibault, P.E. "FDOT remains committed to ensuring the project is completed safely and will continue to monitor the concessionaire to ensure accountability until the project is complete," Secretary Thibault added.

This strategy enhances safety for both workers and motorists. Drivers receive a more reassuring and reliable driving experience sooner with fewer temporary configurations and lane shifts, promoting smoother daily traffic flow. Construction of managed lanes within the median of the interstate after general use lanes are complete minimizes daily disruptions and provides space for crews to work away from live traffic. This also allows the project team to better utilize resources.

FDOT and the I-4 Ultimate project team also resolved claims, streamlined construction processes, and added additional work to help deliver a quality and timely project. A settlement of claims made by the concessionaire for unforeseen impacts and financial compensation of approximately \$125 million has been agreed upon by the project parties.

The latest update reiterates FDOT's highest priority – safety of the traveling public. Additionally, the update reflects FDOT's commitment to completing this major corridor that is the heart of transportation in Central Florida.

RE: Ability to Hold a Virtual Meeting

<u>BACKGROUND AND ISSUE</u>: Given the COVID-19 pandemic, many cities and counties are now holding "virtual meetings" without a quorum of governing board members being physically present. You have asked whether the MPOAC Governing Board may hold a "virtual meeting" using communications media technology at the end of April. I am unable to conclude that the MPOAC may legally do so. Hence any action taken without the presence of a quorum being physically present could be, if challenged in a court of law, voidable.

<u>ANALYSIS</u>: The requirement that a public body must have a quorum of its members *physically* present at its meeting location has been a requirement set forth in numerous Florida Attorney General opinions dating back to the 1990s.<sup>1</sup> Several different Florida Attorneys General have reinforced this position in more recent years.<sup>2</sup>

In Attorney General 2020-03 issued March 19, 2020, the Attorney General explained that while the Government-in-the-Sunshine Law<sup>3</sup> does not require a quorum of a public body's members to be physically present to conduct a meeting, this requirement has been derived from other laws specifying that a quorum must be physically present to lawfully conduct public business or that the meeting of a local government body be held at a place within the body's jurisdiction.<sup>4</sup>

Certain government agencies which are subject to Florida's Administrative Procedure Act ("APA")<sup>5</sup> have the ability by law to conduct so-called virtual meetings using communications media technology. These are primarily, although not exclusively, state agencies. However, both MPOs and the MPOAC are specifically exempted from the APA.<sup>6</sup>

In AGO 2020-03, the Attorney General concluded that the requirement of the presence of a physical quorum being present may only be changed by statute, or by the suspension of the physical quorum requirement during a state of emergency. Thus, the MPOAC must look to the Governor's Executive Order 20-69 issued on March 20, 2020,<sup>7</sup> which states:

Section 1. I hereby suspend any Florida Statute that requires a quorum to be present in person or [*sic*] requires a **local government body** to meet at a specific place.

Section 2. *Local government bodies* may utilize communications media technology, such as telephonic and video conferencing, as provided in section 120.54(5)(b)2., Florida Statutes.

(emphasis supplied).

Among local government attorneys there has been much discussion about what entities are included within the term "local government bodies." Reportedly, several local government attorneys have requested that the Governor's Office clarify the term. Given the workload created in the Governor's Office due to the pandemic, the Governor's Office has not provided further guidance.

Using the legally accepted rules of statutory construction to interpret the Executive Order,<sup>8</sup> the first step is to attempt to interpret the Executive Order using the "plain

meaning rule." "The plain meaning of statutory language is the first consideration of statutory construction, and the courts must construe statutes according to their plain meaning, unless words are defined in the statute, or by clear intent of the legislature, or unless a different meaning or connotation necessarily is implied from the manner or context in which the words are used."<sup>9</sup>

Thus, the starting point in ascertaining what is or is not a "local government body" must be ascertained using the plain meaning rule.<sup>10</sup> Turning to Black's Law Dictionary, the definition of the term "local government" is "[t]he government of a particular locality, such as a city, county, or parish; a governing body at a lower level than the state government. The term includes a school district, fire district, transportation authority, and any other special-purpose district or authority."<sup>11</sup>

I find no applicable definition after consulting Florida Statutes, although there are numerous references to a "local government.<sup>12</sup> Accordingly, while an MPO, made of county commissioners, city council members, and port or airport authority members, all from a discrete and specific location, could easily be construed to be a local government, I am unable to interpret the term "local government body" as used in Executive Order 20-69 as being applicable to a legal entity whose members are located in areas running from Pensacola to Miami-Dade County, a distance of 675 miles, and whose jurisdiction covers much of the same area, as being a "local government." Thus, I am unable to opine that Executive Order 20-69 is applicable to the MPOAC.

In my legal opinion, the effect of holding a meeting of the MPOAC without a physically present quorum would be that any action taken by the governing boy would be voidable by a court of law.

The City of Orlando project will restore a 1926 landmark, increasing its capacity to serve as a transportation hub in South Downtown for Central Florida's rail, bus, bicycling and pedestrian transit network. The station is served by both Amtrak and Central Florida Commuter Rail Transit (SunRail) and is in walking distance to Central Florida's only Level One Trauma Center, Orlando Health, which employs over 20,000 individuals. On behalf of MetroPlan Orlando, I am pleased to submit this letter of support for the Osceola County BUILD Grant application for widening and rebuilding Neptune Road, a critical east-west arterial that connects the county's two cities and that will provide new mobility options for those who live in the area. MetroPlan Orlando is the federally designated metropolitan planning organization for the three county region of Orange, Osceola, and Seminole Counties.

Osceola County is the second fastest growing county in all of Florida. This 3.9-mile long road widening project will expand transportation options for the county's exploding population, while improving connections between existing rural and urban areas. 







#### Central Florida for Transportation Coalition March 10, 2020




