#### **I. CALL TO ORDER**

Chairman Tom O'Hanlon called the Community Advisory Committee meeting to order at 9:30 a.m.

#### **II. PLEDGE OF ALLEGIANCE**

Mr. Jeffrey Campbell led the Committee in the Pledge of Allegiance.

#### **III. CHAIRMAN'S COMMENTS**

Chairman O'Hanlon told CAC members that the SR 417 toll within a toll project is on hold and he believes there still needs to be a swap of road sections between agencies, so that one agency oversees an entire arterial.

#### **IV. AGENDA REVIEW**

Ms. Cynthia Lambert introduced new MetroPlan Orlando staff member Ms. Crystal Mercedes, who will be working with Mr. Eric Hill on Transportation Systems Management and Operations projects. She reported that the June 8<sup>th</sup> MetroPlan Orlando Board Meeting was being held at 9:00 a.m. at Second Harvest Food Bank. Ms. Lambert told CAC members that included in the supplemental folders were revised pages for the Transportation Improvement Program and the latest air quality report.

#### **V. CONFIRMATION OF QUORUM**

Ms. Cathy Goldfarb confirmed that a quorum was present.

## VII. ACTION ITEMS

### *A. Approval of April 27, 2016 Meeting Minutes*

Approval is requested of the April 27, 2016 meeting minutes that were provided.

**MOTION:** Mr. Bill Carpenter moved for approval of the April 27, 2016 meeting minutes. Ms. Theresa Mott seconded the motion, which passed unanimously.

### *B. Repurposing of Federal Earmark Funds - Staff Recommendation*

Mr. Gary Huttman, MetroPlan Orlando, explained a provision that was contained in the new federal transportation bill (the FAST Act) regarding repurposed earmarks, old qualifying earmarks in our three-county area and the staff recommendation that uncommitted funds be used to advance project development work on the US 192 Bus Rapid Transit (BRT) project in Osceola County, the SR 50 BRT project in Orange County and LYMMO North-South expansion. A bulletin describing the repurposing process was provided along with a spreadsheet showing the projects in the MetroPlan Orlando region that have earmark funds available for repurposing. Mr. Huttman told committee members that legislators no longer use earmarks to set aside funding for projects and the state was given the authority to repurpose funding that remained available. The FDOT Central Office in turn gave the authority to the FDOT District Office to designate projects locally to advance with the funds. MetroPlan Orlando has coordinated with District 5, he reported, on allocating the available \$3 million which needs to be allocated by August and requires MetroPlan Orlando board approval. Mr. Huttman added that the funds would be required to be obligated by September 30, 2019 and staff has been looking at what projects could advance and make the best use of the funds within the time frame requirements. He told CAC members that three projects were identified for consideration, including the US 192 Bus Rapid Transit (BRT), the SR 50 Bus Rapid Transit, and the LYNX LYMMO north/south expansion. Discussion ensued regarding local commitments for the identified projects, percentage of FTA new starts contributions, who the grantees were for the three projects, the first stage and total cost for each project and the projected time frame, and was there a limit on the number of projects. Mr. Huttman told committee members that FTA will contribute 50% for new starts projects and all three were good competitive projects for those funds. He added that the grantees were LYNX for the US 192 and SR 50 BRT projects and the City of Orlando for the LYMMO expansion and these were staff recommendations for projects, which were already on the Project Priority List and each needed approximately \$1 million. Mr. Zubarik inquired about the total cost for each project. Mr. Huttman responded that the total costs were \$50 million for the US 192 BRT, \$36 million for the SR 50 BRT and the LYMMO expansion was divided into two segments, one at \$14 million and the second at \$10 million. Mr. Hector Lizasuain commented that there was a lot of communication ongoing in Osceola County regarding setting aside funding for the US 192 BRT project and moving it forward to get it done. Additional discussion ensued regarding project readiness, importance of the SR 50 BRT for other areas along the corridor, timeline constraints, and looking at also advancing pedestrian safety projects.



**MOTION:** Mr. Atlee Mercer moved for approval of allocating \$1 million of the earmarks repurposed funding to each of the three projects that were identified, the US 192 Bus Rapid Transit (BRT), the SR 50 Bus Rapid Transit, and the LYNX LYMMO north/south expansion, with the caveat that if any of the projects could not advance, the funds be allocated to the other remaining projects. Mr. Hector Lizasuain seconded the motion, which passed unanimously

### ***C. Central Florida MPO Alliance Prioritized Project List***

Action was requested by Ms. Virginia Whittington, MetroPlan Orlando staff, to recommend approval of the Central Florida MPO Alliance (CFMPOA) Prioritized Project List, which included a list of highway, trail and transit projects that are of regional significance. The draft list was provided. Ms. Whittington told CAC members that the CFMPOA, which had been meeting for a number of years, decided in 2013 to look at projects of regional significance. Alliance members, she added, implemented a formal prioritization process for Strategic Intermodal System, trail and transit projects compiled by each respective M/TPO. Ms. Whittington noted that the lists were reviewed yearly, updated and the revised drafts are approved by the agencies boards and committees prior to approval by the CFMPOA. She then reviewed the changes that had been made during the recent update. Ms. Whittington reported that at the last CFMPOA meeting, a question was raised regarding the Shingle Creek Trail, which crosses urban boundaries, and why it was not included on the trails list. In the past, she noted, only trails that crossed regional boundaries had been included. At the request of staff, a change was made to also include trails that cross urban boundaries and the Shingle Creek trail was added to the trail priority list. Ms. Whittington told committee members that the third list was transit projects that were all high capacity Bus Rapid Transit or rail projects and privately funded projects had also been included.

**MOTION:** Mr. Tony Tizzio moved for approval of the Central Florida MPO Alliance (CFMPOA) Prioritized Project List. Mr. Atlee Mercer seconded the motion, which passed unanimously.

## **VIII. PRESENTATIONS AND STATUS REPORTS**

### ***A. Preview of FY 2016/17-2020/21 Transportation Improvement Program***

Mr. Keith Caskey, MetroPlan Orlando staff, presented a preview of the new FY 2016/17-2020/21 Transportation Improvement Program (TIP). Copies of the FDOT highway and bicycle and pedestrian projects and the LYNX transit projects were provided. A copy of the FY 2020/21-2039/40 Prioritized Project List that was adopted last year was also provided and had been updated to show the latest project phases that have been funded based on the new TIP. The TIP will be presented for action at the June 22<sup>nd</sup> CAC meeting. Mr. Caskey provided some background information on the TIP and reviewed the changes that had been made for the new TIP. He called attention to some pages that had been revised and were included in the supplemental folders. A TIP public hearing, he added, will be held on Monday, June 20<sup>th</sup> at MetroPlan Orlando with maps available at 5:30 p.m. and the hearing at 6:00 p.m. Mr. Bill Carpenter commented that widening roadways from

four to six lanes created problems for pedestrians. He added that he would like to see information on the pedestrian impact study that had been conducted to see what the outcome was regarding widenings of arterials. Chairman O'Hanlon requested an update at the next meeting on the pedestrian safety audits that had been conducted. Mr. Atlee Mercer commented that looking at what is done to a roadway after the widening to address pedestrian issues is important. Chairman O'Hanlon added that there has been a shift in funding away from capacity projects with more funding going to other modes. Mr. Caskey confirmed that the past few years there has been a shift away from major capacity projects. Mr. Brindley Pieters inquired about aviation projects. Mr. Caskey responded that the airports themselves were responsible for the aviation projects.

## MEMORANDUM

June 15, 2016

**TO:** Community Advisory Committee Members

**FROM:** Gary Huttman, Deputy Executive Director

**SUBJECT:** Repurposing Federal Earmarks

At your meeting on May 25, 2016, I presented information on the need to repurpose federal earmarks that had been assigned to the region years ago. A decision on which projects the funds should go to was to be made by August.

After your meeting, FDOT recommended a solution to allow the region more time to choose projects - essentially a funding swap to eliminate the August deadline. They could apply the earmark funds to a fully-funded project in the work program, the six-laning of Maitland Blvd. from I-4 to Maitland Ave. FDOT could then take an equal amount of funds from the Maitland Blvd. project and apply it to another project(s) in the MetroPlan Orlando region. The MetroPlan Orlando Board at its June 8<sup>th</sup> meeting approved FDOT's suggestion. They will consider project recommendations for the available funds at a future meeting.

The CAC is asked to discuss the options below, which came forward during the discussions at the May/June committee meetings. Approximately \$2.6 million in earmarks is available.

### **OPTION 1**

Stick with CAC's recommendation from May meeting to allocate equally split available funds between three bus rapid transit projects: the US 192 Bus Rapid Transit, the SR 50 Bus Rapid Transit, and the LYNX LYMMO north/south expansion. This recommendation was made with the caveat that if any of the projects could not advance, the funds be allocated to the remaining projects.

### **OPTION 2**

The Municipal Advisory Committee (MAC) recommended that the funds be used to advance improvements for quiet zones along SunRail phase 1. They recently became aware of cost increases in the amount of approximately \$4.5 million and suggested that all available federal earmarks be applied to this project. The CAC could join MAC in recommending that all the money go to quiet zones.

### **OPTION 3**

If desired, the CAC may also suggest another funding allocation, such as a splitting funds between options 1 and 2.

## FY 2021/22-2039/40 Prioritized Project List

This document includes the draft list of highway, Transportation Systems Management & Operations, bicycle & pedestrian, transit and TRIP projects that have been developed for the FY 2021/22-2039/40 Prioritized Project List. Projects that have been added this year are identified as *New*, and the projects carried over from last year's PPL with new ranking numbers have their old ranking numbers from last year shown in parenthesis. Action will be requested to approve the Prioritized Project List at the August/September meetings.

### FY 2021/22 Funding Allocation Estimates

Surface Transportation Program (SU) funds = Approx. \$27.3 million (Annual average of SU funds programmed from FY 2016/17 through 2020/21)

32% of \$27.3 million for Highway Projects = \$8.7 million

30% of \$27.3 million for Transit Projects = \$8.2 million

21% of \$27.3 million for TSMO Projects = \$5.7 million

17% of \$27.3 million for Bicycle & Pedestrian (Enhancement) Projects = \$4.7 million

District Dedicated Revenue (DDR) funds = Approx. \$71.7 million (Annual average of DDR highway funds programmed from FY 2016/17 through 2020/21) *(Note: Beginning in FY 2020/21, MetroPlan Orlando will allocate up to 30% of DDR funds for the operation of the premium transit projects specifically identified in the 2040 LRTP that are ready to utilize the funding. The remaining DDR funds will be combined with the SU funds for the highway projects.)*

National Highway System (NHS) funds = Approx. \$111.1 million (Annual average of NHS funds programmed from FY 2016/17 through 2020/21)

Transportation Regional Incentive Program (TRIP) funds = Approx. \$8.1 million (Annual average of TRIP funds programmed from FY 2016/17 through 2020/21)

## FY 2020/21-2039/40 Prioritized Project List Adopted May 2015 - Updated May 2016 Based on FY 2016/17-2020/21 Tentative Five Year Work Program

This is the list of highway, Transportation Systems Management & Operations (TSMO), bicycle and pedestrian, transit and TRIP projects from the FY 2020/21-2039/40 Prioritized Project List (PPL) that was adopted in May 2015. These project lists were updated in May 2016 to highlight those projects that have had new phases funded by FDOT in the FY 2016/17-2020/21 Tentative Five Year Work Program or by local jurisdictions. New phases funded for those projects since last year's PPL are shown in ***bold italic***. This updated list was developed for the purpose of providing a starting point for developing the list of projects to be included in the FY 2021/22-2039/40 Prioritized Project List.

The figures shown in the Estimated Remaining Cost column for the highway projects are present-day cost estimates provided by FDOT.

The PPL is normally adopted by the MetroPlan Orlando Board each year in September and submitted to FDOT no later than October 1<sup>st</sup>. However, due to the early start for the 2016 Florida legislative session, the PPL was on an accelerated schedule in 2015 and was adopted by the board on May 13, 2015 and was submitted to FDOT.

**Note:** For funding equity purposes regarding TRIP funds, MetroPlan Orlando's policy is that, for any TRIP funding allocation for the MetroPlan Orlando area in FY 2015/16, each of the three counties will receive a percentage of the allocation based on population percentages, with Orange County receiving 64%, Seminole County receiving 21.3% and Osceola County receiving 14.7%. Each of the counties will then set aside 22% of their TRIP funding allocations for LYNX projects. If MetroPlan Orlando receives a TRIP funding allocation in FY 2015/16, Orange County's share of those funds will be used for the SR 528/Innovation Way interchange project (ranked #1 on the list) and the other projects on the TRIP list will remain in their current priorities as shown on the list. However, if MetroPlan Orlando does not receive any TRIP funds in FY 2015/16, and the SR 528/Innovation Way interchange project is funded through construction with funding categories other than TRIP funds and moves off the list, Orange County's next priority, the 4-laning of Boggy Creek Road from Simmons Road to SR 417 (ranked #5 on the list), will move up to the #1 priority on the TRIP list, since Orange County has not had any projects funded with TRIP funds since FY 2008/09. For FY 2016/17 and beyond, MetroPlan Orlando's TRIP funding allocation will not be divided into percentages for the counties, and the projects on the TRIP list will be funded based on priority and the availability of TRIP funds and local matching funds.
