I. CALL TO ORDER

Chairwoman Sarah Elbadri welcomed everyone and called the Community Advisory Committee meeting to order at 9:33 a.m.

II. PLEDGE OF ALLEGIANCE

Mr. Jeffrey Campbell led the Pledge of Allegiance.

III. CHAIRMAN'S COMMENTS

Chairwoman Elbadri detailed the hybrid meeting guidelines and public comment procedures. She welcomed new CAC member Mr. Jeffrey Boebinger representing Altamonte Springs. Mr. Boebinger spoke briefly. Chairwoman Elbadri said that she had shared CAC members' concerns regarding a Turnpike widening project in West Orange County at the September MetroPlan Orlando Board meeting. She noted board members received a Brightline presentation, along with an I-4 Ultimate presentation. Chairwoman Elbadri called attention to the new board room AV equipment, because some members in attendance had not yet had the opportunity to use it. Some brief instruction was provided on using the equipment.

IV. AGENDA REVIEW

Ms. Mary Ann Horne noted that due to the current pandemic situation, the decision was made to conduct hybrid meetings with a quorum in person for the remainder of the year. Ms. Horne called attention to the legislative priorities document in the agenda packet She told CAC Members that Ms. Virginia Whittington was not able to give a presentation on the priorities at the meeting due to a scheduling conflict. Ms. Horne reported that the Florida AV Summit was being held November 29th to December 1st at the Rosen Shingle Creek, not at CFX. She told CAC members that Mr. Douglas Henley had resigned from CAC due to new employment commitments. New CAC member recruitment

would be taking place at the end of the year, and she asked if any members were not able to continue serving to please let staff know. Ms. Horne noted there were some changes in the order of the agenda that Chairwoman Elbadri would help walk members through.

V. CONFIRMATION OF QUORUM

Ms. Lisa Smith conducted the attendance roll call and confirmed that an in-person quorum was not in attendance at that time.

VI. PUBLIC COMMENTS ON ACTION ITEMS

None.

VII. ACTION ITEMS

Due to the absence of a quorum at this time, the following items were presented for review and discussion. Action was taken later in the meeting when a quorum was reached.

A. Approval of CAC Virtual Workshop Meeting Minutes: December 2020 – August 2021

Approval was requested of CAC virtual workshop meeting minutes from December 2020 through August 2021, listing of meetings was provided. Copies of minutes were provided in the respective meeting agendas, except for August. Those minutes will be presented at the December committee meeting.

B. Ratification of Board Action Items: December 2020 – September 2021

Approval was requested of the action items approved by the MetroPlan Orlando Board from December 2020 through September 2021, which were provided.

C. Appointment of Officer Selection Subcommittee

Action was requested to approve the establishment of a subcommittee to select candidates to serve as the CAC Chair and Vice-Chair from January through December 2022. Chairwoman Elbadri called for volunteers to serve on the Officer Selection Subcommittee. Representation was requested from all three counties. Mr. David Sibila, Ms. Gigi Moorman, Mr. R.J. Mueller, Ms. Maria Cortes and Mr. Jeffrey Boebinger volunteered and were subsequently appointed by Chairwoman Elbadri to the Officer Selection Subcommittee. *This item did not return for a vote after a quorum was established, since the committee members had reached consensus on Chairwoman Elbadri's appointments.*

D. Approval of the Proposed 2022 Board/Committee Meeting Schedule

Approval was requested of the 2022 MetroPlan Orlando Board/Advisory Committee Meeting Schedule, a copy of which was provided.

B. Presentation on I-4 Beyond the Ultimate Project - taken out of order

Ms. Catalina Chacon and Mr. Todd Helton, FDOT, gave a presentation on the status of the I-4 Beyond the Ultimate project. Ms. Chacon provided background on the project noting that FDOT was looking at critical areas that needed to be advanced. She told CAC members that there were new tools available to evaluate opportunities to add capacity such as managed lane policy versus

the express lane policy, options with managed lane separation and size and cost of projects. Ms. Chacon added that projects were identified through the process, and some were already planned. She said a potential westbound bottleneck had been identified, and an interim solution was being called the "tube," a continuous westbound express lane that would bypass interchanges. Ms. Chacon provide a graphic illustration of a typical section of the interim single westbound express lane, along with information about other identified projects and the delivery plan. Mr. Todd Helton provided additional information on the individual projects and the designbuild procurement process. Discussion ensued regarding whether construction would be temporary, possible use of the tube lane before project completion, why the tube is only westbound, effect of tube project on business access and transit stops, the reasons for expediting the amendment request, and whether the project would preclude a rail corridor.

C. Presentation on Federal Stimulus Projects - taken out of order

Mr. John Tyler, FDOT, gave a presentation on the projects being funded in the MetroPlan Orlando region as a result of the federal stimulus program under the American Rescue Plan Act (ARPA). Mr. Tyler told CAC members that FDOT was asked to compile a list of projects to which stimulus funds could be allocated. FDOT staff, he added, looked at projects that were ready and each district compiled its own list. Mr. Tyler noted that District 5 received \$300 million in stimulus funds, and the MetroPlan Orlando tri-county area received \$125 million of that funding. He reported that once the list is announced, FDOT will be working on procurement. Local projects include I-4 Beyond the Ultimate South projects and two interchange projects in I-4 Beyond the Ultimate North. Discussion ensued regarding the I-4/SR528 intersection, the need for improvements on local roads, need for funding for transit, and whether there was a study conducted for the bottleneck projection.

A quorum was present at this time.

E. FDOT Amendment to 2045 Metropolitan Transportation Plan

Mr. Nick Lepp, MetroPlan Orlando staff, requested the CAC to recommend that Table 6 in the 2045 MTP be amended to include the I-4/Sand Lake Road Interchange and express lane project from west of SR 528 to west of Kirkman Road and the I-4 express lane project from west of Central Florida Parkway to west of SR 528. A letter from FDOT stating this project is consistent with the SIS Cost Feasible Plan was provided, along with a fact sheet prepared by MetroPlan Orlando staff. Mr. Lepp noted that this was a procedural amendment.

MOTION: Mr. Tom O'Hanlon moved for approval of amending the 2045 MTP to include the I-4/Sand Lake Road Interchange and express lane project from west of SR 528 to west of Kirkman Road and the I-4 express lane project from west of Central Florida Parkway to west of SR 528. Mr. Casmore Shaw seconded the motion, which passed unanimously.

F. FDOT Amendment to FY 2021/22 - 2025/26 TIP

Mr. Keith Caskey, MetroPlan Orlando staff, requested the CAC to recommend that the FY 2021/22 - 2025/26 TIP be amended to include the federal stimulus projects described in the FDOT presentation at the October 27 CAC meeting. The amendment included:

• FM #4411133 – I-4 at Daryl Carter Pkwy. Interchange

- FM #4443151 I-4 at Sand Lake Road from west of SR 528 to west of Kirkman Road
- FM #4443153 I-4 from west of Central Florida Pkwy. to west of SR 528

A letter from FDOT staff explaining the amendment request was provided, along with a fact sheet prepared by MetroPlan Orlando staff and the draft resolution to be presented at the November 10th Board meeting. Mr. Caskey noted that FDOT needs this amendment for the procurement process.

MOTION: Mr. Tom O'Hanlon moved for approval of amending the FY 2021/22 - 2025/26 TIP to include the federal stimulus projects described in the FDOT presentation at the October 27 CAC meeting. Mr. Casmore Shaw seconded the motion, which passed 20:1 (Cortes opposed).

VIII. PRESENTATIONS/STATUS REPORTS

A. Presentation on I-4 Ultimate Project

Mr. John Tyler, FDOT, gave a presentation on the status of the I-4 Ultimate project, which is currently under construction from west of Kirkman Road to east of SR 434. Mr. Tyler provided an overview of the I-4 Ultimate project, typical section, general use lane completion milestones and the remaining work, which is expected to be completed by the end of the year. He reviewed the express lane progress and future integration testing of those lanes with Florida's Turnpike Enterprise. Mr. Tyler told CAC members that the express lanes provided an additional mobility choice for motorists. He noted toll amounts will be static to begin with and will be based on demand in the future. Mr. Tyler detailed express lane signage and tolling procedures, the outreach plan and response to incidents. Discussion ensued regarding all-electronic tolling, potential cost increases, entrance and exit points, travel time savings figures, toll lane cost controls, safety data, and project punch list.

Ms. Rakinya Hinson reported that the District 5 Five-Year Work Program Public Hearing was being held the week of October 25th with the open house scheduled October 28th at the District Office, 719 S. Woodland Blvd, DeLand. The Work Program Public Hearing was available online all week. Theo Webster requested that the Work Program information be sent to CAC members.

Mr. Jeff Piggrem commented that he would like to see funding reinvested in bicycle and pedestrian projects.

Mr. Tom O'Hanlon commented on the ability to remotely send fixes to Teslas and said that technology saves lives. He added that he could not support transportation internal combustion engines.

Mr. Keith Caskey, MetroPlan Orlando staff, requested the CAC to recommend that the FY 2021/22 - 2025/26 TIP be amended to include projects with funds that rolled forward from FY 2020/21 to FY 2021/22. A letter from FDOT explaining the amendment request was provided, along with the FDOT Roll Forward Report, a fact sheet prepared by MetroPlan Orlando staff and the draft resolution to be presented at the September 8th Board meeting. Mr. Caskey provided some background information on the amendment request. Mr. Jeff Piggrem asked about the SunRail efficiency funding that was not included in the roll forwards. Mr. Caskey deferred to FDOT/SunRail staff to respond. Mr. Mark Calvert responded that federal safety funds were used

on ongoing cleaning of machines and safety personnel through 2020. Mr. Piggrem added that the funds he was inquiring about were a specific grant in September 2020 of \$6 million for a second track in Osceola County. Mr. Calvert noted he will look into the status of that funding.

D. FDOT Amendment to FY 2021/22 - 2025/26 TIP

Mr. Keith Caskey, MetroPlan Orlando staff, requested the CAC to recommend that the FY 2021/22 - 2025/26 TIP be amended to include SunRail projects that had funds that rolled forward from FY 2020/21 to FY 2021/22. A letter from FDOT SunRail staff explaining the amendment request was provided, along with a fact sheet prepared by MetroPlan Orlando staff and the draft resolution to be presented at the September 8th Board meeting. Mr. Caskey reviewed background information on the amendment request.

VIII. PRESENTATIONS/STATUS REPORTS

A. Presentation on Public Opinion Survey Results

Ms. Cynthia Lambert, MetroPlan Orlando staff, gave a presentation on the results of MetroPlan Orlando's 2021 Public Opinion Survey. Ms. Lambert reviewed details of the survey and introduced Dr. Sara Vega from Summit Survey Research, who conducted the survey. Ms. Lambert reported that they surveyed 3,055 people through the month of May both online and in person. She noted that the survey was conducted in English and Spanish and CAC members were very supportive with community outreach, along with staff members Ms. Mary Ann Horne and Ms. Leilani Vaiaoga. Ms. Lambert provided survey results on topics including transportation funding, travel challenges, unsafe driver behavior, public transportation, equity in transportation, and technology. She called attention to a link to view the full report and contact information for any additional questions. Discussion ensued regarding vehicle-miles-traveled fee funding, response numbers overall and among the three counties, future dissemination and uses of survey information, and strategies for reducing the number of drivers who engage in unsafe behavior. Additional discussion ensued regarding inadequacy of gas tax funding, the future of self-driving vehicles, transit riders' access to jobs, lack of dedicated funding for transit, lack of knowledge of transit options in more remote areas such as Poinciana, and media reporting on self-driving vehicles' crashes and safety factors.

B. Presentation on Florida's Turnpike Widening PD&E Study

Ms. Jazlyn Heywood, Atkins, gave a presentation on the Project Development and Environment (PD&E) study for the widening project on Florida's Turnpike from SR 408 to SR 50. Ms. Heywood reviewed the study objective, limits, scope, and coordination efforts. She noted that the project had been split into three segments and she detailed a typical section. Ms. Heywood called attention to the interchanges that will be addressed in the study at SR 408, Sr 429, SR 50, Avalon Road and SR 50 (Oakland/Clermont). She provided information on the public outreach efforts, primary questions and comments received, and the study schedule. Discussion ensued regarding adding capacity, need for improvements, potential bottlenecks, addressing growth and development, managing rush hour congestion in the area, the number of lanes proposed, and the need for communication with residents in the area. Ms. Heywood noted that the project is not funded past the PD&E study.

The Florida Department of Transportation (FDOT) requests MetroPlan Orlando amend the Adopted 2045 MTP to accommodate changes to project as part of the I-4 Ultimate Program. Hicks Avenue (formerly Terry Avenue) Extension **FM# 432193-5** was first added to the I-4 Ultimate project in 2013 as requested by the City of Orlando. This project will help reconnect the Griffin Park Historic District, which had previously been surrounded by the SR 408 interchange ramps which separated it from neighboring communities and neighborhoods. This project is possible since the I-4 Ultimate project will remove the ramps and provide the opportunity to construct an extension of Hicks Avenue from Gore Street to Anderson Street with complete street features, including two roundabouts, bicycle and pedestrian facilities, drainage ponds, and the much needed and desired connection between neighborhoods. During 2020, FDOT worked closely with the City of Orlando as it planned and designed this project to achieve the goal of creating complete streets and enhancements to reconnect these neighborhoods and community which will support further residential development and continuity.

The project will be constructed as its own segment outside of the I-4 Ultimate Concessionaire Agreement and has gone through extensive public engagement and community outreach since 2015 when the City of Orlando developed the Parramore Comprehensive Neighborhood Plan. The project has received support from the Parramore Community Engagement Council and City Commissioner Regina Hill. A community outreach and education plan has been developed which includes a website containing videos, images, and handouts. A media release about the improvements has been planned in conjunction with the City of Orlando's community event. Community Open House dates are scheduled for December 7, 9, and 14, 2021. The City of Orlando will also participate in the outreach.

This letter and enclosures are to comply with Subsection 339.135(4)(c) 3 and (d), Florida Statutes, which require the Florida Department of Transportation (FDOT) to provide Metropolitan Planning Organizations (MPOs) with a written explanation for any project in the MPO's Transportation Improvement Program (TIP), which is proposed to be rescheduled or deleted for the common four years (Fiscal Year 2022/23 to Fiscal Year 2025/26) of the Department's Adopted and Tentative Work Programs. In addition, FDOT must provide justification for projects included in the TIP but not in the Department's Work Program, if applicable.

The MPO may request in writing that District Five Secretary Jared W. Perdue, P.E., consider changes to the Tentative Five-Year Work Program. The District Secretary is required to submit all such requests, along with the Tentative Five-Year Work Program, to the FDOT Secretary, Kevin J. Thibault, P.E., and the Florida Transportation Commission.

Board Meeting Highlights – November 10, 2021

- Chairwoman's Announcements: Chairwoman Viviana Janer opened the meeting at 9:00 a.m. Commissioner Bob Dallari, Seminole County, led the Pledge of Allegiance. She welcomed Mr. Tom Green, new Orlando Sanford Airport representative, and recognized Orange County Commissioner Nicole Wilson attending the meeting on behalf of Commissioner Gomez-Cordero. Chairwoman Janer gave Board members an overview of her attendance and participation in the November 3rd Blind American's Equality Day event held at Orlando City Hall. Chairwoman Janer announced that the Osceola County State of the County was held on October 6th. She thanked Commissioners Dallari and Uribe for attending the event. The new Osceola County logo was displayed. Commissioner Mayra Uribe reported on the October 28th Metropolitan Planning Organization Advisory Council (MPOAC) meeting. Commissioner Uribe gave perspective on her participation in the November 3rd Blind American's Equality Day event. Mayor Jerry Demings reported on the November 4th Central Florida Commuter Rail Commission (CFCRC) meeting. Commissioner Christine Moore reported on the October 8th Central Florida MPO Alliance (CFMPOA) meeting.
- MetroPlan Orlando Executive Director's Announcements: Mr. Gary Huttmann thanked Board members for their attendance and supporting the transition back to in-person meetings. He reported that MetroPlan Orlando staff participated in the Blind Americans Equality Day event on November 3rd, which was held in conjunction with FDOT Mobility Week. He thanked Commissioner's Janer, Uribe, and Zembower, and Mayor Dyer for their support and participation in the event. He thanked Orange County Commissioner Nicole Wilson for attending the meeting as the alternate to Commissioner Gomez-Cordero. Mr. Huttmann said that several members of MetroPlan Orlando's staff attended the WTS Annual Awards Banguet on September 30th. He thanked Commissioner Uribe for her participation in the event. He recognized MetroPlan Orlando staff member Sarah Larsen on being elected as the Director of Advancement for the Central Florida Chapter of WTS. He announced that the NARC Executive Director's conference and Board retreat was held September 26-28, and the AMPO Annual Meeting held October 5-8. He reported that he participated in the AMPO Policy Committee Meeting virtually. Mr. Huttmann reported on continued coordination efforts with FDOT Leadership and Work Program staff on stimulus funding. Mr. Huttmann informed Board Members that late on Friday, November 5, 2021, the US House of Representatives approved the \$1.2 trillion bipartisan infrastructure bill. He stated that the BIF, among other things, contains a full reauthorization of the federal surface transportation program (currently called the FAST Act). The President is expected to sign the bill into law soon. There is a lot to the Bill and more will be learned in the coming weeks. He noted that he will participate in an educational session on the Bill with the NARC team after today's Board meeting. Mr. Huttmann touched upon an email forwarded to Board members earlier in the week from Mr. Charles Small, from Intergovernmental Affairs with the Office of the US DOT Secretary, with highlights of the BID. He mentioned key elements of the Deal that is of particular interest to staff: safety, public transportation and rail, EV charging, roads, coordinating housing and transportation, and pilot programs to replace the gas tax. Mr. Huttmann reported that the FDOT on-line work program was held during the week of October 25-29. He mentioned that he attended the in-person hearing at the District Office on October 28. Mr. Huttmann informed that staff was not able to reach consensus on a date/time that worked for our Executive Committee members to meet and discuss legislative issues but that he and Ms. Virginia Whittington, Director of Regional Partnerships, did meet with each of the members individually to go over legislative items. He announced that the automated vehicle summit is scheduled in Orlando from November 29-December 1. He briefly reviewed the information placed in the supplemental folders, which included a corrected set of the September meeting minutes which did not properly reflect Board members that were physically in attendance.

LYNX and Regional Partners to Test Orlando International Airport to Downtown Orlando Zero Emission Trip

The Central Florida Regional Transportation Authority (LYNX) will operate a month long zero-emission pilot project utilizing electric buses between the region's largest airport, convention center and downtown Orlando.

The project will run Nov. 8-Dec. 4 using ABC Companies Van Hool electric bus motor coach with stops at Orlando International Airport, Sand Lake Road SunRail Station (weekdays only), Orange County Convention Center and Destination Parkway SuperStop. This route will operate as FASTLINK ZERO. Customers will be able to transfer to an electric Proterra bus on Link 38 at the Destination Parkway SuperStop and travel downtown to LYNX Central Station, where they can hop on an electric LYMMO Orange Line bus to the Orange County Administration Building or Orlando City Hall.

The project's focus will be to demonstrate the potential of an electric bus zero-emission trip that will enhance the passenger experience with more direct connections throughout the region. Currently, LYMMO buses began transitioning to an all-electric fleet in October 2020. The LYMMO fleet will be fully electric in mid-2022.

The FASTLINK ZERO route will not operate on Nov. 25, Thanksgiving Day.

Project partners are Orange County Government, City of Orlando, Orange County Convention Center, the Orlando Utilities Commission and the Central Florida Expressway Authority.

Subject: December 2021 Bicycle & Pedestrian Activity Update

City of Casselberry

Construction of pedestrian projects for Queens Mirror Circle and Quail Pond Circle is underway, with construction to be completed in early 2022. The Quail Pond Circle project features a new shared use path connection between Lake Concord Park and N. Sunset Drive. Queens Mirror Circle will receive speed feedback signs and RRFB's (rectangular rapid flashing beacons).

Construction of the Lake Kathryn Circle Complete Street Improvements project is anticipated to commence in early 2022. This local sales tax funded project will narrow the road to promote traffic calming and free up space for an eight foot wide sidewalk and landscaping improvements.

City of Longwood

Construction has begun on the Cross Seminole Trail Connector Project. The project includes shared lane markings and new sidewalk with some sections of shared use path to connect the Longwood SunRail station to Seminole County's Cross Seminole Trail on General Hutchinson Parkway. The project is approximately 2 miles long and runs along E. Church Ave. and N. Grant Street past the Longwood Candyland Park and Arbor Dog Park, then connects to Timocuan Way and the Cross Seminole Trail. The project cost is \$985,714 and will take about 9 months to complete.

Town of Oakland

The Town is completing a Complete Streets Design Plan for Oakland Avenue and Tubb Street that includes landscape, streetscape, sidewalks, crossings and roundabouts. Also, new, lower speed limits are to be established at 25 MPH for main streets, 20 MPH for local paved streets and 15 MPH for unpaved roads.

Osceola County

The pre-construction meeting for Fortune-Lakeshore Trail is scheduled for December 1, 2021. The construction is expected to last approximately 19 months.

The Kissimmee-St. Cloud Trail project is advancing to 100% plans.
