# JOINT BOARD MEETING HIGHLIGHTS TBARTA MPOS CCC BOARD & CFMPOA July 15, 2016

The Tampa Bay Area Regional Transportation Authority MPOs Chairs Coordinating Committee and Central Florida MPO Alliance hold an annual meeting, open to the public, amongst board members and staff. On July 15, 2016 both groups held individual business meetings in the morning followed by a joint meeting in the afternoon.

#### I. TBARTA MPOs CCC and CFMPOA Joint Meeting Highlights

1. Keynote Address

Jacob Stewart, Executive Director of the Central Florida Partnership, and Rick Homans, Executive Director of the Tampa Bay Partnership, partook in a discussion moderated by Harry Barley, Executive Director of MetroPlan Orlando. The keynote speakers focused on the role of transportation and its effects on economic development and the business community. The Super Region of Tampa Bay and Central Florida is home to over 8 million residents, across 14 counties, and represents the 10<sup>th</sup> largest economic region in the United States. This Super Region is projected to grow by an additional 4 million residents by 2030. The overriding theme of the discussion was the need to eliminate jurisdictional and county lines while continuing to work together on regional transportation solutions.

- 2. <u>Resolution of Support Identity & Wayfinding Signage for the Coast-to-Coast Connector</u> The joint board voted to support the identity and wayfinding signage along the Coast-to-Coast (C2C) Connector; this statewide multi-use trail, when complete, will traverse over 220 miles from the Atlantic Ocean (Titusville), through Central Florida (Orlando), to the Gulf of Mexico (Pinellas County). The consistent wayfinding signage would allow for local identity to be preserved while providing trail users with an overriding theme. Brian Smith, Chair of the Florida Greenways & Trails Council, and Brian Ruscher, Staff member of the Office of Greenways & Trails, presented this item. The Resolution of Support was signed by Kathy Meehan, Chair of the CFMPOA, and Lance A. Smith, Chair of the TBARTA MPOs CCC Board.
- 3. <u>I-4 Ultimate and Beyond the Ultimate</u> Noranne Downs, FDOT District 5 Secretary, presented on the project to redesign I-4 throughout Orlando to improve connectivity throughout the Central Florida region. The Public Private Partnership seeks to provide capacity improvements sooner than traditional pay-as-you-go, eliminate project phasing, capitalize on private sector innovation and access to capital, transfer appropriate risk, and enhance long-term, lifecycle cost efficiency and service quality. The Express Lanes are expected to be in full operation by 2021.
- 4. I-75 Relief Task Force Update

Ray Chiaramonte is a member of the I-75 Relief Task Force and provided an update and presentation. The purpose of the task force is to provide consensus recommendations on maximizing existing and developing high-capacity transportation corridors to serve the broad study area from Tampa to Jacksonville, with initial emphasis along and to the area

west of I-75. The two overarching goals are to provide relief to I-75 and to improve regional connectivity between Tampa Bay, North Central Florida, and Northeast Florida. Early work indicates separating I-75 traffic north of Gainesville would reduce passenger and freight vehicles distance by over 50 miles and alleviate congestion along I-75.

5. <u>Regional Multi-Use Trails</u>

Michael Case, Senior Planner of TBARTA, further elaborated on the statewide network of multi-use trails and the effort undertaken by TBARTA staff and regional stakeholders in connecting to and expanding the network. A standing committee since 1995, the TBARAT MPOS CCC Regional Multi-Use Trail Committee meets monthly to identify and update regionally significant trails that close gaps and serve destinations throughout West Central Florida. Regional multi-use trails should create functional linkages among the region's major attractors and activity centers and the many population centers found within the area. The Southwest Coastal Regional Trail was prioritized as the states #3 trail priority corridor, and when complete, would connect to the C2C in Pinellas County, and head south along the Gulf Coast to through Tampa, Bradenton, Sarasota, Ft. Myers, and Naples. This would represent the nation's largest network of locally connected trails.

6. Beach Accessibility

Florida's world class beaches have local, regional, and state-wide effects on residents, tourism, economic development, land use, and transportation. Whit Blanton provided a presentation on the initiatives within Pinellas County as it pertains to beach accessibility and various modes of transportation.

#### JOINT RESOLUTION 2017-01

#### A RESOLUTION BY THE CENTRAL FLORIDA MPO ALLIANCE AND TAMPA BAY AREA REGIONAL TRANSPORTATION AUTHORITY MPOS CHAIRS COORDINATING COMMITTEE SUPPORTING THE PROPOSED STATEWIDE TRAIL ALIGNMENTS AND CONTINUED COORDINATION FOR FLORIDA'S COAST-TO-COAST TRAIL, ST. JOHNS RIVER-TO-SEA LOOP, AND FLORIDA'S GULF COAST TRAIL

WHEREAS, the Central Florida MPO Alliance (CFMPOA) and the Tampa Bay Area Regional Transportation Authority MPOs Chairs Coordinating Committee (TBARTA MPOs CCC) collectively comprise 12 metropolitan planning organizations and transportation planning organizations encompassing 18 counties in the Central Florida superregion; and

**WHEREAS,** the goal of the annual joint meeting of the CFMPOA and the TBARTA MPOs CCC is to promote and coordinate regionally-significant, multimodal transportation improvements across the superregion; and

**WHEREAS,** the Shared-Use Nonmotorized Trail Network will create a statewide system of greenways and trails, supports economic development, increased tourism, provides health benefits, improved transportation, quality recreation and greater conservation for Floridians and Visitors alike; and

**WHEREAS,** the Florida Department of Environmental Protection's Office of Greenways and Trails is updating the Florida Greenways and Trails System Plan for 2018-2022 and the Florida Greenways and Trails Council will approve modifications to regional trail corridors along the Florida Greenways and Trails System Plan in the Fall of 2017; and

**WHEREAS,** the CFMPOA and TBARTA MPOs CCC by adoption of Joint Resolution No. 2013-01 supported the implementation of Florida's Coast-to-Coast Connector (C2C) Project, requested the allocation of funds by the Florida Department of Transportation and pledged the assistance of member MPOs and TPOs to close the existing gaps in the Connector; and

WHEREAS, the western portion of the C2C connects to Florida's Gulf Coast Trail (GCT) and the eastern portion of the C2C connects to the St. John's River-to-Sea Loop (SJR2C); and when complete, these three corridors will be over 750-miles of local networks along a regional and statewide multi-use trail system from Titusville to Naples connecting Central and Southwest Florida; and

WHEREAS, the C2C, SJRSL, and GCT represents projects for all types of trail users ranging from hikers, bicyclists to equestrians, and includes connections to natural areas with paddling opportunities; and

**WHEREAS,** the 2014 C2C Summit brought together 150 participants and the 2016 Gulf Coast Regional Trail Summit brought together 200 participants to build upon local, regional, and statewide leadership in the public and private sectors, resolve local issues, and identify opportunities for collaboration; and

**WHEREAS,** the Florida Greenways and Trails Council recommended that the Florida Department of Environmental Protection and FDOT prioritize the C2C as Florida's first priority regional trail system, the SJR2C as Florida's next priority regional trail system, and the GCT as Florida's third priority regional trail system following completion of the C2C, for FDOT's Shared-use Nonmotorized (SUN) Trail Program;

#### NOW, THEREFORE, BE RESOLVED THAT THE CENTRAL FLORIDA MPO ALLIANCE AND TAMPA BAY AREA REGIONAL TRANSPORTATION AUTHORITY MPOS CHAIRS COORDINATING COMMITTEE JOINTLY:

- Support regional trail identity of the Florida's Coast-to-Coast Trail, St. John's River-to-Sea Loop, and Florida's Gulf Coast Trail while maintaining local trail identity and unique community characteristics in each City and County;
- Endorse current and proposed corridor alignments of the Florida's Coast-to-Coast Trail, St. John's River-to-Sea Loop, and Florida's Gulf Coast Trail for approval by the Florida Greenways and Trails Council;
- Support the continued role of the Coast-to-Coast Leadership Team, partners supporting the St. John's River-to-Sea Loop, and the Gulf Coast Trail Alliance, in collaborating on investment and promotional opportunities for this important statewide network.
