#### We've Moved to A New Location!

MetroPlan Orlando has completed its move to the second floor of the Park Building, on Orange Avenue, adjacent to the SunTrust Tower in downtown Orlando. #### **US DOT Beyond Traffic**

In October 2015, MetroPlan Orlando in cooperation with Orlando Mayor Buddy Dyer and our partners at the Central Florida Partnership hosted people from across the state as they packed the DeVos Family Room at Dr. Phillips Center for the Performing Arts for the USDOT Beyond Traffic forum. The day's events included a panel discussion from community leaders, group sessions on Beyond Traffic trends and an address from Federal Highway Administration leader Greg Nadeau. Participants also were able to send messages about transportation needs and ideas directly to US DOT Secretary Anthony Foxx.

#### MetroPlan Orlando LRTP (Re)Adoption

The MetroPlan Orlando Board approved re-adoption its 2040 Long Range Transportation Plan. Shortly after the MetroPlan Orlando board adopted the plan in June 2014 staff began discussions with the Federal Highway Administration on the steps necessary to get on the same schedule as the other M/TPOs in District Five.

#### **Health Impact Assessment**

The MetroPlan Orlando Health Impact Assessment for the proposed SR 50 Bus Rapid Transit System has been completed. Since its completion it has been presented at the Florida APA Conference, RailVolution in Dallas, and the TRB Annual meeting in Washington D.C.

#### ITS Master Plan

MetroPlan Orlando is embarking on an Intelligent Transportation System (ITS) Master Plan. This master plan will evaluate the current systems in the planning area, determine future needs and formulate an implementation strategy for the future deployment and maintenance of the ITS. It will ensure conformity with federal and state requirements, account for emerging technologies in vehicles and devices used in transportation infrastructure and communication systems. Since the MetroPlan Orlando area includes Orange, Osceola and Seminole Counties, the master plan will assess these counties and the municipalities in these counties; conduct a similar evaluation for each of the modal agencies in the planning area; and provide a master plan that is coordinated, integrated and interoperable. MetroPlan Orlando contracted with consultant Gannett-Fleming to complete the master plan.

#### Work Zone Impact Strategy Estimator (WISE)

MetroPlan Orlando received a grant in the amount of \$250,000 from the FHWA Strategic Highway Research Program 2 to pilot test the Work Zone Impact Strategy Estimator (WISE) software. In practice, WISE is a decision support system for use by planners and engineers to help them evaluate the traffic impacts of work zones to better schedule/sequence a set or program of projects and determine other strategies to reduce the overall impacts. WISE has the capability to evaluate the regional impact of various strategies such as day/night operations, accelerated construction techniques, and traveler/community information campaigns. MetroPlan Orlando is partnered with the University of Central Florida and Calipers Corporation for technical assistance on conducting the test.

#### DELEGATION REPORT January 2016

#### 2040 Long Range Transportation Plan

Adopted LRTP November 24, 2015. Preparing final documentation for publication and submittal to FDOT and FHWA. Latest information available at www.PlanOcalaMarion.com.

#### Urban Cycling Plan

Additional work identified as part of the 2035 Bicycle/Pedestrian Master Plan. Urban Cycling Plan will identify a core network of streets in select areas to improve pavement markings and signage for cyclists to access work and shopping areas. Plan is in response to lack of available right-of-way on major corridors for bicycle facilities and to provide safe, well connected cycling opportunities.

#### SR 40-Silver Springs Corridor Plan

Held second public meeting to present concepts and potential typical sections. Concept plan includes a double roundabout at the intersection of SR 40 and SR 35. Marion County recently approved a Community Redevelopment Area (CRA) plan for the area and DEP is developing a long-term plan for the Silver Springs State Park. These changes are anticipated to dramatically alter the area and provide unique opportunities to develop a more mixed-use environment. Plan focuses on improving multimodal facilities along the corridor with special focus on pedestrian and bicycling connectivity to Silver Springs State Park.

#### Comprehensive Operations Analysis (COA) – SunTran

The COA reviewed SunTran at an operations level to identify improvements in route efficiency, headways and peak service needs. Data generated by ITS equipment installed earlier this year will be utilized in the development of the analysis. Staff is currently reviewing recommendations.

#### US 441 - City of Belleview Corridor Plan

Initiated the development of corridor improvements plan for a 1.5 mile section of US 441 in the City of Belleview. The plan will review traffic safety and operations as well as enhancements to the pedestrian environment and aesthetic improvements along the corridor. Initial public involvement sessions held in June. Currently awaiting safety analysis on critical intersections.

#### Bicycle/Pedestrian Safety Review

Work will review high-crash locations for both bicycle and pedestrian crashes and identify potential safety improvements.



#### **Polk TPO Report**

"Momentum 2040" - 2040 Long Range Transportation Plan Update – The TPO Board adopted the 2040 Long Range Transportation Plan at a public hearing on December 10, 2015.

<u>Transportation Management Area (TMA) Certification</u> – The Federal Highway Administration and Federal Transit Administration are completing its certification of the Polk TPO, the first TMA Certification for Polk. The site visit and public meeting were held in September, the certification results will be presented at the February TPO Board Meeting.

<u>Evaluation of Potential Rail Quiet Zones</u> – The TPO approved a consultant services authorization for the evaluation of potential rail quiet zones in Polk County. The project consultant (AECOM, Inc.) will evaluate candidate quiet zone locations along the CSX 'S' Line as part of the initial study phase. A later phase will evaluate other rail lines in Polk.

<u>Complete Street Corridor Feasibility Studies</u> – The TPO is currently evaluating eight separate corridors for the implementation of complete street improvements. The project consultant (Kimley-Horn and Associates) has identified recommended complete street treatments for each corridor. The recommended improvements are being reviewed by stakeholders prior to the development of an action plan for each corridor. Project completion is slated for June 30, 2015.

<u>Pedestrian and Bicycle Safety Action Plans</u> – The TPO is preparing separate Pedestrian and Bicycle Safety Action Plans to identify education, enforcement and engineering solutions to improve safety. The project consultant (Sprinkle Consulting) has completed a comprehensive crash analysis and identified the most frequent crash types. Development of the action plans is underway. Project completion is slated for June 30, 2015.

#### January 15, 2016 DELEGATION REPORT

#### • 2040 LRTP Cost Feasible Plan Adoption

Over the past two years, TPO and committee members, staff, local agency partners and the public have dedicated considerable time and resources to defining a community vision for 2060 on which the 2040 Plan is based. The Plan addresses features such as economic prosperity and environmental quality that were not addressed in prior plans. Effective transportation is essential to economic prosperity. This Plan builds upon the rich transportation resources of the area as a means of enhancing economic prosperity.

#### • ITS Master Plan Adoption

The SCTPO's development of the ITS Master Plan was a coordinated effort with stakeholders from local agencies and FDOT staff. The Master Plan evaluates the applicability of various ITS programs, recommends targeted expansion of the ATMS and other ITS programs currently in place and provides recommendations for operating and maintaining the system.

#### • 2014 Countywide Safety Report - High Crash Corridor Analysis

In addition to conducting focused analysis on high crash corridors for vulnerable road users, the SCTPO is analyzing those corridors that ranked highest in overall crashes and severity, and would include all crash types. Field audits are being conducted and countermeasures will be developed specific for each corridor. Improvements will be categorized as short-term (maintenance activity), mid-term (can be included in an upcoming improvement project) and long term improvements (need to be added to work program).

#### • Space Coast Pathways Project

The SCTPO is developing an interactive guide to Brevard's trails, waterways, sidewalks, bike lanes and unique outdoor adventures. The project is in response to a long recognized need for greater access to Pathways information. An expansion of the Bicycle & Pedestrian Mobility Plan, the pathways guide will foster local partnerships, encourage public involvement, and highlight needs for future bicycle and pedestrian facilities.



## River to Sea TPO's Delegation Report to the Central Florida MPO Alliance January 2016

#### Planning Projects - Underway and Upcoming

- Volusia Systems Connector Study Parsons Brinkerhoff is finalizing a study of potential enhanced transit connections between SunRail service and the Daytona Beach area. The limits of the project area spans from SR 46 in Seminole County to US 1 in Daytona Beach. The project team is set to present final alternatives and potential next steps in February 2016.
- SR A1A Pedestrian Safety and Mobility Study The R2CTPO is utilizing Kittleson & Associates to complete a pedestrian mobility and safety study for SR A1A throughout the entire planning area boundary (including CR A1A). The effort will include detailed field review for six locations to produce detailed recommendations for improvements to the corridor. ECD is June 2016.
- <u>US 17/92 Corridor Improvement Plan, Phase II</u> The R2CTPO is utilizing Tindale Oliver and Associates complete the second phase of evaluation for this major north-south corridor serving west Volusia County. The goal of the CIP is to identify improvements needed to improve mobility and safety along the corridor and ensure it serves the needs and goals of surrounding communities. ECD is May 2016.
- Transportation Impact Analysis (TIA) Guidelines Update In November 2009, the R2CTPO adopted the TIA Guidelines to provide a standardized methodology for assessing the impacts of new development on the transportation system. The guidelines were developed with input from public and private sector practitioners and it's provided a useful tool in standardizing data resources and methods used to evaluate the impacts of development. Expansion of the planning area boundary along with an increasing emphasis on transit requires the guidelines be updated. Work is underway and a draft is expected in February 2016.
- <u>Transit Development Guidelines</u> Transit planning funds are being utilized by Votran to update the
  Transit Design Guidelines (TDG). These guidelines provide guidance for development throughout
  Volusia County and its jurisdictions to ensure that site planning activities encompass design features
  appropriate for transit.
- <u>Intelligent Technology System (ITS) Planning</u> Over the years, ITS has been deployed through throughout the R2CTPO planning area. The R2CTPO is beginning an effort to develop a coordinated masterplan to continue the deployment of ITS and maximize the benefits of these investments.

**2040 Long Range Transportation Plan (LRTP)** -- Staff is reaching completion of the final documentation for the 2040 LRTP. Regional modeling outputs will be added when provided by FDOT. Project information and updates can be found at www.r2cmobilty2040.org

#### B. FDOT District Reports

Ms. Jennifer Stults, FDOT District I, reported that all segments of the Central Polk Parkway are in design and plans are 30% complete. She noted that section eight which connects to I-4 is in the PD&E stage. Ms. Stults told CFMPOA members that District 1 is working on raising and replacing bridges on CR 559 and CR 557 in order to offer more options for I-4 expansion. In addition, the CSX rail bridge over I-4 will be going to design later in 2015. I-4 resurfacing, she reported, is underway from CR 557 to the Osceola County line. Ms. Stults added that US 27 from Barry Road to US 192 is undergoing widening to six lanes with the entire expanse of US 27 from SR 60 to US 192 expected to be six-laned with drainage, signage and sidewalk work underway as well. She informed members that the Poinciana Parkway section in Polk County is undergoing muck removal, which is expected to be completed in July. Ms. Stults provided an update on the formation of the Heartland TPO. She told CFMPOA members that a formation meeting was held in April, the TPO adopted their UPWP, their Public Participation Plan has been posted for comment, and they are in the process of appointing a Technical Advisory Committee. Expectations are, she noted, that Heartland TPO representatives will begin attending CFMPOA meetings in the near future.

Secretary Billy Hattaway, FDOT District I, added that FDOT adopted a complete streets policy in September 2014 and he is the champion for that program statewide. He asked that CFMPOA members and staff call him if they need any help in implementing the new policy. Secretary Hattaway told committee members that plans are to hold focus group meetings with a draft technical memo available in August 2015 and a complete implementation plan projected to be completed by the fall of 2015. He noted that there will be significant changes in street design, especially in downtown areas.

Mr. Frank O'Dea, FDOT District V, reported that the first section of the Wekiva Parkway in Lake County is expected to be open in 2016. Central Florida Expressway Authority, he noted, has been able to advance two Orange County sections of the Wekiva Parkway through TIFIA loans, however, FDOT has not been able to advance any of their sections. Mr. O'Dea informed CFMPOA members that the I-4 Ultimate project is underway and work continues on planning for the southern extension, I-4 Beyond the Ultimate. He reported that PD&E on I-4 Beyond the Ultimate is expected to be completed this year and design has begun, in addition to looking at funding options for the project. Mr. O'Dea told committee members that SunRail celebrated its first anniversary in May. SunRail Phase II south, he reported, will go to construction in November 2015 and Phase II north is waiting on federal funding to move forward. Mr. O'Dea informed CFMPOA members that District V continues to work with the Space Coast TPO on the St. John Heritage Parkway and two major interchange projects are scheduled next year at I-95 and Ellis Road and I-95 and Palm Bay. The widening of I-95 to six-lanes, he reported, is on target to be completed throughout the state. He noted that I-75 on the west side of the region is also undergoing widening to six-lanes. He called attention to the Coast-to-Coast trail project, which is a focus for District V, and commented that two segments currently are lagging, one in Sumter County and one at the Space Coast. Mr. O'Dea commented that there are changes in the way FDOT is doing business as a result of the area being more urbanized. He told CFMPOA members that there is a shift in focus to institutionalize non-traditional capacity improvements, such as transportation systems management and operations and transit. FDOT, he reported, is currently working with LYNX and MetroPlan Orlando to advance Bus Rapid Transit projects such as the US 192 BRT. Work will begin on that project in the next few years. Some areas that need widening, he noted, will still be widened.

There was no representative from Florida's Turnpike Enterprise in attendance.

Mr. Harry Barley provided a brief report on FDOT Secretary Boxold's visit to MetroPlan Orlando for the July 8<sup>th</sup> board meeting. He told CFMPOA members that Secretary Boxold complimented CFMPOA members on the way they work together to advance projects and initiatives for the region. This collaborative effort was the reason Secretary Boxold felt the region was able to have so much currently underway. Mr. Barley reported that Secretary Boxold spoke about the controversy regarding construction of express lanes on a section of SR 417 and Florida's Turnpike Enterprise's new policy of adding express lanes to new capacity. He indicated that the department may be interested in negotiating a deal to trade pieces of local toll roads, so that a road would operate under one single tolling agency. Mr. Barley noted that the Central Florida Expressway Authority (CFX) was created through legislation last year and included multi-counties, which would lend itself to a more regional approach to toll roads. Commissioner Scott Boyd, who is a member of the CFX board, reported that there was positive discussion at the recent CFX board meeting regarding possible changes in road segment ownership. Mr. Bob Kamm called attention to SR 528 and the issues on that corridor in terms of various agencies owning segments. Commissioner Boyd responded that the CFX board also discussed SR 528 and the importance of roadway and rail connections on that corridor. Mr. Barley added that there has been some discussion regarding the addition of Brevard County to CFX, especially in light of the East Central Florida Corridor Task Force recommendations. Commissioner Boyd noted that there had been positive feedback from CFX board members regarding adding Brevard.

#### A. Approval of Previous Meeting Minutes

Action was requested for approval of the April 10, 2015 Central Florida MPO Alliance meeting minutes.

MOTION: Mayor Pro-Tem Ray Goodgame moved approval of the April 10, 2015 meeting minutes. Commissioner Carl Zalak seconded the motion; which carried unanimously.

#### B. CFMPOA Priority Project List

Now entering the third year of a regional prioritization process, the CFMPOA was asked to approve a draft Regional List of Priority Projects. The draft was an update of last year's document with adjustments based on completion of phases or programming of funds for forthcoming phases. The regional list addressed priorities in three categories: Strategic Intermodal System projects, Regional Trail projects (with the Coast to Coast Connector an established priority), and Regional Transit projects.

As directed by the Alliance, staff met to review and revise the list, which currently included the five MPOs in FDOT District 5. Polk County projects are not included at this time, but could be added at the request of the Polk TPO. Approval of the CFMPOA Priority Project list was requested. Mr. T J Fish. Lake Sumter MPO, told CFMPOA members that the trail list had quite a few revisions due to phases that are now funded. He noted that the trail funding has gained a lot of momentum as a result of efforts on the part of CFMPOA and there is talk beginning in regards to moving forward other major trails, such as the Heart of Florida Loop. A number of CFMPOA member agencies indicated that their M/TPO had already approved the priority lists. Mr. O'Dea commented that the priority lists are beneficial to FDOT since they let FDOT know what the regional priorities are, that are supported. FDOT, he noted, will keep using the lists to advance projects in cooperation with the M/TPOs. Mr. Dale Allen, Florida Greenways and Trails Foundation, thanked CFMPOA members for their efforts in moving forward the Coast-to-Coast Trail and noted that their efforts have served as an inspiration to the rest of the state.

**MOTION:** Mayor Kathy Meehan moved approval of the CFMPOA Regional List of Priority Projects. Mayor Pro-Tem Ray Goodgame seconded the motion; which carried unanimously.

#### VII. Other Business

#### A. Regional Transit and Rail Plan

At the January Alliance meeting, Ms. Huiwei Shen, Florida Department of Transportation, summarized the findings and recommendations from the work of the East Central Florida Corridor Task Force. This was the first pilot project to be completed as part of FDOT's New Corridors program. In April, Ms. Brenda Young, FDOT District 5, specifically highlighted Task Force Recommendation #5 'To develop a regional passenger rail and transit system plan' as it related to the statewide perspective for regional passenger connectivity. The Alliance requested that a resolution in support of the recommendation be drafted for approval. Resolution No. 2015-01 was provided. Mr. Bob Kamm provided some background on the East Central

Florida Corridors task force and noted that the CFMPOA has been tasked with working with FDOT to develop a regional mobility plan. He added that in addition to formulating a regional mobility plan, thought must also go into how to fund that plan. Mr. Kamm commented that the Tampa Bay area just developed a regional mobility plan and if their plan could be joined up with the one developed by the Alliance, there would be a comprehensive, boundary neutral plan for the entire Central Florida region. Mayor Pro-Tem Goodgame commented that with projected growth in the area, there was not sufficient roads or funding to support that growth.

MOTION: Mayor Kathy Meehan moved approval of the resolution in support of the East Central Florida Corridor Task Force recommendation to develop a regional passenger rail and transit system plan. Commissioner Scott Boyd seconded the motion; which carried unanimously.

Mr. Bob Kamm commented that TBARTA has a presentation slated at the joint meeting on their regional mobility plan. He asked CFMPOA members to keep in mind what had been discussed regarding a regional mobility plan at the Alliance meeting, when that presentation is given.

Mr. Harry Barley, MetroPlan Orlando, commented that the population of Florida has doubled since 1990. The forecast was for future population growth of 50-75%. He questioned whether the state was ready for the growth and although Florida was better off than some other states in terms of funding, funding would still be inadequate to address all the needs.

### 2016 Legislative Session Transportation Priorities

#### Safety

#### **Bicycle and Pedestrian Safety**

Support legislation that increases funding to improve bicycle and pedestrian safety awareness programs, facility improvements, and seeks to reduce bicycle and pedestrian injuries and fatalities statewide. This includes support for reexamining current legislation to strengthen laws to protect bicyclists and pedestrians.

#### Strengthen Ban on Use of Hand-held Electronic Devices While Driving

Support legislation that reduces distracted driving by regulating as a primary offense the use of electronic wireless communications devices and other similar distracting devices while operating a motor vehicle.

Currently a secondary offense, the use of electronic wireless devices while driving leads to distracted drivers who may be manually texting, emailing, messaging, or utilizing the device without the hands-free feature. Bills increasing the penalty have been introduced in 2014 and 2015. The strengthening of the 2013 "Florida Ban on Texting While Driving Law" by establishing the violation as a primary offense would lead to stronger enforcement.

#### **Funding**

## Support Continued Funding for the Central Florida Coast-to-Coast Trail and Other Regional Trail Projects such as the Heart of Florida Loop

The development of the Coast to Coast Connector, the Heart of Florida Loop and other trails of statewide significance will provide an international attraction for ecotourism. Great momentum is underway in the closing of gaps in the Coast to Coast Trail between existing trails from Brevard County to Pinellas County. The CFMPOA supports the continuation of funding for regional multi-use trails and the allocation of a portion of funds generated from Amendment 1 to trail development and maintenance which would allow local agencies to expand and sustain these vital regional assets.

### Enhance and Protect the State Transportation Trust Fund and Transportation Disadvantaged Trust Fund

In addition to revenues generated by transportation-related surcharges already directed outside the Transportation Trust Fund, millions of transportation dollars have been diverted from the Transportation Trust Fund for other purposes. Overall, such diversions and lost revenues degrade the state's infrastructure

and impact Central Florida's competitiveness for federal discretionary funding. Likewise, negative impacts to the Transportation Disadvantaged Trust Fund should also be discouraged.

### Amend Charter County and Regional Transportation System Surtax to Make Eligible to all Counties with an MPO

The current legislation allows a surtax to be taken before voters as a referendum to fund transportation projects through an up to one percent consumption tax. The law has evolved through the last 25 years to now be eligible to all charter counties, as well as to any non-charter county that is part of a Regional Transportation Authority. The transportation surtax is an appropriate referendum option for urban counties and therefore should be extended to all counties served by a metropolitan planning organization in order to provide funding for cost-feasible transportation plans.

#### The CFMPOA will support legislation that:

- Restores funding for the Transportation Regional Incentive Program (TRIP) to promote regional planning and project development.
- Authorizes a local option rental car surcharge (implemented through a public referendum) with proceeds committed to regional transportation projects.
- Preserves transportation funding and provides greater flexibility of funding options at the state and local level that support the transportation system.
- Allows up to a one-cent municipal option sales tax for cities with population in excess of 150,000 (or the largest municipality in a county).
- Allows for indexing of local option fuel taxes to CPI, consistent with indexing allowed for state fuel taxes.
- Allows Strategic Intermodal System (SIS) funds to be used on roads and other transportation facilities not designated on the SIS if the improvements will relieve congestion on the SIS.
- Preserves the existing coordinated system for paratransit service.
- Advances Florida's Comprehensive, Statewide Rail System Plan.
- Continues investments in Space Transportation Infrastructure.
- Prohibits additional increases in federal truck weight limits in the State of Florida.

- Seeks to alter or repeal Red Light Camera Enforcement legislation.
- Legislation on Developments of Regional Impact (DRIs)

## The Fixing America's Surface Transportation Act or "FAST Act"

On December 4, 2015, President Obama signed into law the Fixing America's Surface Transportation Act, or "FAST Act." It is the first law enacted in over ten years that provides long-term funding certainty for surface transportation, meaning States and local governments can move forward with critical transportation projects, like new highways and transit lines, with the confidence that they will have a Federal partner over the long term. Secretary Foxx and his team at U.S. DOT have worked tirelessly to advocate for a long term bill, underscoring the needed sense of urgency to the American people.

As Secretary Foxx said, "After hundreds of Congressional meetings, two bus tours, visits to 43 states, and so much uncertainty – and 36 short term extensions – it has been a long and bumpy ride to a long-term transportation bill. It's not perfect, and there is still more left to do, but it reflects a bipartisan compromise I always knew was possible."

Overall, the FAST Act largely maintains current program structures and funding shares between highways and transit. It is a down-payment for building a 21st century transportation system, increasing funding by 11 percent over five years. This is far short of the amount needed to reduce congestion on our roads and meet the increasing demands on our transportation systems. In comparison, the Administration's proposal, the GROW AMERICA Act, increases funding by 45 percent.

The law also makes changes and reforms to many Federal transportation programs, including streamlining the approval processes for new transportation projects, providing new safety tools, and establishing new programs to advance critical freight projects.

Below is a more detailed summary of some FAST Act provisions. More detailed descriptions of how the FAST Act will affect each mode of transportation will be released in the coming weeks.

**PROJECT DELIVERY:** DOT has been a leader in reducing the bureaucratic red tape that can stall and delay critical transportation projects from moving forward. The FAST Act adopted a number of Administration proposals to further speed the permitting processes while still protecting environmental and historic treasures and also codifying the online system to track projects and interagency coordination processes.

**FREIGHT**: The FAST Act would establish both formula and discretionary grant programs to fund critical transportation projects that would benefit freight movements. These programs are back >

similar to what the Administration proposed and will for the first time provide a dedicated source of Federal funding for freight projects, including multimodal projects. The Act emphasizes the importance of Federal coordination to focus local governments on the needs of freight transportation providers.

INNOVATIVE FINANCE BUREAU: The FAST Act establishes a new National Surface Transportation and Innovative Finance Bureau within the Department to serve as a one-stop shop for state and local governments to receive federal funding, financing or technical assistance. This builds on the work of the Department's Build America Transportation Investment Center and provides additional tools to improve coordination across the Department to promote innovative finance mechanisms. The Bureau is also tasked with responsibility to drive efficiency in the permitting process, consistent with our request to establish a dedicated permitting office.

**TIFIA:** The TIFIA Loan program provides important financing options for large projects and public-private partnerships. The FAST Act includes organizational changes that will provide an opportunity for important structural improvements with the potential to accelerate the delivery of innovative finance projects. However, FAST's cut to the TIFIA program could constrain growth in this area over the course of the bill.

**SAFETY:** The FAST Act includes authority sought by the Administration to prohibit rental car companies from knowingly renting vehicles that are subject to safety recalls. It also increased maximum fines against non-compliant auto manufactures from \$35 million to \$105 million. The law also will help bolster the Department's safety oversight of transit agencies and also streamlines the Federal truck and bus safety grant programs, giving more flexibility to States to improve safety in these areas. However, we know the bill also took a number of steps backwards in terms of the Department's ability to share data with the public and on the Department's ability to exercise aggressive oversight over our regulated industries.

**TRANSIT:** The FAST Act includes a number of positive provisions, including reinstating the popular bus discretionary grant program and strengthening the Buy America requirements that promote domestic manufacturing through vehicle and track purchases.

LADDERS OF OPPORTUNITY: The Act includes a number of items that strengthen workforce training and improve regional planning. These include allocating slightly more formula funds to local decision makers and providing planners with additional design flexibilities. Notably, FAST makes Transit Oriented Development (TOD) expenses eligible for funding under highway and rail credit programs. TOD promotes dense commercial and residential development near transit hubs in an effort to shore up transit ridership and promote walkable, sustainable land use.

#### RESOLUTION OF THE LAKE~SUMTER METROPOLITAN PLANNING ORGANIZATION ENDORSING AND APPROVING THE REGIONAL LIST OF PRIORITY PROJECTS APPROVED BY THE CENTRAL FLORIDA MPO ALLIANCE

WHEREAS, the Lake~Sumter Metropolitan Planning Organization (MPO) is the duly designated and constituted body responsible for carrying out the urban transportation planning and programming process for the Lake~Sumter Planning Area; and

WHEREAS, Florida Statutes 339.175; 23 U.S.C. 134; and 49 U.S.C. 5303 require that the urbanized area, as a condition for the receipt of federal capital or operating assistance, has a continuing, cooperative, and comprehensive transportation planning process that results in plans and programs consistent with the comprehensively planned development of the urbanized area; and

WHEREAS, Florida Statutes 339.175(8)(a) requires that the MPO is responsible for developing, annually, a list of project priorities ranking the transportation needs of the MPO area; and

WHEREAS, the Lake~Sumter MPO, by interlocal agreement, is a member of the Central Florida MPO Alliance, which includes the Ocala/Marion County Transportation Planning Organization (TPO), the River to Sea TPO, the Space Coast TPO, MetroPlan Orlando, and the Polk County TPO; and

WHEREAS, on April 12, 2013, the Central Florida MPO Alliance took action to approve a process through which a Regional List of Priority Projects would be developed, with the regional document addressing priorities for three funding categories: (1) Strategic Intermodal System projects, (2) regional trail projects and (3) regional transit projects; and

WHEREAS, on September 25, 2013, the Lake~Sumter MPO formally supported the first-ever Regional List of Priority Projects and on October 11, 2013, the Central Florida MPO Alliance ratified the first-ever Regional List of Priority Projects; and

WHEREAS, on July 10, 2015, the Central Florida MPO Alliance approved an updated Regional List of Priority Projects; and

WHEREAS, the Central Florida MPO Alliance Regional List of Priority Projects is consistent with the Lake~Sumter MPO List of Priority Projects; and

WHEREAS, the FDOT has agreed to utilize the regional list as a guide to programming state and federal funds; and

WHEREAS, each MPO of the Central Florida MPO Alliance has been requested to take action to endorse and approve the Regional List of Priority Projects.

**NOW, THEREFORE, BE IT RESOLVED** by the Lake~Sumter MPO:

The Central Florida MPO Alliance Regional List of Priority Projects, attached as Exhibit A, is hereby endorsed and supported.

#### **RESOLUTION #2015-01**

#### In Support of the Development of a Central Florida Regional Mobility Plan

- WHEREAS, the Central Florida MPO Alliance brings together six metropolitan planning organizations in Central Florida and is seen as a model for regional cooperation throughout the State of Florida; and
- WHEREAS, the Central Florida MPO Alliance collectively recognizes the importance of the development of a comprehensive multi-modal transportation system to provide for travel demands now and into the future; and
- WHEREAS, the Central Florida MPO Alliance collectively supports alternative forms of passenger transportation being provided at the local, regional and statewide level to provide for a sustainable future for the State of Florida; and
- WHEREAS, Governor Rick Scott signed Executive Order 13-319 on November 1, 2013 creating the East Central Florida Corridor Task Force ("the Task Force") to evaluate and develop consensus recommendations on future transportation corridors serving established and emerging economic activity centers in portions of Brevard, Orange, and Osceola counties.
- WHEREAS, the resulting report identified limited options for both east-west and north-south travel which raise concerns about the region's ability to achieve economic opportunities and to support the planned development of new population centers; and
- WHEREAS, there are no transit connections between these centers today, and no high-capacity transit is currently planned; and
- WHEREAS, the Task Force recommended nine corridor alternatives for further study, five of which primarily involve multimodal improvements to existing corridors; and
- WHEREAS, the Task Force recommends two potential study areas for new or significantly upgraded east-west corridors and two potential study areas for new north-south corridors, each of which are to be evaluated for multimodal options; and

- WHEREAS, the Task Force recommended a proposed nine-point action plan for further study of existing and new transportation corridors in the study area which includes improvements to the five existing corridors; initiation of evaluation studies as part of FDOT's Future Corridor Planning Process for the four potential new corridor study areas; amendments to regional and local transportation and land use plans to reflect the corridors and study areas; and additional enhancements to the planning process; and
- WHEREAS, the Central Florida MPO Alliance has received briefings on the work of the East Central Florida Corridors Task Force and is supportive of its recommendations; and
- WHEREAS, Recommendation number five of the nine-point action plan is to "Develop a regional transit system plan to identify and set priorities for long-term transit investments in the three study area counties and the broader Central Florida region;" and
- WHEREAS, the Central Florida MPO Alliance recognizes the broader Central Florida region as nine counties: Brevard, Flagler, Lake, Marion, Orange, Osceola, Seminole, Sumter, and Volusia;
- NOW THEREFORE, BE IT RESOLVED by the Central Florida MPO Alliance, that we will work with the Florida Department of Transportation in the development of a Central Florida Regional Mobility Plan, including passenger rail, consistent with the recommendation of the East Central Florida Corridors Task Force.
- BE IT FURTHER RESOLVED that since the Central Florida MPO Alliance service area already has a backlog of currently unfunded prioritized projects, the Central Florida Regional Mobility Plan should emphasize new and innovate methods of funding, especially for transit projects, to ensure that a practical plan is developed.
