CFMPOA Delegation Report October 2021

Current Construction Projects:

• 238395-5 U.S. 441 Widening from Lake Ella Road to Avenida Central

This is a project to widen U.S. 441/U.S. 27/State Road (S.R.) 500 from four to six lanes between Lake Ella Road and Avenida Central. Both northbound and southbound U.S. 441 will be expanded from two to three lanes, and bicycle lanes and sidewalks will be added along the length of the project. The FDOT will also do drainage work, add signage, make lighting upgrades, make median access changes and improve the aesthetics of the roadway with new landscaping.

A key aspect of the project will be the removal of U.S. 441 bridges over County Road (C.R.) 25, and the creation of a new, at-grade intersection at that location. C.R. 25 will connect with U.S. 441 on the east side of the highway via a signalized intersection but will end as a cul-de-sac on the west side of U.S. 441. Estimated completion date: Late 2023. Cost \$45.3 million

238275-7 SR 429/46 from west of Old McDonald Road to east of Wekiva Park Road (Section 6)
 The project is to design 5.5 miles of limited access toll road largely along the existing State Road 46 corridor from west of Old MacDonald Road to east of Wekiva Park Road. The project will include designing: an additional non-tolled, service road for local travel; a new, higher-profile bridge that is aesthetically pleasing over the Wekiva River; and three wildlife bridges to allow animals to pass safely between the Seminole State Forest, Rock Springs Run State Reserve and Lower Wekiva River Preserve. A multi-use trail will be built along this section. The wildlife bridges and new bridge over the Wekiva River will provide 7,800 feet of safe passage underneath for wildlife, compared to the 79 feet provided by the current two wildlife tunnels along S.R. 46. Work will include removing portions of S.R. 46 and building connector roads, drainage, signing and pavement markings, utilities and other roadway features.  240200-2 SR 429 / SR 46 from east of Wekiva Park Road to Orange Boulevard (Section 7A) This project includes 3.53 miles of limited access toll road largely along the existing State Road 46 corridor from a half mile east of Wekiva Park Road to Orange Boulevard. The project will include designing non-tolled, service roads for local travel, slip ramps to enter and exit the Wekiva Parkway, and several bridges over side streets. Work will include roadway widening, drainage, lighting, sign and pavement markings, utilities, and other roadway features. • 429556-1 SR 44 over the St. Johns River Bridge # 110063

The purpose of this project is to replace the existing State Road (S.R.) 44 bridge over the St. Johns River, also known as the Whitehair Bridge, with a high-level fixed span bridge. During construction, the existing S.R. 44 bridge will remain open for drivers to use while the new bridge is constructed to the south of the existing bridge. After construction, the existing bridge will be removed.

• 445082-1 Weather Sensor Systems

This Florida Department of Transportation (FDOT) project will be enhancing District 5's emergency management and maintenance systems by installing remotely accessible sensors that will provide continuous monitoring of roadway bridges that are critically important for the movement of people and goods throughout the District. These new sensors will monitor wind speed, water level, and roadway surface conditions on various bridges across Brevard, Flagler, Lake, Marion, Sumter, and Volusia counties.

SR 471 Complete Streets Study – SR 471 from CR 478A to CR 730 Objective: Assess the feasibility of and develop concepts for improved multimodal safety and mobility along the corridor. Areas of Focus:

- Existing and future traffic patterns
- Speeding traffic

- Crosswalks
- On-street parking
- Beautification
- Leesburg Main Street Complete Streets Study



The purpose of the study is to evaluate East Main Street from Canal Street to SR 44, and West Main Street from CR 468 to US 27 for bicycle and pedestrian improvements, Americans with Disabilities Act (ADA) considerations, landscaping, and intersection modifications, including roundabouts.

Work and Upcoming Studies:

Pedestrian & Bicyclist Safety Action Plan

Final review of the six pedestrian and bicyclist safety corridor infrastructure projects is wrapping up. The next action will be local government applications to move them into the Prioritized Project List.

Corridor Safety Concept Development & Countermeasure Study

Corridor concepts have been completed for four study corridors: Silver Star Road (SR 438) from Hiawassee Road to Pine Hills Road, Orange Blossom Trail (US 441) from Oakridge Road to 34th Street, Colonial Drive (SR 50) from Tucker Road to Harrell Road, and Colonial Drive (SR 50) from Harrell Road to Alafaya Trail.

Vulnerable Users Safety Working Group

A working group has been created to explore planning strategies to further improve our pedestrian and bicyclist safety efforts. The primary focus will be on corridor vehicle operating speeds. The working group is comprised of representatives of MetroPlan Orlando's Community Advisory, Technical Advisory, and Transportation Systems, Management & Operations Committees, the Transportation Disadvantaged Local Coordinating Board, FDOT, LYNX and Bike/Walk Central Florida.

Traffic Signal Retiming Contract

The FY 2020-2021 Traffic Signal Retiming program is complete, with 21 corridors and 18 standalone intersections being retimed throughout the MetroPlan Orlando planning area. The assessment of the 2020-2021 retiming program is underway and will wrap up in Fall 2021.

Kickoff meetings for the FY 21/22 slate of corridors commenced on August 24th and are ongoing. Data collection and preliminary corridor analyses have begun on several corridors. Four packages of corridor performance metrics have been made available as part of the before and after evaluations for the FY 21/22 retimings. The available "metric packages" offer a diversified slate of potential performance metrics that can be used to measure the success of the program in a way that considers safety and bicycle and pedestrian benefits and impacts as well as those associated with vehicular throughput. Maintaining agencies are also being provided with corridor summaries for each corridor to be retimed to help them with refining retiming goals and with choosing which performance metrics should be tracked.

Equity Audit

MetroPlan Orlando staff kicked off an equity audit for the organization in March. The intent of the audit is to explore the distribution of transportation benefits and disbenefits across the region through a social equity lens as well as to catalog how equity is addressed through existing policies and plans. The planned schedule for the audit calls for developing a draft white paper and presentation for internal review and discussion in late October or November, with the potential to provide initial findings and recommendations to the Board and committees in early 2022.

Safety Data Initiative (SDI) Safety Tool Grant

In June 2020 MetroPlan Orlando, along with major partners UCF and FDOT, was awarded one of the

nationwide Safety Data Initiative (SDI) Safety Tool grants. The award amount was nearly \$295K. The grant funds will be used to develop the Crash Prediction for Expedited Detection (CPED) application, which will further refine the Real-Time Crash Visualization Tool for Traffic Safety Management tool developed by the UCF SST team led by Professor Abdel-Aty.

The team has completed the Crash Prediction for Expedited Detection (CPED) application, integration and testing. Additionally, the visualization function for the CCTV module and the secondary crash prediction module are complete along with data cleaning and integration. The team has prepared a user manual for the CPED system. The team participated in the SDI peer exchange in May 2021. The purpose of the meeting is for the review panelists to provide feedback on the MetroPlan Orlando Crash Predictions for Expedited Detection tool, discuss opportunities, and describe how they envision applying this tool. Review panelists include FHWA, NHTSA, OST, NCDOT, and MDOT SHA. Each of the project teams from other parts of the county participated in virtual meeting with the Office of Safety Librarian on procedures and protocols for submitting reports and data.

10th Street Complete Streets Study

Within St. Cloud, 10th Street is a significant east to west street and provides a vital link to Downtown. This critical linkage to the heart of the community serves an important function of connecting residents to the vibrant shops and events in Downtown. The purpose of the 10th Street Complete Streets Study is to evaluate 10th Street from US 192 to South Narcoossee Road for modifications to sidewalks and crosswalks, bicycle facilities, landscaping, drainage and lighting. The study goal is to improve the travel and safety for residents and visitors and create positive economic impacts. Led by MetroPlan Orlando in partnership with Osceola County and the City of St. Cloud. This study will coordinate and engage with community members, agencies, businesses, and government entities throughout the 18-month duration of the project (January 2021 through June 2022) in order to guide project goals, provide support and feedback for alternative's concepts, and share information about the recommended conceptual plan. Rock Springs Road and West Orange Trail Extension Studies

MetroPlan Orlando is conducting two studies concurrently in the City of Apopka: 1) the Rock Springs Road Study, and 2) the West Orange Trail Extension Study. The Rock Springs Road Study will evaluate safety and access improvements at the intersection of Rock Springs Road and Welch Road, and along the half-mile of Rock Springs Road from Welch Road to Lester Road. The study will also include an intersection analysis and evaluate realignment for the intersection of Sandpiper Street with Park Avenue, as well as consider the addition of sidewalks on either side of Park Avenue to fill existing gaps. The West Orange Trail Extension Study will evaluate a connection between the existing portion of the West Orange Trail, which currently ends at Lester Road, and Kelly Park Road, tying into the proposed Wekiva Trail. The study will also evaluate two trail spurs to connect the Trail to the entrance to Wekiwa Springs State Park along Welch Road, and to connect to Wolf Lake Elementary and Middle Schools and the City's Northwest Recreation Complex.

The Initial Design Traffic Technical Memorandum (DTTM) has been developed in addition to the draft Corridor Analysis Technical Memorandum. Initial public and community outreach has culminated with over 600 responses to the first project Community Input Survey. The community feedback received, along with the preliminary results of the DTTM and Corridor Analysis Technical Memorandums, is being used to help craft the project alternatives. Once developed, the study alternatives will be presented and discussed at the upcoming Stakeholder and Agency Meetings planned for late 2021 and early 2022 respectively.

These studies are expected to be completed in December 2022 and are being conducted in partnership with the City of Apopka and Orange County. More information on both studies can be found at http://www.metroplanorlando.org/rocksprings.

Health Strategic Plan

The Health Strategic Plan will highlight the ways in which MetroPlan Orlando can enhance the transportation system by planning with health and the environment in mind. This plan shall illustrate areas where public health improvement through transportation planning is needed most, as well as exploring potential strategies in tackling public health issues. Some of the key components of the plan include supporting healthy lifestyles, improving healthcare access through transportation, and integrating health equity into transportation planning. The goal of the Health Strategic Plan is to provide data-driven solutions to public health issues in order to round out MetroPlan Orlando's commitment to performance-based planning. This project will wrap up at the end of October 2021.

Safety Data Initiative (SDI) Safety Tool Grant

In June 2020 MetroPlan Orlando, along with major partners UCF and FDOT, was awarded one of the nationwide Safety Data Initiative (SDI) Safety Tool grants. The award amount was nearly \$295K. The grant funds will be used to develop the Crash Prediction for Expedited Detection (CPED) application, which will further refine the Real-Time Crash Visualization Tool for Traffic Safety Management tool developed by the UCF SST team led by Professor Abdel-Aty.

The CPED application is complete. Real-time big data are accessed by the system, including traffic, CCTV live streams, traffic events, and weather, in order to generate predictive insights (i.e., real-time crash prediction) and Proactive Traffic Management (PATM) Strategies. Then, the CPED application utilizes the real-time predictive safety insights (i.e., real-time crash/secondary crash prediction) to anticipate the locations of crashes on limited access facilities in Central Florida and utilizes CCTV cameras to achieve expedited crash verification. Meanwhile, it highlights the nearby CCTV cameras for each crash-prone or traffic event location and recommends a scanning direction for each camera to assist the traffic operators in monitoring the road traffic conditions. Moreover, a third-party page and external API were developed to share the outputs with third parties, while a report page was developed to support TSMO project development and decision making. System tests and evaluations are were conducted in this project to refine the application. Moreover, Florida Department of Transportation District 5 (FDOT D5) is working with the development team to implement the CPED application within the FDOT network. The developed CPED tool can be accessed using the following URL: http://ucfsstcped.com/. Additionally, MetroPlan Orlando hosted a webinar on the CPED on August 19, 2021. The event attracted 105 attendees, including representatives from the local transportation agencies and academic community and representatives from other states.

Regional TSMO Program

MetroPlan staff is advising M/TPOs on specific TSMO goals and objectives for their agencies. This includes suggestions on areas of development, knowledge sharing on emerging technologies in transportation and opportunities for advancing TSMO and alternative funding strategies.

During the August 2021 RTSMOP Working Group Meeting, Ms. Kristine William, Center for Urban Transportation Research (CUTR) gave a presentation on a research grant to explore the potential of establishing and sustaining an entity comprised of seven MPOs in Central Florida to advance TSMO. Ms. Lara Bouck, MetroPlan Orlando gave a presentation on evaluating traffic signal retiming using Connected Vehicle data. MetroPlan Orlando manages an annual traffic signal retiming program, including a before and after evaluation to report of travel time, delay and emission improvements.

MetroPlan Orlando is part of a research team led by the CUTR that was awarded a \$3.5 million dollar award from the Department of Energy (DOE) - National Vehicle Technologies Office (VTO) Grant. Dr. Xiaopeng (Shaw) Li Center for Urban Transportation Research (CUTR) gave a presentation on the research grant to develop a smart low-cost Visual-Enhanced Cooperative Traffic Operations (VECTOR) system to efficiently

manage cooperative driving automation (CDA) technology at the September 2021 RTSMOP Working Group Meeting.

Current connected vehicle technologies use high-frequency wireless communication. However, due to the high cost of the necessary infrastructure investment, these technologies have very limited availability and other challenges. Connected Wise's VECTOR system uses dynamic message signs and low-cost sensing technologies, such as cameras, that are available on the traffic infrastructure and the flashing sequences of vehicles' headlights, tail lights and LED displays to receive information from the vehicles. The project will reduce the cost for sensing, communications and computation by at least 60% and reduce energy consumption by at least 40% compared to existing technologies. MetroPlan Orlando will provide coordination between the research team and RTSMOP to provide support on evaluation of and feedback on the proposed technologies; facilitate use of planning models in the region to evaluate the benefits, impacts and potential applications of these technologies beyond the research. Additionally, during the Dr. Ilir Bejleri, University of Florida gave a presentation on travel safety and equity analysis using Signal 4 crash database. MetroPlan Orlando contracts with University of Florida to maintain crash data for its planning area. This analysis is used for reporting, identification of safety improvements and address equity in marginalized communities.



Ocala/Marion County Transportation Planning Organization (TPO) Delegation Report, October 2021

Safety Action Plan

The TPO is planning to invest in the development of a Safety Action Plan for Ocala/Marion County. The Action Plan is envisioned as a collaborative process involving citizens and stakeholders, private and public partners, and state agencies. The title of the Action Plan is **Commitment**

to Zero: An Action Plan for Safer Streets in Ocala Marion. The purpose of **Commitment to Zero** is to bring together the Ocala Marion community and collaborate in the development of an Action Plan to improve the safety of our transportation system. The Action Plan will be focused on four key areas:

- Education and Awareness
- Public and Partner Engagement
- Safety Analysis
- Action Planning

The partner and stakeholder engagement process is currently underway, with a formal kickoff planned for January 2022.

Congestion Management Plan

The TPO is on schedule to adopt a Congestion Management Plan (CMP) in October 2021. The CMP includes a Policy and Procedures Element and State of the System Report and was developed to meet state and federal requirements. Upon Board adoption, the TPO will next create an online interactive map portal of the CMP network and corresponding congested corridors. The CMP will also be integrated into the annual List of Priority Projects (LOPP) process. Pending the results of the 2020 Census, the TPO anticipates becoming part of a Transportation Management Area (TMA) requiring the CMP to meet the federal eight-step process.

Transportation Resilience Guidance

The TPO is developing a planning guidance resource on transportation resilience. The impetus of this planning project is tied to federal planning factors, pending federal reauthorization and the recently enacted Resilient Florida. The project will involve an assessment of major vulnerability issues, funding opportunities, along with a general set of recommended actions and strategies to further integrate resilience into the TPO/MPO planning process. The Resilience Guidance Paper is expected to be completed by December 2021, and made available to the public on the TPO's website.

Bicycle Pedestrian Safe Routes to School Education Project

Contract development challenges and pandemic schooling conditions tried to derail the Bicycle Pedestrian Safe Routes to School Education Project, but patience and tenacity prevailed. The Polk TPO entered into contract on September 9, 2021, with AECOM Technical Services, Inc. to implement the Public Outreach and Education countermeasures identified in the Pedestrian Safety Action Plan and the Bicycle Safety Action Plan. The major tasks of the project are to develop instructional kits to include digital learning/online virtual interface; develop educational materials geared towards parents and students on safety issues related to traffic circulation for school drop-off/pick-up; and pilot online Safe Routes to School educational program at five Polk County Schools. The project curriculum will provide additional engagement, beyond the current in-school curriculum, to Polk County School District students with an online education program (what we affectionately call "the pandemic pivot") to give all students a safe option for accessing bicycle and pedestrian safety education.

2021 Gulf Coast Safe Streets Hybrid Summit

As part of the Sun Coast Transportation Planning Alliance (formerly known as the West Florida MPO Chairs Coordinating Committee), the Polk TPO is participating in the 4th Annual Gulf Coast Safe Streets Hybrid Summit on November 2-4, 2021.

The Sun Coast Transportation Planning Alliance (SCTPA) is bringing together industry leaders, elected officials, policymakers, planners, businesses, nonprofits and residents to encourage safety and accessibility for everyone. Space Coast TPO's Delegation Report to the Central Florida MPO Alliance October 8, 2021

2021 Intelligent Transportation System (ITS) Master Plan Adoption

The SCTPO officially adopted its 2021 ITS Master Plan on July 8, 2021.

The ITS Master Plan is the TPO's guiding document for implementing technology on the transportation network. The 2021 ITS Master Plan Update focuses on using technology to improve traffic flow and aims to maximize existing infrastructure to provide an accessible, safe, reliable, efficient, and secure transportation system for all users. This plan proposes numerous technologies and locations for safety improvements as well as a tiered approach for future system expansion and operation. The proposed improvements and strategies will ensure that the Space Coast area is prepared for autonomous and connected vehicles

SCTPO staff is working closely with Brevard County Traffic Operations to design the county's first Regional Transportation Management Center (RTMC).

Transportation Resiliency Master Plan

The SCTPO is in the process of developing a Transportation Resiliency Master Plan. Upcoming activities include community conversations with Transportation Disadvantaged Communities and determining shocks and stressors to be analyzed.

The Transportation Resiliency Master Plan will build on our past work regarding sea-level rise vulnerabilities to define potential transportation-specific stressors, identify vulnerable corridors in Brevard County, and recommend strategies to improve the adaptability/recoverability of the system.

North Brevard Wayfinding Master Plan

North Brevard has a network of regional trails such as the Coast to Coast Trail, St. Johns River to Sea Loop, and East Coast Greenway. The regional trails cross through multiple jurisdictions within Brevard and each have its unique branding.

Per the request of trail managers and North Brevard municipalities, the Space Coast TPO is developing a Wayfinding and Amenities Master Plan to address trail network and trailheads which provide access to the North Brevard Trail Network. The plan will develop a consistent wayfinding and amenity plan to be used across the regional trails for the purposes of improving the trail experience and aesthetic.

Planning Projects and Activities

Congestion Management Process (CMP) and Performance Measures Report

Transportation data is being used to evaluate the performance of the existing system as well as to inform decisions regarding the prioritization and funding of projects and programs to address needed improvements. The R2CTPO is conducting an update to the CMP to define congestion management objectives, performance measures, and methods to monitor and evaluate system performance. Congestion management strategies will also be identified and assessed for their expected user benefits and contributions to system performance. A draft report is expected in Spring 2022.

Flagler County Public Transportation Transit Development Plan (TDP) Major Update

The R2CTPO is providing staff support and funding to the local transit provider to assist with planning efforts to develop their TDP. These efforts are currently underway and are anticipated to be complete in November 2021.

Project Feasibility Studies

The R2CTPO sets aside \$100,000 annually in two project categories (Traffic Operations/Safety and Bicycle/Pedestrian) to complete project feasibility studies as requested by local government sponsors for projects administered through the Local Agency Program (LAP). Projects are prioritized and studies are initiated at the start of the fiscal year to prepare project applications for the next Call for Projects. The R2CTPO is currently conducting one Traffic Operations and three Bicycle/Pedestrian feasibility studies.

R2CTPO Annual Public Outreach Summary Report

Each year TPO staff compile a summary of outreach activities and measures of program success. Outreach efforts and public engagement were particularly challenging during FY 20/21 due to the COVID-19 pandemic.

Recent Community Outreach Activity

- <u>Port Orange Family Days</u> The River to Sea TPO staff set up a booth and provided bicycle and pedestrian safety information, educated adults and children on bicycle and pedestrian safety laws and handed out safety gear to many attendees at this community event on September 25, 2021.
- <u>SR A1A Bicycle/Pedestrian Outreach</u> The River to Sea TPO is partnering with FDOT to raise awareness of bicycle and pedestrian safety at three community events along SR A1A on September 18th, October 2nd, and October 16th, 2021.
- <u>Speakers Bureau</u> River to Sea TPO Community Outreach Coordinator continues to recruit participants to join the TPO in offering presentations that describe their life changing experiences resulting from their involvement in a collision with distracted and/or speeding drivers.

Recently Completed Projects

<u>Votran Transit Development Plan (TDP) /Transportation Disadvantaged Service Plan (TDSP) and</u> <u>Comprehensive Operational Analysis (COA)</u>

The R2CTPO provided staff support and funding to the local transit provider to assist with planning efforts to develop the TDP/TDSP/COA. These documents were adopted by the local agency in August 2021.

Paratransit Service Analysis

Many changes have occurred regarding the provision of transportation services for disabled and disadvantaged. New transportation options, as well as changes to the structure of the coordinated transportation system established under Florida Statutes, have influenced the provision of services throughout Florida. This study examined the local area service and the state of practice throughout Florida to identify issues and opportunities that impact efficiencies in paratransit service. The Paratransit Service Analysis Report was adopted in September 2021.

b. FDOT District Reports

Mr. Jack Adkins represented FDOT District 5 and reported that in anticipation of stimulus funds becoming available they are getting plans in place and projects ready that they will prioritize with M/TPO staff. He added that they will work as a team to meet needs as best they can. He called attention to the new Safety Office headed by Ms. Loreen Bobo. The Safety Office will focus on behavioral solutions, new ideas and building collaborative

a. Approval of Previous Meeting Minutes

b. Regional Prioritized Project List

Ms. Georganna Gillette, Space Coast TPO, gave a presentation on the updated Regional Prioritized Project List. She noted that at the April CFMPOA meeting the process, schedule, and last year's list were provided. Ms. Gillette told committee members that the adopted list goes to FDOT to be used for programming of state and federal funds. She added that regional priorities are developed to leverage resources and connect population and markets. Ms. Gillette reviewed the funding categories and updates to the list. Discussion ensued regarding the location of a MetroPlan Orlando project that had been deleted.

MOTION: Commissioner Viviana Janer moved approval of the Regional Prioritized Project List. Commissioner Bob Dallari seconded the motion. Motion carried unanimously.

A question was raised regarding the motion including a Space Coast TPO project that was added. Ms. Gillette confirmed that project as South Babcock Street that was added to the TRIP list.

VIII. Presentations

a. Regional TSMO Update

Mr. Eric Hill, MetroPlan Orlando, gave an update on the Regional Transportation Systems Management & Operations (TSMO) program. Mr. Hill told CFMPOA members that TSMO uses information and communication technology to improve transportation and mobility. He noted that the future of TSMO is to develop a system that will communicate with vehicles. The TSMO Regional Working Group is tasked with developing a program, to work with the MPOs in Central Florida to advance TSMO, and to develop an innovative program that is consistent in the region. Mr. Hill reported that the Working Group includes not only the M/TPOs, but representatives from FDOT Districts 1, 5 and 7, plus Florida's Turnpike Enterprise and the Tampa and Orlando tolling agencies. A Memorandum of Understanding guides the work of the group. He told committee members that at the April 9th meeting they had an update on the NICR grant with CUTR to develop an academic perspective on the feasibility of developing a consortium. A presentation on the North Central Texas Council of Government AV program and a planned survey. At the June meeting they received information on the Southeast Michigan Council of Governments broadband and survey results to address knowledge transfer, deficiency in funding and advancing and prioritizing TSMO.

b. I-4 Beyond the Ultimate Update

Ms. Catalina Chacon, FDOT, reviewed the presentation agenda, which included goals of the project, and the north and south segments. She provided an update on the I-4/Sand Lake Road intersection. Ms. Chacon called attention to opportunities available, and the value engineering approach being used to relook at the corridor. She provided an example of an original typical section and a potential typical section after using the new approach. Ms. Chacon detailed the next steps and gave a programming update. Discussion ensued regarding the I-4 portion for Brightline and how the "small bites" approach being used impacts residents and level of service.

c. FDOT Freight Parking Study Update

Mr. Steven Buck, FDOT, gave a presentation on the FDOT Freight Parking Study. Mr. Buck reported that the PD&E study kicked off this summer to address the number one issue for commercial truck drivers. He provided information on Jason's law and the survey assessment by USDOT. Mr. Buck told committee members that the survey objective was to evaluate each state, assess volume, and develop a system of metrics. A statewide survey was completed in March 2020 and I-4 was identified as the most critical corridor and current and future parking needs were identified. Mr. Buck added that federal freight funds were available to conduct the study which will include heavy public involvement. He provided a timeline for the study which is currently in the data collection phase. Design was slated to begin later this year. Discussion ensued regarding issues with rest stops including the decreasing availability, and increasing need and cost of right-of-way.

d. CFX Master Plan Update

Mr. Will Hawthorne, CFX gave a presentation on the Central Florida Expressway Authority's 2045 Master Plan that is currently under development. Mr. Hawthorne told committee members that CFX was created as an agency of the State of Florida by the legislature in 2014. As part of that action, the scope of the agency was expanded to include Lake, Osceola, and Seminole counties and would look at multimodal partnerships. CFX, he reported, has a 10-member board and oversees 125 miles of limited access expressway. Mr. Hawthorne noted the CFX Master Plan sets the course for the future and is a five-year, needs-based plan that is approved by the board. The 2040 Master Plan identified \$11 billion in needs and by 2025, \$2.5 billion will be invested in the system. Mr. Hawthorne reviewed major initiatives, signature projects the SR408/SR417 and SR 528/SR 436 interchanges, and study areas that have been identified. He provided a survey link and requested input from CFMPOA members.

e. Bicycle & Pedestrian Safety Presentation

Mr. Mighk Wilson, MetroPlan Orlando, gave a presentation that pedestrian safety initiatives. Mr. Wilson reviewed the Pedestrian Danger Index used to compute how dangerous an area is along with the impact the Central Florida visitor population has on crashes. He provided information on scenarios for reducing fatalities, FDOT's new safety principle 'Safe System," fatality factors and crosswalk law. Mr. Wilson compared examples of local roads with similar roads in other states where speeds are reduced. He called attention to the deadly factors in crashes, including types of vehicles, noted in the Dangerous by Design report. Mr. Wilson added that an additional mitigation option could be reducing nighttime speed limits. Discussion ensued regarding type of lighting and traffic study requirements for reducing speed limits.

IX. Member Comments

Ms. Virginia Whittington called attention to Ms. Lois Bollenback's decision to tender her resignation from the River to Sea TPO. Ms. Bollenback spoke briefly about her great experience working with local leaders and staff.
