**I. CALL TO ORDER**

Chairman John Dowless called the meeting to order at 9:35 a.m.

**II. PLEDGE OF ALLEGIANCE**

Chairman Dowless requested a moment of silence for Ms. Lena Tolliver, former MetroPlan Orlando staff member who passed away Monday, February 4<sup>th</sup>. He then led the committee in the Pledge of Allegiance.

**III. CHAIR'S ANNOUNCEMENTS**

Chairman Dowless welcomed everyone and requested MAC members introduce themselves.

**IV. CONFIRMATION OF QUORUM**

Ms. Goldfarb confirmed a quorum was present.

**V. PARTNER REPORTS**

**LYNX**

Mr. Myles O'Keefe, LYNX, reported that LYNX had been holding their board meetings bi-monthly however the decision was made to hold them monthly starting February 28<sup>th</sup>. He added that LYNX will be starting pre-site work on their biennial review and a team of contractors will be assembled to provide feedback for LYNX sometime in the March/April time frame.

**FDOT**

Ms. Rakinya Hinson, FDOT, was delayed and would provide a report later in the agenda.

**Florida's Turnpike Enterprise**

Mr. Jim Martin, Florida's Turnpike Enterprise (FTE), reported that a new state FDOT Secretary, Mr. Kevin Thibault, had been appointed. He noted that there will be an upcoming project for the Long Range Transportation Plan involving the SR 429 and Turnpike interchange.

**VI. AGENDA REVIEW/FOLLOW-UP**

Ms. Virginia Whittington told MAC members that Mr. Gary Huttman had the opportunity to meet with new FDOT Secretary, Kevin Thibault last week. She reintroduced Mr. Alex Trauger, who had returned to MetroPlan Orlando in December and will be working on the Metropolitan Transportation Plan. Ms. Whittington thanked MAC members for their response to the annual member commitment letters. She spoke briefly about the recent trend where cities are appointing a technical staff member to MAC and the need to curb these appointments to retain

the intent of the MAC committee structure. Ms. Whittington reported that Mr. Bob O'Malley (Brightline) was unable to attend due to a business obligation and that the Brightline presentation would be deferred to the May MAC meeting. MAC members had the option to view a brief video for Brightline at the end of the meeting. Mayor Bruhn asked about the Winter Garden vacancy and outreach efforts to secure an appointment for that seat on MAC. Ms. Whittington responded that she sent the confirmation letter to Winter Garden and that the city pays their assessment for the MAC seat on the MetroPlan Orlando Board. She added that she will reach out again. Chairman Dowless told MAC members that he will reach out to his contacts at the City of Winter Garden as well.

## VIII. ACTION ITEMS

### *A. Approval of December 6, 2018 Meeting Minutes*

Approval was requested of the December 6, 2018 meeting minutes, which were provided.

**MOTION:** Mayor Gary Bruhn moved for approval of the December 6, 2018 meeting minutes. Mayor Dale McDonald seconded the motion, which passed unanimously

### *B. Amendment to FY 2023/24–2039/40 Prioritized Project List*

Mr. Alex Trauger, MetroPlan Orlando staff, requested the MAC recommend that the FY 2023/24–2039/40 Prioritized Project List be amended to include additional projects. An attachment was provided. Mr. Trauger provided some background information on the Prioritized Project List and reviewed the projects in the request. He told MAC members that the approval schedule had been adjusted to coincide with FDOT's Five-year Work Program schedule. Mr. Trauger noted that TAC approved the Prioritized Project List, however there were a few dissenting votes. The dissenting votes, he told committee members, were related to concerns with the overall process. Mr. Trauger added that the Community Advisory Committee and Transportation System Management and Operations Committee both passed the amendment unanimously.

**MOTION:** Mayor Gary Bruhn moved for approval of the amendment to the FY 2023/24–2039/40 Prioritized Project List. Council President John Dowless seconded the motion, which passed unanimously

### *C. Support for FDOT Performance Measure Targets and Support for LYNX Transit Asset Management (TAM) Targets*

Mr. Nick Lepp, MetroPlan Orlando staff, requested the MAC recommend the re-support of FDOT's targets for Safety, Travel Time Reliability, Bridge and Pavement Condition, as well

as the targets established in the LYNX Transit Asset Management (TAM) plan. An attachment was provided. Mr. Lepp provided some background information on the performance measures and reviewed the targets. He noted that approval was required annually and a percentage of poor condition was allowed in order to alleviate FDOT from having to focus all their funding on any one project.

**MOTION:** Mayor Gary Bruhn moved for approval of re-support of FDOT's targets for Safety, Travel Time Reliability, Bridge and Pavement Condition, as well as the targets established in the LYNX Transit Asset Management (TAM) plan. Mayor Charles Lacey seconded the motion, which passed unanimously

Ms. Rakinya Hinson, FDOT provided her FDOT report at this time. She reported that FDOT will be holding a public hearing for the SR 434/Falkner Road project on February 12<sup>th</sup>, 5:00 p.m. at the New Life Community Church.

## **IX. PRESENTATIONS AND STATUS REPORTS**

### ***A. Sunshine Law Training***

Ms. Marilyn Crotty, former director of the John Scott Dailey Florida Institute of Government at UCF, conducted a training session on the Florida Sunshine Law. Ms. Crotty told MAC members that she was presenting an abbreviated version of the Florida Sunshine Law course required for elected officials. She reviewed what defined a meeting, requirements for a meeting location, requirements for minutes, voting and public participation and the sanctions for violating the Sunshine Law. In addition, Ms. Crotty informed committee members what qualified for an exemption from the law. Mayor Cole requested a copy of the presentation. He asked about discussion of an item that was not on the agenda for a meeting. Ms. Crotty responded that it would be preferable to get public involvement prior to discussing an item not on an agenda and any action on that item would need to be postponed. Mayor McDonald asked about publishing requirements, noting that the City of Maitland had submitted notices to the Orlando Sentinel that were not published as requested. Ms. Crotty responded that the Florida League of Cities had been trying to get approval for electronic ads, but had not been successful so far.

### ***C. Update on Best Foot Forward***

Ms. Amanda Day, Best Foot Forward, presented a report on the latest status of the Best Foot Forward pedestrian safety program in the MetroPlan Orlando region. Ms. Day reported that the Dangerous by Design report from 2011 was the impetus for Best Foot Forward and the most recent report once again designated Central Florida as the number one most dangerous. She noted that speed and carelessness are major contributing factors, and there is a distinct language gap in terms of the use of the word "pedestrian." Best Foot Forward, she added, is a grassroots coalition that came together to work as one voice to address the pedestrian safety issue. Ms. Day explained what legal crossings and crossing issues are and called attention to the improvement in driver yield rates that have been a direct result of enforcement efforts. She told MAC members that Best Foot Forward already has a presence in Orange and Osceola Counties and will launch their program in Seminole

County in February. Ms. Day called attention to the upcoming Bike Five Cities event. She commented on the media, who had been a great partner in Best Foot Forward's efforts. Mayor Cole asked if there was any funding sources available for Rapid Flashing Beacons for Kennedy Boulevard in Eatonville. Mr. Gary Huttman responded that staff could work on getting the Eatonville project in the Prioritized Project List in order to make the project eligible for funding. Mayor McDonald requested a version of Ms. Day's PowerPoint that could be used on the City of Maitland's website. Ms. Day responded that she would provide the PowerPoint.





## **2045 Metropolitan Transportation Plan (MTP) Working Group: Overview, Purpose and Role, and Proposed Group Composition**

MetroPlan Orlando is committed to an open and inclusive planning process for the 2045 MTP. Direct input and participation of community, industry and thought leaders as well as other stakeholders is a critical component of long-range metropolitan transportation planning. To better manage the plan development process, MetroPlan Orlando staff is establishing a MTP Working Group made up of volunteer community leaders, subject matter experts, and transportation planning and traffic engineering agency staff from the three-county area.

The working group's purpose is to help ensure a process that is technically sound, enjoys broad public and expert support, and results in the creation of a far-sighted and feasible transportation plan that can guide regional transportation investment for the years to come. All working group meetings will be public and will welcome public participation and input. The working group's role is to convey needs/concerns/desires, identify opportunities, provide project guidance, and review MTP work products and deliverables.

Engaged volunteers and agency staff should expect to:

- Play an active role in the MTP planning process by routinely attending and participating in working group meetings. Meetings will tentatively take place monthly for the first six months of the planning process and every other month until the adoption of the MTP in December 2020;
- Provide input and lend subject matter expertise to identify ambitious, cost effective and sustainable transportation solutions; and
- Become an ambassador to promote community engagement and support for the 2045 MTP.

- Three (3) members of the TSM&O Advisory Committee who serve in a traffic engineering/ITS role
- Three (3) members of the Technical Advisory Committee who serve in a planning role
- Three (3) members of the Community Advisory Committee
- Transportation Operating and Planning Agencies
  - LYNX (CFRTA) staff
  - Central Florida Expressway Authority (CFX) staff
  - East Central Florida Regional Planning Council (ECFRPC) staff





The Central Florida Regional Transportation Authority's (LYNX) submission period will open Feb. 18 for qualified non-profit organizations in Orange, Osceola and Seminole counties to register for a spot on the agency's Public Service Bus.

Eight qualified agencies will be chosen in a random drawing to have their logo displayed for one year. The Public Service Bus travels routes every day throughout the three-county area.

To be eligible, for the 18th annual celebration, the non-profit organization must be based in Orange, Osceola or Seminole County; operate on a budget of less than \$1.5 million and show proof of 501(c)(3) status or be a governmental agency.

Qualified agencies are required to:

Fill out registration form online ([www.golynx.com](http://www.golynx.com) (<http://www.golynx.com/>)) with all fields completed.

Attach copy of 501(c)(3) status or government agency designation. (Example: IRS form.)

Attach copy of annual budget of less than \$1.5 million. (Example: annual budget document.)

Attach electronic file of organization logo in Adobe Illustrator (.ai) format.

The deadline to enter is 5 p.m. March 18. Incomplete entries will not be accepted. Winners will be drawn randomly and announced the week of March 25.

Agencies on the 2018-19 Public Service Bus are not eligible until next year.

The official unveiling of the 2019-20 Public Service Bus will be held at a to-be-determined location in April.

**Subject:** February 2019 Bicycle & Pedestrian Activity Update

### City of Maitland

Completing a Bike / Pedestrian Master Plan through DRMP. Once staff completes their review, this plan will be reviewed by the City's Transportation Advisory Committee and the Planning and Zoning Committee prior to going to City Council for final approval later this year.

### Orange County

- **INVEST in our Home for Life:** This program provides \$15 million over five years for pedestrian safety projects at intersections and other selected locations that will enhance various features such as sidewalks, crosswalks, signals, turn lanes, updated signage and other necessary improvements.
- **Pedestrian Safety Corridor Projects:** Design is currently underway to improve pedestrian safety in three high pedestrian crash areas: 1) UCF Area - Alafaya Trail and University Boulevard; 2) Oak Ridge Road; and 3) Pine Hills Road. These projects are the result of studies that identified needs and recommended infrastructure enhancements to improve pedestrian access and safety.
- **Pedestrian Safety Studies:** Orange County recently completed the Universal Boulevard Pedestrian Safety Action Plan, which calls for installation of signals that will provide protected pedestrian crossings, installation of sidewalk, upgraded lighting, and narrowed travel lanes. The International Drive Crosswalk Areas study, nearing completion, recommends consolidating uncontrolled pedestrian crossings to new signal-controlled pedestrian crossings as well as installation of pedestrian channelization barrier. Eight pedestrian crossing studies were conducted in the last two years for key corridors, including Rock Springs Road and Apopka Vineland Road, with recommendations for pedestrian refuge islands, sidewalk, speed feedback signs, and ADA upgrades currently underway.
- **Safety Programs:** Roadway Lighting - \$3M this year, Sidewalks - \$2M annually, ADA retrofits - \$2M annually, \$500,000 specifically allocated to pedestrian counts, pedestrian safety studies, and pedestrian safety education/messaging annually, neighborhood traffic calming - \$300,000 annually, speed radar sign program - \$250,000 annually.

- **Policies and Plans:** Orange County recently completed Phase 1 of its Pedestrian/Bicycle Safety Action Plan, as well as the Orange County Pedestrian Crossing Treatment Guidelines for consistent countywide application. The development of a Complete Streets Policy and Pedestrian Safety Code updates are underway. Roadways scheduled for resurfacing are systematically reviewed for multi-modal improvements, such as the resurfacing review of Rio Grande Avenue, which resulted in recommendations for two new mid-block crosswalks, with installation in progress.
- **Walk-Ride-Thrive! Pedestrian Safety Program:** Staff completed 18 pedestrian safety education events in 2018 in partnership with schools and community groups, created “Eyes Up, Ears Open” messaging to address distracted walking, and wrapped signal cabinets with pedestrian safety messages at high-crash intersections. Pedestrian safety messaging was installed on LYNX busses, at high-use bus shelters, and on an I-Ride Trolley.
