Dear Mr. Huttmann:

Florida Department of Transportation requests MetroPlan Orlando amend the FY 2022/23-2026/27 TIP to reflect project changes as described below.

Project #424255-1 is funded by FTA for the Central Florida Regional Transit Authority (CFRTA/DBA LYNX) LYMMO upgrade. An increase in annual formula allocations have been added and funds from previous years need to be rolled forward for the project in FY 23, which creates an increase of more than \$2M and 20% of the total project cost.

Project #451939-1 is funded by FTA for LYNX through the Bus and Bus Facilities program. This is a new project recently added to the FDOT Five-Year Work Program therefore it must also be listed in the TIP.

Project #451947-1 is funded by FTA for LYNX through the Transit-oriented Development Planning program for SR 436. This is a new project recently added to the FDOT Five-Year Work Program therefore it must also be listed in the TIP.

WHEREAS, the requested amendments are described as follows:

Orange County

- FM #424255-1 LYNX Section 5309 LYMMO Upgrade Funding consists of \$12,000,000 in FTA funds and \$2,800,000 in LF funds for capital improvements in FY 2022/23;
- FM #451939-1 LYNX Section 5339 Bus and Bus Facilities Funding consists of \$16,132,025 in FTA funds and \$4,033,006 in LF funds for capital purchases in FY 2022/23;
- FM #451947-1 LYNX FTA Transit Oriented Development Planning for SR 436 Funding consists of \$300,000 in FTA funds and \$75,000 in LF funds for capital improvements in FY 2022/23; and

WHEREAS, the requested amendments described above are consistent with MetroPlan Orlando's project priorities and currently adopted Long Range Transportation Plan.

NOW, THEREFORE, BE IT RESOLVED by the MetroPlan Orlando Board that the Florida Department of Transportation's amendment to the FY 2022/23 - 2026/27 TIP be approved as requested.

Subject: 2022 Population Estimates

The official 2022 population estimates have been released by the University of Florida's Bureau of Economic and Business Research (BEBR).

The attached table compares the 2021 population estimates with the 2022 population estimates for our 3-county region, as well as for our neighboring counties and the State of Florida. The original BEBR statewide 2022 population estimates report is available at https://www.bebr.ufl.edu/population/population-data-archive/

Highlights are as follows:

- From 2021 to 2022, there was a 2.07% increase in the population of our 3-county area slightly less than the percentage increase for the 2020-2021 report. This is an increase of more than 48,000 new residents which is nearly the current population of Ocoee.
- In our 3-county region, Osceola County continued to have the highest rate of growth (4.55%).
- The Orange County municipality with the largest percentage increase was the Town of Oakland (38.54%).
- The Osceola County municipality with the largest percentage increase was the City of Kissimmee (1.44%).
- The Seminole County municipality with the largest percentage increase was the City of Lake Mary (2.76%).

These population figures will be used to develop our Unified Planning Work Program and our budget for this year.

2023 MioVision Counts

Background

The MioVision system uses video and artificial intelligence to count pedestrians, bicyclists, and motor vehicles. It is also equipped with Bluetooth readers that can be used in tandem for speed and count observations. MetroPlan Orlando has two of these units and has been using them primarily for pedestrian and bicyclist counts. This system is superior to infrared counters in that it can differentiate between bicyclists and pedestrians, can count bicyclists in mixed traffic, and can record user direction.

The cameras are designed for temporary deployments, with average battery life suitable for 48-hour counts. Wider roads and intersections may require two cameras. Data is downloaded from the cameras, then uploaded to MioVision for processing.

Typical MetroPlan deployments have been for mid-block pedestrian and cyclist counts along streets and highways, and for trail counts. The system was used for the Bikeway Risk Analysis Study, and for before-and-after studies for planned path, road diet, complete streets, and redevelopment projects. While our focus has been on non-motorists, the system can count all modes.

Roads wider than 100 feet are typically addressed with two cameras. Locations with street lighting or good ambient lighting are preferred, as the system needs some lighting for night-time counts.

Data output is in standard CSV or Excel tables, separating pedestrians and bicyclists, with columns for position and direction and at 15-minute intervals. The MioVision website hosts all the data. We can provide you access with a simple email; contact Mighk Wilson at the email address above.

MioVision Capacity

We can deploy each camera once per week, with cameras going out on Monday or Tuesday, and retrieved on Thursday or Friday. We currently have 19 deployments (11 weeks) planned and can provide up to another 21 to 23 weeks of counts through 2023.
